

Introduction

How to Use this Book

This book makes the assumption that you have already mastered the subject at GCSE and if this is not so you may find it necessary to refer back to your GCSE textbook in order to understand some of the topics in this book. If you are not in possession of an appropriate GCSE textbook then there is a suitable book in the Work Out GCSE series. The A-level papers include many questions on topics examined at GCSE but usually will introduce additional areas and involve far more calculations than at GCSE.

In using this book you are recommended to read each chapter, making sure you understand the technique being explained before proceeding to the next point. You should then study the worked examples and solutions, ensuring that you fully understand how the solutions have been arrived at, and why.

Revision

Before you start to revise, find out exactly which syllabus you are following and obtain a copy of it. The book contains many questions from the most recent examination papers of various examination boards. However, having worked through these, you may wish to obtain copies of past papers from your own examination board. Certainly the best way to check your revision progress in Accounting is to work carefully through as many typical questions as you possibly can. Take a topic at a time, make certain that you understand fully the key points of theory and then attempt a range of questions.

The Examination

In practical accounting examinations it is vital that you allocate the time you spend on each question according to the number of marks awarded for the question. Calculate how long you can afford to spend on each question and do not spend more time on it.

1 Accounting Concepts

1.1 Introduction

Although you may not have been aware of it, you have already been applying certain accounting concepts when you were preparing accounting statements in your earlier studies. Examples of this are in valuation of stock and depreciation of fixed assets. The method of dealing with these operations has arisen from generally accepted accounting concepts. One further example is the differentiation between capital and revenue expenditure, where such expenses as rent and wages have been treated as revenue expenditures and have been taken account of in the calculation of the net profit. Capital expenditures — for example, fixtures — have been treated as an asset and have not been taken account of in the profit calculation (except by way of depreciation).

We shall now consider in turn some accounting concepts, all of which are applied in the preparation of accounting statements. The first two are very basic and therefore, while universally accepted, are taken for granted. The third concept, of materiality, is also taken for granted. The last four are embodied in a document called Statement of Standard Accounting Practice (SSAP) No. 2. Chapter 5 explains what these standards are and looks at them in greater depth.

1.2 Business entity concept

Your first studies of accounting will have made it clear that what we are doing is keeping the books or accounts of a business and not the owner's personal books. For this reason we consider the business separately from its owner and record only those transactions which affect the business. Thus, we ignore private transactions, and also the owner's personal assets and liabilities.

1.3 Money measurement concept

Accounting is about recording things which can be measured in money terms. For example, assets are recorded at their cost in money terms to the business. For the same reason we ignore any assets of the business which it has not paid for in money terms — for example, goodwill that the business may have built up, either with its customers or with its employees. Similarly, in stating liabilities, we are concerned with the monetary value of those liabilities.

1.4 Materiality concept

The materiality concept recognises that if we tried to be absolutely precise about everything, it would cost the business considerable time and expense. Stock valuation and depreciation are good examples of where absolute precision, even if it were possible, would involve tremendous time, trouble and expense.

Where the amount of any possible error would have an immaterial effect on the accounting statements, it is both reasonable and acceptable to use best approximation to actual value.

1.5 Going concern concept

Accounting statements are prepared on the basis that the business will continue to operate as it has been, for the foreseeable future. It therefore assumes that the business is not likely to terminate the whole or part of those operations in the near future.

The treatment of fixed assets can be considered under this concept. Fixed assets are depreciated with the object of writing off the cost (less residual value) over their useful life. It is irrelevant that the asset could not be sold for its balance sheet value (that is to say, we ignore a lower realisable value for fixed assets). Similarly, we would not be interested in the fact that it would cost us substantially more to replace the asset.

1.6 Accruals or matching concept

Expenses should be matched against the revenues which are earned as a result of those costs. This is why we accrue for expenses incurred during an accounting period, even though we have not paid for them — for example, wages due but unpaid. Similarly, where the revenue has not yet been earned, we carry forward the associated or related costs — for example, in the stock evaluation.

1.7 Consistency concept

Where there are alternative methods of accounting, such as with depreciation and stock valuation, it is necessary to apply consistent treatment in every accounting period.

1.8 Prudence concept

Profits should not be recognised until they are realised, which is taken to mean when goods are sold, for example. Also, all expenses and losses should be accrued when they become apparent; this in *some* cases can mean altering accounts before they have been signed by the directors.

You should realise that the concept is not designed to enable deliberate understatement of profits and the creation of hidden reserves. Rather it is designed to err on the prudent side where there is genuine doubt surrounding the value of an asset or liability. This means that assets should be understated rather than overstated, and liabilities overstated rather than understated.

1.9 Worked examples

Example 1.1

Two of the Concepts of Accounting are 'Matching' and the 'Going Concern' concept. Explain fully what these concepts are and why they are so important in preparing accounts.

(OLE)

Solution 1.1

For explanations refer to the text.

The importance of matching is to ensure that the profit is a true and fair figure and to ensure that profits (or losses) do not fluctuate violently from year to year for reasons of accounting treatment rather than trading activity. For example, consider what would happen to profits if in Year 1 we omitted to accrue for a substantial amount of wages for no reason other than the fact that we had not yet paid our labour force. Year 1's profit would be unduly high, since it would take no account of this cost, whereas Year 2's profit would be unduly low, since it would bear the cost but with no related revenue.

The importance of the going concern concept can also be attributed to the above reasons. If fixed assets were adjusted to their realisable value each year, then each year's profits would not reflect a depreciation charge which spreads the costs of the assets in a fair manner. Rather profits would reflect realisable values of fixed assets bearing little relevance to the trading activities of the business for that year.

Example 1.2

With one month of the financial year remaining, indications are that Stainer plc will return a profit figure substantially lower than that earned in previous years. In addition, the company's bank overdraft has increased considerably and is now close to the limit set by the bank. The managing director, after discussion with other directors, is considering the following three proposals.

- (1) To include both profit and interest on a substantial three year credit sale in this year's revenue accounts. Previous accounting policy has been to apportion both profit and interest over the length of the credit agreement.
- (2) To delay a credit payment to a major supplier until the final settlement date, which occurs early in the next financial year, despite an offer of substantial cash discount if early payment is received.
- (3) To sell for £50,000 cash an item of plant and machinery which is surplus to requirements. The machine cost £250,000 when purchased four years ago and has been depreciated by £100,000.

REQUIRED

- (a) Outline the effect of each of the three proposals on both the cash situation and projected profit of the company. [12 marks]
- (b) Advise the managing director as to the accounting principles involved in proposals (1) and (3) above. [10 marks] (AEB)

Solution 1.2

- (a) (1) The cash situation would be unaffected. Profit would be substantially higher, since it would reflect the total profit and interest on the credit sale, as opposed to only one-third (or less) thereof.
 - (2) The overdraft would be reduced and trade creditors would remain at the higher level. Profit would be reduced by the amount of the cash discount.
 - (3) The overdraft would be reduced by £50,000. The profit would be reduced by a loss or disposal of fixed assets of £100,000.
- (b) (1) The company should be consistent in the application of accounting bases and continue to recognise profits and interest over the length of the agreement. To recognise all of the interest element in the current year would also be contrary to the matching concept, since the interest income does

- not relate to that year and the associated financing costs would not be reported in that year. (Refer to note at end concerning profit.)
- (2) The loss on the sale of the machinery would have to be recognised, since it would be realised. Even if it were not sold, Stainer plc would need to convince its auditors that the machinery is only temporarily surplus to requirements and that it would, in the foreseeable future, be put to profitable use by the company. If it were unable to convince them of this they would need to recognise the diminutions in value in its accounts even if it were not sold.

Note: In regard to b(1) and the profit element, Statement of Standard Accounting Practice (SSAP) 21, 'Accounting for leases and hire purchase contracts', requires the profit to be recognised in the year of the sale. The company would therefore need to amend its accounting policies to reflect this. A knowledge of this SSAP is outside the scope of most A-level syllabuses.

Example 1.3

Choose four different ways of calculating or allocating depreciation and explain the difference between them. In each case state the type of asset for which it might be used, giving a reason.

Solution 1.3

- (1) Straight line method This method apportions the cost (less residual value) equally over the estimated life of the asset; in other words, it calculates depreciation as a fixed and equal amount of cost for each year. It is the most commonly used method, and is appropriate for most types of fixed asset for example, plant and machinery.
- (2) Reducing balance method This method calculates depreciation as a fraction of the previous year's net book value. Thus, the depreciation charge is comparatively high in the early years but quickly becomes comparatively low. It is therefore appropriate where the early years in the life of an asset enjoy its most efficient use and when it is also incurring comparatively low repair and maintenance charges. For this reason it might be appropriate for such assets as motor vehicles.
- (3) Machine hour method This method is used where we can estimate the life of an item of machinery in terms of the hours of use that we can expect from it. The depreciation charge would be based on the hours of use as a fraction of its total expected hours of use throughout its life. It is therefore appropriate for any item of plant where the major cause of its loss in value is through use, rather than time, and this usage can be quantified in terms of hours reasonably accurately.
- (4) Revaluation method The depreciation charge is calculated by adding purchases of new assets to the opening value for assets of that type and deducting from this the closing value of these assets. It is appropriate for such items as small tools (manufacturing company) or cutlery (hotel or restaurant) where there are several small items of low but lasting value.

Example 1.4

Explain with two examples of each the difference between revenue expenditure and capital expenditure. Why is the distinction between the two important in preparing final accounts and balance sheets?

Solution 1.4

Revenue expenditure such as rent and wages is taken account of in calculating the profit of the business. Capital expenditure is expenditure on fixed assets such as buildings and machinery, and is not taken account of in calculating profit (except by way of depreciation). The distinction is important, therefore, since the treatment of revenue expenditure as capital expenditure will show an unfairly high profit figure and, conversely, the treatment of capital expenditure as revenue expenditure will show an unfairly low profit figure.

Refer to the text. Also, the object of depreciation is *not* to provide for its eventual replacement. Any setting aside for replacement of assets is a transfer to reserves (an appropriation of profit), not a provision (charge against profits).

2 Partnership Accounts

2.1 Introduction

Examination questions on the topic of partnership accounts, in particular, will be set to examine your understanding of other accounting areas. These will include subjects such as year-end adjustments and forecasts which you studied at GCSE. You should study the worked examples very carefully to ensure that you have a thorough grasp of these GCSE topics. It may be necessary for you to go back to your GCSE book to revise these areas.

2.2 The partnership agreement

It is advisable for the partners to draw up an agreement covering the following areas:

- (i) Capital How much each should contribute and leave in the business.
- (ii) *Profit sharing* One partner may be entitled to a greater share of the profits because he has more experience or is doing a greater share of the work.
- (iii) Salaries One or more partners may be entitled to a salary because of the work they are performing.
- (iv) Interest on capital This might be appropriate where one or more partners is contributing a materially greater sum than others.
- (v) *Drawings* The agreement should cover the amount of profits that may be withdrawn and may further discourage drawings by charging interest on them.

Any points not covered in the partnership agreement are decided by reference to the Partnership Act 1890, which states:

- (i) Profits are shared equally.
- (ii) There are no partnership salaries.
- (iii) Partners shall receive no interest on capital but should receive 5 per cent interest per annum on any loans to the business.

2.3 Admission of new partner

When a new partner is about to be admitted, the existing partners will give consideration to revaluing assets — in particular, goodwill. In order to revalue assets, we debit the asset account with the increase in value of that asset and credit the partners' capital accounts according to their profit-sharing ratios. Similarly, if we want to recognise the value of goodwill built up by the existing partners, we debit a goodwill account and credit the existing partners' capital accounts according to their profit-sharing ratios.

Often the partners will decide that they do not want the value of goodwill appearing on the balance sheet. This is due to the uncertain value and nature of

such an asset. In order to eliminate goodwill, we must credit the goodwill account and debit the partners' capital accounts (including the new partner) according to their new profit-sharing ratios.

2.4 Realisation accounts

When a partnership ceases, it becomes necessary to close the books of account and record what happens to the assets and liabilities of the partnership.

The first step is to transfer the assets of the partnership from the asset accounts to a realisation account. We do this by debiting the realisation account and crediting the appropriate asset account. If these assets are sold for cash, we debit cash or bank with the proceeds and credit the realisation account. If the assets are taken over by one of the partners, we debit the partner's capital account and credit the realisation account with the agreed value for that asset.

The next stage is to pay any liabilities of the partnership (debit the liability account and credit cash or bank). There will usually be, additionally, realisation costs involved; these are debited to the realisation account.

The balance on the realisation account will now represent the profit or loss on winding up the partnership. This profit or loss is apportioned to the partners according to their profit-sharing ratios and is transferred to their current accounts.

The balances on the partners' current accounts are then transferred to their capital accounts. At this stage the only accounts that remain open are capital accounts and cash or bank. The books are finally closed by paying the partners the balance on their capital accounts or receiving from them the amounts due where they show a debit balance.

In the event of a partner's capital accounting showing a debit balance and his being unable to pay the amount due, there is an important legal point which should be noted. This is the Garner vs Murray 1904 rule, which states that, in the event of a partner being unable to pay the debit balance on his capital account, it must be shared by the other partners in proportion to their last agreed capitals.

2.5 Worked examples

Example 2.1

Misfit and Wartz are in partnership. At 31 December 1984 they agree that their assets are worth:

	£
Premises	200,000
Fixtures	80,000
Motor vehicles	60,000
Stock	20,000
Debtors	8,200
Bank	1,200
Cash	300

At the same date they have creditors of 5,700

During the year ending 31 December 1985 the following transactions took place:

- 1. On 1 July 1985 Misfit loaned the partnership £20,000 for ten years.
- 2. At the same date, Wartz increased his capital by £36,000 to make it equal to Misfit's.
- 3. Cash sales for the year were £300,000.
- 4. £490,200 was paid into the bank during the year.
- 5. Expenses paid in cash during the year were £2,400.

- 6. Expenses paid by cheque during the year were:
 - (i) wages £56,000;
 - (ii) lighting and heating and rates £9,700;
 - (iii) motor vehicle expenses £18,300;
 - (iv) carriage on purchases £3,400;
 - (v) other expenses £18,800.
- 7. Some small items of goods for resale were purchased and paid for out of the cash £10,000.
- 8. Goods which cost £1,200 had been returned to credit suppliers.
- 9. £288,720 was paid to creditors during the year. 10% cash discount had been deducted from all payments.
- 10. No discounts were allowed to debtors, but £200 had been written off as bad.
- 11. One of the vehicles is used occasionally by Misfit's wife. The cost of this usage (included in the motor vehicle expenses) is estimated to be £3,400; this to be charged to Misfit.
- 12. Both partners had taken goods from the business during the year valued at cost. These were estimated at:

Misfit £2,800; Wartz £1,900.

As Green does not require the partnership premises, they are sold for £20,000, and other fixed assets are taken over by Green at an agreed valuation of £12,000. Half the stock is taken by Green at its cost, the remainder being sold for £2,700. Green takes over the debtors after £500 has been written off as bad. The creditors are paid in full.

Half the loan is paid to Smith, who agrees to transfer the other half to Green for payment by him at a later date. The expenses of winding up the partnership were £500.

The partnership has been profitable over many years and although profitability has been maintained, recently the firm has suffered from cash-flow problems. In addition to the cash-flow problems, the partnership needs to reinvest in fixed assets at a cost of £42,000. Profits have been £40,000 per annum over the last three years and it is anticipated that the same level of profit will continue during the present year. Profit accrues evenly throughout the year.

A and B are considering two alternative methods of raising the necessary funds from 1 July 1985:

- (1) To purchase the fixed assets on hire purchase over a period of three years. The hire purchase agreement provides for 36 equal instalments of £1,500. (It can be assumed that interest is applied evenly over the three years.) In addition a long-term loan of £30,000 is available from a finance company at 15 per cent interest with only the interest being repayable over the first two years.
- (2) To accept into the partnership a new partner C on the following terms from 1 July 1985:
 - That C will bring into the partnership £60,000 cash as capital.
 - That the partners will be entitled to interest at the rate of 15 per cent per year on fixed capital.
 - That A and B will be entitled to a salary of £3,200 per annum and £2,000 per annum, respectively.
 - That the balance of profits and losses will be shared equally between the partners.

2.6 Further exercises

Question 2.1

James, Peter and Paul have been in partnership for several years, trading as Goodgame and Co. On 1 January 1982, Peter announces his intention to retire. James and Paul invite John, a young accountant, to join them in partnership. James, Peter and Paul share profits 3:2:1, respectively, and their agreement allows for interest on capitals at 5 per cent per annum.

Peter finally retires on 30 June 1982, and John is admitted into the partnership on 1 July 1982. On Peter's retirement the goodwill of the business is valued at £30,000. Before John is admitted James and Paul agree to revalue the premises to £120,000 and Fittings to £18,000. Because the stock contains several obsolete items it is decided that the value should be reduced by £2,000.

The agreement between James, Paul and John allows for interest on capital at 8 per cent and a partnership salary to John of £8,000 per annum. John is to receive $\frac{1}{4}$ of the profits and James and Paul are to share the remainder equally. John is asked to bring in £5,000 as his share of the goodwill and £5,000 capital. John agrees that he will leave £5,000 of his profit per annum in the business as capital until it equals £25,000. Profits will then be shared equally. Until this time John will not receive interest on his capital.

On the entry of John, Paul agrees to leave his share of the goodwill brought in by John in his Capital account. James is allowed to withdraw his share of this goodwill at any time.

At 31 December 1982 the following trial balance is prepared from the books. No adjustments have been made in the books for any of the items agreed at the time of the change of partnership. The only entries made are that all the payments made by John have been credited to his current account. Peter's share of the goodwill has been paid to him on 30 June 1982, and his capital account has been reduced by the same amount. He has agreed to leave the remainder in the partnership until 1 January 1983.

The profits of the partnership have been low during recent years but a new business opportunity is available from 1 December 1983 requiring an additional investment of £20,000. 3 Issue of Shares and Debentures

3.1 Types of capital

A limited company may raise finance either by issuing shares or by raising loans. Debentures are simply a type of loan. Shares may be further subdivided into different types, as follows.

- (i) Preference shares are shares which carry the right to a fixed dividend before any dividend can be paid to the ordinary shareholders. Where there are insufficient profits (including those retained from previous years) to cover the preference dividend, then none can be paid and it is lost.
- (ii) Cumulative preference shares are similar to preference shares, but if in any one year, because of the circumstances described above, the dividend is not paid it accumulates and is carried forward until such time as there are sufficient profits to cover both current dividends on the shares and the arrears.
- (iii) Ordinary shares carry no right to a fixed dividend and dividends are decided upon once the profit is known. There is a risk of no dividend, but at the other end of the scale there is no limit on the amount.

Finally, you should appreciate that all loans, including debentures, mean that the company incurs interest charges. Interest is an expense of the company, which must be paid whether profits are earned or not. Debenture holders of the company are its creditors. Conversely, shareholders own the company and earn a right to dividends, which are an appropriation of profit.

3.2 Authorised and issued share capital

When a company is formed, it is necessary to prepare a Memorandum of Association, which is a legal document setting out its constitution and powers. Among other things, this document states the amount of share capital with which the company proposes to be registered and which is therefore the maximum amount it will be allowed to issue. However, when the company commences, it will only issue sufficient shares to raise the cash it needs.

3.3 Issues at a premium or discount

All shares and debentures have a nominal or face value (also referred to as par value). This is the amount at which they will appear in the balance sheets if they have been fully paid for. However, shares and debentures may be issued at a

premium or discount to this par value. The reasons for this are not always logical, but if a company has other shares already in existence, then any further issues must be at a price near to the market price of those existing shares. This is necessary so as not to disadvantage the existing shareholders.

The share premium account is a so-called capital reserve. That is to say, it cannot be distributed to shareholders as dividends. The uses to which it may be put, as laid down by the Companies Act 1985, are:

- (i) to issue bonus shares (see Section 3.6);
- (ii) to write off share and debenture issue expenses and commissions;
- (iii) to write off preliminary expenses;
- (iv) to write off discounts allowed on shares or debentures:
- (v) under certain circumstances, to provide for any premium payable on redemption (see Chapter 6).

At this point it is helpful to consider the journal entries for a share issue at a premium or discount. We could, in a simple case,

- Dr. Bank
- Cr. Share capital
- Cr. Share premium

or

Dr. Discount on shares

You should be aware that there are legal restrictions on issuing shares at a discount, and the amount of discount must be written off (against reserves or in the profit and loss account) immediately.

In practice, we would expand the above journal entries by use of an intermediate account called an applications and allotment account, and this is demonstrated later in this chapter.

3.4 Payment by instalments

It is common for payments to be made by instalments as follows:

- (i) Application the amount payable by potential investors or shareholders when they apply for the shares.
- (ii) Allotment the amount payable when the company decides to allot the shares to the above applicants who have been successful. Often people apply for more shares than the company is issuing and one of two things may then happen. First, a ballot may be held and application monies may be returned to the unsuccessful applicants. Second, applications may be scaled down so that applicants only receive some but not all of the shares for which they applied.
- (iii) Calls the final amounts payable as and when called by the directors.

You should note from the worked examples that the balance sheet figure for share capital includes only amounts called up by the company (including application and allotment monies).

The accounting treatment for an issue payable by instalments is as set out in Worked Example 3.1. You should note the following: Debit bank and credit application and allotment with monies actually received. (Reverse the entry for monies refunded.) Debit application and allotment and credit both share capital and share premium with amounts due on application and allotment. Alternatively,

if there is a discount, debit share discount. With debentures the procedure is identical, except that debentures are credited and not share capital.

3.5 Rights issues

Rights issues are nothing more complicated than shares offered first of all to existing shareholders. That is to say, existing shareholders have the right to apply for the shares being issued. The accounting treatment is not affected.

3.6 Bonus issues

Bonus shares are issued when there is a build-up of reserves (e.g. undistributed profits) in the company. These profits will often not be represented by cash, since the profits have been invested in other assets to expand the business. The issue of bonus shares is recorded as follows:

- Dr. Profit and loss (retained earnings)
- Cr. Share capital

This decreases the amount of retained earnings and increases share capital. There is no entry on cash or bank because no cash changes hands; the bonus shares are issued free.

You should realise that the shareholder receiving the shares is no better off, since, although he owns more shares, each share will now be worth less.

3.7 Forfeit of shares

Forfeit of shares arises where shares are issued payable by instalments and a share-holder fails to pay an amount due on a call. The accounting entries are

- Dr. Share capital
- Cr. Forfeited shares (with the nominal value or called-up value if not fully paid)
- Dr. Forfeited shares
- Cr. Call, application and allotment (with amounts unpaid on the shares)

The balance on the forfeited shares account now represents the amount paid by the shareholder. If the shares are then cancelled, this balance is part of the capital reserves. Often, however, they will be reissued and the entries for that reissue are then as follows:

- Dr. Forfeited shares
- Cr. Share capital (amount as first entry above)
- Dr. Bank
- Cr. Forfeited shares (monies received)
- Dr. Forfeited shares
- Cr. Share premium (balance on forfeited shares account)

3.8 Worked Examples

Example 3.1

The William Co. Ltd, with an Authorised Capital of £1,000,000, have already issued 600,000 £1 shares on 1 January 1983 when they offer 200,000 £1 Ordinary Shares to the public at a price of £1.50 each. The terms of issue are 50p payable on application, 80p (including the premium) on allotment and the remainder to be called later.

Applications were received by 31 January for 300,000 shares and on 2 February allot-ments were made as follows:

- (a) 50,000 applications were refused and the money was returned to the applicants.
- (b) The remainder of the shares were issued on a pro rata basis, any money overpaid being retained towards the amount due on allotment.

All money due on allotment was received by 28 February. The call for the remaining money was made on 4 April and by 30 April all but 2,000 shares had been paid for.

You are required to:

- (i) Prepare journal entries to record the issue of these shares and the call made on 4 April, and
- (ii) Show how the Ordinary Share Capital appears in the Balance Sheet of the Company at 30 April 1983. [18 marks]

Example 3.2

Growfast Ltd, having established itself as a manufacturer of plastic products, is now in a position to expand its production. The company is considering three alternative ways of financing the £2,000,000 required to purchase the fixed assets. It is company policy to depreciate fixed assets at the rate of 10 per cent per annum on cost.

- Alternative (1) To issue 1,000,000 £1 ordinary shares at £2 per share. The directors of the company intend to continue to pay dividends of 15 per cent per annum.
- Alternative (2) To issue at a discount of 3 per cent £1,500,000 in 12 per cent debentures redeemable in ten years' time. The discount is to be written off over the tenyear period. The remaining fixed assets that are required are to be hired from Hirers Ltd over a ten-year period at an annual rental of £65,000.
- Alternative (3) To purchase the fixed assets on credit. The terms of the credit agreement provide for five annual instalments of £450,000 each. Assume that interest accrues evenly over the period of the loan.

Solution 3.2

(a) (1) Dividends payable of 150,000 (15 per cent of nominal value) would appear as an appropriation of profit at the end of the profit and loss account after the net profit had been calculated.

(2) The discount of £4,500 ($\frac{1}{10} \times 3\% \times £1,500,000$) would appear as an expense under the heading 'interest payable' and similar charges (see Chapter 4).

The hire charges of £65,000 ($\frac{1}{10} \times £65,000$) would also appear as an expense under the heading 'cost of sales' (as it is production plant).

Debenture interest of £180,000 would appear as an expense in the profit and loss account.

- (3) The interest charge of £50,000 (5 \times £450,000 = £2,250,000; therefore interest charge to be spread over five years would be £250,000).
- (b) (1) Share capital would increase by £1,000,000. Share premium would increase by £1,000,000.
 - (2) Creditors, amounts falling due after more than one year
 Deferred asset (discount not written off) £1,500,000
 £41,000

It should be noted that current accounting practice may require that the hired assets be included in the balance sheet also. This would almost certainly be outside the scope of any A-level syllabus.

(3) Fixed assets (less depreciation) £2,000,000 (Assets should always be shown at their cash price.)

Creditors, amounts falling due within one year £1,600,000 (This represents the repayment element only of future payments.)

(c) An existing shareholder might be reluctant to accept alternative (1), since if he does not have sufficient funds to purchase any of the additional shares, his stake in the company will become diluted. However, alternatives (2) and (3) expose the company (and therefore its shareholders) to additional risk, since additional profits have to be made to cover the interest charges incurred. Further, under alternative (2) the company will have to consider how it is going to redeem the debentures in ten years' time: where will the funds come from?

3.9 Further exercises

Question 3.1

A group of six young computer enthusiasts is considering forming a small business to market software and to repair certain types of hardware.

They have estimated that the total amount of capital that they require is £850,000, which they can raise in a variety of ways.

The projected operating profits for the first three years are:

They have managed to agree on the following three possible capital structures for the business:

Lines 2, 4 and 5 include the appropriate charge for depreciation of fixed assets. Any amounts included by way of hire costs for plant and machinery must be disclosed separately by way of notes. Similarly, auditor's remuneration must be disclosed by way of note.

Lines 15 and 16 items will be defined in chapter 4.

The published format ends with the net profit or loss for the year. However, the Act itself requires that both dividends and transfers to and from reserves should be shown separately.

4.2 Balance sheet

Again the 1985 Companies Act allows a choice of formats, and shown below is the one most commonly used.

Fixed assets may be valued at cost or a revalued amount. In the latter case the difference between cost and the revalued amount must be shown as a revaluation reserve (K. III) and not included as profit.

Additional information for fixed assets must be provided. For each category we must detail cost (or valuation) at the beginning of the year and show additions and disposals, and the effect of revaluations during the year; this should then lead to cost (or revaluation) at the end of the year. Similarly, for the depreciation provisions we must show the balance at the beginning of the year and the charge for the year, the write-back on disposals, and so arrive at the year-end balances for depreciation provisions. Worked Example 4.3 illustrates this requirement.

Called-up share capital is the amount paid and amounts due but unpaid at the balance sheet date. The accounting treatment was discussed further in Chapter 3 but here we should note that a company must make additional disclosure of (a) the authorised share capital as stated in its memorandum of association; (b) the

number and aggregate value of shares of each class allotted (e.g. preference and ordinary).

In the capital and reserves section, be aware that some reserves are distributable by way of dividends (e.g. profit and loss account balance). Others (e.g. share premium and revaluation reserve) may not be distributed by way of dividend.

Finally, there is a requirement to show by way of note any contingent liabilities; these are explained in Chapter 5. Specifically we must provide details of: (a) contracts for capital expenditure not provided for; (b) capital expenditure authorised by the directors which has not been contracted for.

After the preparation of the draft balance sheet the following information became available.

- (1) No entry had been made in the books of the company to record the sale of a motor vehicle to a retiring member of staff. Although the sale was completed during October 1986, it has been agreed that the former employee need not pay for the vehicle until January 1987. The vehicle, which was purchased in December 1985 for £7,000, was sold to the former employee for £1,000. It is company policy to depreciate motor vehicles at the rate of 25 per cent each year based on the cost of assets shown in the accounts at the end of the financial year.

5 Statements of Standard Accounting Practice

5.1 Introduction

Prior to 1981 the Companies Acts were generally deficient in the regulation of accounting principles, and even with what has now become the 1985 Companies Act there are still many different bases which can be used legally in the preparation of accounts. The bases of stock valuation and calculation of the depreciation charge are two examples.

This weakness has been overcome to an important degree by the issuing of Statements of Standard Accounting Practice (SSAPs) by the major accountancy bodies. The object of these SSAPs is first and foremost to ensure a degree of standardisation and uniformity in the preparation of accounts. Where, for various reasons, this uniformity cannot be achieved, the SSAPs require that companies must make sufficient disclosure (of, for example, bases and policies) to give users of accounting information a fuller picture of the facts as they would wish to know them

Since the first was issued in the early 1970s further SSAPs have been issued and existing ones revised or withdrawn. Below are listed the SSAPs relevant to the A-level syllabus.

5.2 SSAP2: Disclosure of accounting policies

Chapter 1 dealt with the fundamental accounting concepts covered by the SSAP. In applying these concepts companies may still use different bases of accounting (e.g. stock valuation). The SSAP requires that accounting policies (i.e. selection of bases) should be stated by way of a note to the accounts.

5.3 SSAP3: Earnings per share

'Earnings' is another word for 'profit', and earnings per share is therefore the figure arrived at by taking the company's profit after tax and dividing by the number of ordinary shares issued. Thus, it can be used by investors to compare the results of a company over a period of time. For this reason SSAP3 requires that we use the profit figure after tax but before extraordinary items (defined in Section 5.6). This ensures that any trend figure is not distorted by these items.

The earnings per share figure can also be defined as the amount of profit attributable to one share in the company.

SSAP3 requires that the figure be stated on the face of the profit and loss account.

5.4 SSAP4: The accounting of treatment of Government grants

SSAP4 divides grants into revenue grants and capital grants.

Revenue grants are credited to revenue in the same period as that in which the revenue expenditure to which they relate is charged.

Capital grants are grants to cover a proportion of the costs of items of capital expenditure. These must be credited to revenue over the expected useful life of the asset, and this can be done in one of two ways:

- (i) by reducing the cost of the asset by the amount of the grant and depreciating the reduced cost;
- (ii) by treating the grant as a deferred credit and transferring part of it annually to the profit and loss account.

5.5 SSAP5: Accounting for value added tax

VAT (value added tax) will in most cases be added by the business to its selling price. At the same time, it will incur VAT when it purchases goods and services from its suppliers. The business will then on a quarterly basis pay over to HM Customs and Excise the amount of VAT charged on its sales less VAT incurred on its purchases.

In the circumstances outlined above, both sales and purchases will be recorded excluding VAT. VAT charged to customers will be credited to the VAT account and VAT incurred will be debited to the VAT account. The balance on the VAT account will therefore represent the amount due to or from HM Customs and Excise, and as such should be shown as a debtor or creditor in the balance sheet.

There are circumstances in which VAT on purchases cannot be recovered. Briefly, these concern:

- (i) persons not registered for VAT;
- (ii) persons carrying on exempted activities (e.g. banking and insurance);
- (iii) non-deductible inputs, including tax on private motor-cars and entertaining UK customers.

In any of the circumstances (i)–(iii) the VAT element must be included in the cost of the item purchased and the tax inclusive amount debited to the appropriate asset or expense account. If this procedure is followed, except in circumstances (i)–(iii) outlined above, all figures for sales, purchases and expenses will therefore be net of VAT.

5.6 SSAP6: Extraordinary items and prior year adjustments

In the Companies Act format for the published profit and loss account (Section 4.1) we referred to the separate lines for extraordinary items. SSAP6 defines these as items which derive from events or transactions outside the ordinary activities of the business and which are both material and not expected to recur frequently or regularly.

This SSAP has been and is still the subject of much debate. However, examples would be:

- (i) redundancy costs related to a discontinued business;
- (ii) the sale of an investment not acquired with a view to resale;

(iii) writing off intangibles due to unusual events.

The logic behind this SSAP is to give users of accounts an indication of the trend in profits and level of profitability undistorted by those extraordinary items.

5.7 SSAP8: Treatment of taxation under the imputation system

The only knowledge required of SSAP8 is that the tax charge will appear as a charge in the profit and loss account on the appropriate line. You should notice that dividends are paid out of profits which have themselves already been subject to tax by way of corporation tax. For this reason dividends are deemed to be paid net of tax and no further tax is usually payable by the recipient.

In calculating the taxation charge in the profit and loss account, an estimate will usually be required to be made, since the exact liability will not have been finalised. Any over- or under-provision, when the taxation charge is finalised, will be adjusted in the following year's profit and loss account in the same way as any other over- or under-accrual.

The taxation charge will usually be paid sometime after the company's year end. However, when a dividend is paid, a company is required to make an advance payment of corporation tax or ACT (advance corporation tax). The amount of this ACT is then deducted from the total corporation tax liability when that latter liability becomes due.

5.8 SSAP9: Stocks and work in progress

Chapter 14 covers the points you need to know about SSAP9.

5.9 SSAP10: Statements of source and application of funds

Chapter 19 fully discusses this topic.

5.10 **SSAP12: Accounting for depreciation**

SSAP12 requires that all fixed assets having a finite useful life be depreciated. The major item of fixed assets not requiring to be depreciated will therefore be free-hold land.

SSAP12 recommends no particular method, but requires businesses to allocate depreciation as fairly as possible to periods expected to benefit from the use of the asset. Thus, any one of straight line, reducing balancing, sum of digits, depletion unit, machine hour or revaluation methods might be appropriate.

5.11 SSAP13: Accounting for research and development

SSAP13 deals with the occasions when development costs may be deferred to future periods by treating them as an asset in the balance sheet under intangible assets.

Research costs, whether pure or applied, should always be regarded as a continuing operation and therefore written off as they are incurred.

Development costs may be deferred when:

- (i) there is a clearly defined development project, and the related expenditure on this project is separately identifiable;
- (ii) the expected outcome of the project has been assessed, and there is reasonable certainty that
 - (a) it is technically feasible, and
 - (b) it is commercially viable;
- (iii) the eventual profits from the developed product or system will be sufficient to cover past and future costs;
- (iv) the company has adequate resources to complete the development project.

If any of these conditions is not satisfied, the development costs should be written off in the year of the expenditure.

5.12 SSAP14: Group accounts

The topic of SSAP14 is mostly outside the scope of A-level syllabuses. However, an elementary knowledge is necessary.

Where a company owns more than 50 per cent of another company, that company is a subsidiary of the first company. SSAP14 requires companies with subsidiaries to prepare group accounts including a consolidated profit and loss account and balance sheet. These consolidated or group accounts will incorporate the figures (assets, liabilities, revenues and expenses) for the holding company itself and its subsidiary company or companies.

Where the subsidiary is not fully owned, the total profit of that subsidiary is incorporated in the group accounts initially, with a deduction shown for that share of the subsidiary company's profits attributable to outside (or minority) shareholders. Similarly, all of the subsidiary company's assets are included in the group balance sheet and that proportion owned by outside shareholders is shown elsewhere as minority interest.

5.13 SSAP17: Accounting for post-balance sheet events

SSAP17 requires that any information coming to light after the balance sheet date, but before the accounts have been signed by the directors, should not be ignored. If that information alters our opinion as to the value of an asset or the amount of a liability at the balance sheet date, then we should adjust the accounts accordingly. Any information which does not so alter our opinion, but which would be of interest to users of accounts, should be disclosed by way of note.

5.14 SAP18: Accounting for contingencies

A contingency is a condition which exists at the balance sheet date where the outcome will be confirmed only on the occurrence or non-occurrence of one or more uncertain future events. A contingent gain or loss is a gain or loss dependent on a contingency.

We noted in Chapter 4 that, where contingencies have not been provided for in the accounts, further information must be given by way of note. SSAP18 recommends the following treatments dependent upon likelihood.

- (i) Contingent losses If it is probable that a loss will result, then provide for it. If it is reasonably possible that a loss will result, then disclose it by way of note only. Otherwise ignore.
- (ii) Contingent gains If a gain is probable, then disclose it by way of note. If a gain is less than probable, then ignore it. Contingent gain must be a near-certainty before an 'accrual' in the profit for the year becomes appropriate.

5.15 **SSAP22:** Accounting for goodwill

The appropriate parts of SSAP22 are discussed in Chapter 7.

5.16 Worked examples

This will eliminate the liability and is all that needs to be done. However, because of the strain on the bank balance, many companies set aside out of profits annually an amount to provide for the redemption; this is done as follows:

Dr. Profit and loss

Cr. Debenture redemption reserve

The debenture redemption reserve is part of the total reserves of the company making up the shareholders' funds. By doing this the company is indicating that it is not intending to distribute those reserves by way of dividends.

6.2 **Redemption of shares**

The 1985 Companies Act gives a company power to issue both redeemable preference shares and redeemable ordinary shares. While giving this power, the Act also ensures that creditors (including debenture holders) are protected. This is necessary, since on a winding up of the company the shareholders rank last in order of payment and, if it were not for the above protection, a troubled company could use share redemption to give preferential treatment to its shareholders.

The protection is given by requiring that shares can only be redeemed from one or both of the following:

- (i) the proceeds of a new issue;
- (ii) out of profits, which involves transferring an amount equivalent to the cost of redemption from distributable reserves to non-distributable reserves.

This will ensure that the balance sheet figure for share capital and non-distributable reserves is not reduced. An understanding of this basic objective will help you to understand the journal entries involved, particularly when share premiums make the situation a little more complex.

Referring back to (i) and (ii) above, you will appreciate that, in the case of a new issue of shares to finance redemption of others, the only change on the

balance sheet is a substitution of old shares by new shares. Where the redemption is financed by method (ii), the journal entry is as follows:

- Dr. Profit and loss
- Cr. Capital redemption reserve

This is similar to the journal entry described in Section 6.1, which the company made voluntarily, whereas in the case of share redemption there is a legal requirement for it.

We shall now consider the case of redeeming shares at a premium. This will normally be done as follows:

- Dr. Share capital (nominal value of shares redeemed)
- Dr. Profit and loss (premium payable on redemption)
- Cr. Bank (cost of redemption)

The above reflects the final effect on the balance sheet; however, theoretically a share redemption account should be used as follows:

- Dr. Share capital
- Cr. Share redemption

followed by

- Dr. Share redemption
- Cr. Bank

However, where the shares were originally issued at premium, the company may debit share premium account with the premium on redemption, provided that:

- (i) the redemption is financed by a fresh issue of shares;
- (ii) the premium does not exceed the lower of
 - (a) the premium received on the issue of the shares redeemed,
 - (b) the current balance on the share premium account (including premiums on the new issue).

Where redemption is financed only partly by the issue of new shares at premium, we must consider how much needs to be transferred to the capital redemption reserve. The more generally accepted view of the legal requirement is as follows: transfer to capital redemption reserve the nominal value of the shares redeemed less the proceeds (including premium) of the new issue.

6.3 Purchase of company's own shares

Subject to observing the legal requirements, companies may purchase their own shares. The accounting treatment is then almost identical with that for share redemption. Public companies must either finance the purchase by a new issue of shares or by capitalising distributable profits. Private companies are not so restricted but they have to meet further legal requirements.

A company will use this method where there is no power of redemption contained in the company's articles of association.

6.4 Worked examples

Example 6.1

A company has an authorised capital of 2,000,000 £1 shares, of which 1,500,000 have been issued. At 31 May 1985 the balance sheet of the company shows the following items:

- (1) Refer to Section 6.2. The share premium must be charged to profit and loss, since shares were not originally issued at a premium.
- (2) Refer to Section 3.3. It would be logical to utilise the share premium account balance for the bonus issue.
- (3) Nominal value of shares redeemed is £50,000 less proceeds of new issue £30,000. Some accountants have suggested that in the above case we could reduce the amount needed to be transferred by a further £2,000, this £2,000 being the amount of non-distributable reserves capitalised when the bonus shares are issued. However, a strict interpretation of the 1985 Companies Act would require that £20,000 as above be transferred to the capital redemption reserve. In view of this, it would be a good idea to qualify your answer accordingly.

Question 6.2

- (a) Explain why the capital and profits of a business are liabilities and not assets.
- (b) A company can 'purchase' or redeem its own shares; what is the difference between these two terms? [8 marks]

Answer 6.2

- (a) Both capital and profits represent the owners' investment in the company capital by way of cash introduced and profits by way of amounts left in the business. Both amounts can therefore be deemed to be amounts due to the owners of the business by the business itself.
- (b) Refer to the text. Shares may be issued as redeemable and redeemed in accordance with the terms of issue and legal requirements. A company may purchase its own ordinary shares provided that the legal requirements are fulfilled.

7 Takeovers and Mergers

7.1 Types of amalgamation

Businesses amalgamate in order that together they may achieve more than the sum total of what they would achieve by remaining independent. The amalgamation may come about as a result of:

- (i) a partnership being taken over by another sole trader, a partnership or a limited company;
- (ii) a partnership being taken over by another partnership or a limited company;
- (iii) a limited company being taken over by another limited company;
- (iv) a new company being formed to take over one or more existing businesses.

In any type of examination question on this subject you will have to deal with either the books of the new business, the books of the old business or possibly both. However, the accounting treatment will be affected little by which of the above types of amalgamation you are faced with.

7.2 Books of the old business

The steps necessary to close off the books of the old business are as follows.

(i) Transfer all assets and liability accounts which are being taken over to a realisation account, as follows:

```
Dr. Realisation
Cr. Various assets

and

Dr. Creditors
Cr. Realisation

Bliabilities taken over
```

Be sure to leave out any assets or liabilities not taken over — for example, cash and/or creditors.

- (ii) If any assets are to be taken over by somebody other than the new business, then deal with these by
 - Dr. Cash or Purchaser or Partner's capital
 - Cr. Realisation (with the agreed value of these assets)
- (iii) Calculate the total value of the consideration (shares, debentures and cash) being paid by the new business and deal with this by
 - Dr. Purchaser of business
 - Cr. Realisation

- (iv) In the case of a company being taken over, transfer to a sundry members account the balances on ordinary share capital, reserves and intangible or fictitious assets as follows:
 - Dr. Ordinary share capital
 - Dr. Reserves (e.g. profit and loss, share premium, etc.)
 - Cr. Goodwill
 - Cr. Sundry members
- (v) Ascertain the balance on the realisation account. This will represent a profit or loss on realisation and should be transferred to capital account(s) (in the case of sole traders and partnerships) or sundry members account (in the case of a company). In other words,
 - Dr./Cr. Realisation
 - Dr./Cr. Capital or Sundry members (with balance on realisation account)
- (vi) Deal with the consideration being received from the new business as follows:
 - Dr. Cash (with cash part of consideration)
 - Dr. Sundry members (with value of shares in new business issued to them)*
 - Dr. Debentures or preference shares (with any part of the consideration received by them)*
 - Cr. Purchaser of business (with total purchase consideration)

Note that you may also find that the debit at first is to an account called 'shares in new company' account. If this is so, this account will then be credited at a later time with a debit to the accounts asterisked above.

- (vii) Pay any liabilities which the old business itself has to settle by
 - Dr. Creditors
 - Cr. Bank
- (viii) Any balance on the bank account should now be equal to an opposite balance on capital (sole traders or partnerships) or sundry members (company). This balance will be used to settle the liability to them as follows:
 - Dr. Capital or Sundry members
 - Cr. Bank

All of the accounts in the books of the old business should now be closed.

7.3 Books of the new business

It is important to ascertain the values at which the assets, in particular, are to be recorded in the books of the new business. The entries will then be as follows:

- (i) Dr. Various assets (with agreed values)
 - Cr. Liabilities (with liabilities taken over)
 - Cr. Purchase of business (with total consideration paid for those assets and liabilities)
 - Dr. Goodwill (balancing figure)*

The item asterisked is the difference between the price paid for the business as a whole and the total values of the individual assets less liabilities. If the figure is negative there will be a credit to capital reserve.

- (ii) Dr. Purchase of business (total consideration as above)
 - Cr. Cash (with cash part of consideration)
 - Cr. Share capital (nominal value of shares issued as consideration)
 - Cr. Share premium (agreed value less nominal value of shares issued as consideration)

In simple cases you may find that the purchase of business account is bypassed and journal entries (i) and (ii) above are then combined with the purchase of business account omitted.

7.4 Worked examples

Example 7.1

On 30 April 1986 a new company, Rainbow plc, was formed to take over three existing companies. The authorised capital of Rainbow plc was to consist of 1,000,000 Ordinary Share of 50p each.

The terms of the takeover were as follows:

BLUE plc The creditors and all the assets with the exception of the bank to be taken over at book values, settlement to be: nine ordinary shares in Rainbow for every fifty ordinary shares in Blue. Four ordinary shares in Rainbow for every two preference shares in Blue and a cash payment of £99,000.

Blue plc is to redeem its own debentures at par.

ORANGE plc All the assets and liabilities except the bank overdraft to be taken over at a price of £98,000, half of the purchase price to be in ordinary shares in Rainbow.

GREEN plc Rainbow will not take over the creditors but will take over all the assets, including bank, and will settle with one ordinary share in Rainbow for each ordinary share in Green. The debenture holders are to receive 200 ordinary shares in Rainbow for every £100 debentures. £25,000 is to be paid to Green in cash.

All the necessary formalities are completed by 31 May 1986 by which time Rainbow plc have issued all the remaining shares at a premium of 5p per share. Legal expenses of the takeover, £20,000, have been paid and land and buildings have been revalued at £100,000. Apart from this there are no other transactions for Rainbow for the month.

8 Capital Reconstruction

8.1 The need for capital reconstruction

Capital reconstruction schemes usually become necessary following periods of losses, and any or all of the following features will be present.

- (i) A debit balance will have built up on the profit and loss account.
- (ii) In addition to (i), there may be other debit balances on the books, representing a non-existent or fictitious asset e.g. goodwill.
- (iii) The business may be unable to meet its obligations to creditors as and when payments become due. These obligations will include interest relating to loans.
- (iv) There may be arrears of dividends on cumulative preference shares.

8.2 The object of the reconstruction

A company suffering from the above symptoms will find it very difficult, if not impossible, to raise new finance. This will make it very difficult to continue trading; in fact, the obvious action may seem to be to wind up the company. Winding up is obviously a drastic step, and a business will usually make every attempt to avoid it. If winding up is to be avoided, what the company really needs is a fresh start, and this is where the capital reconstruction scheme comes in.

The primary objectives of the scheme must be to:

- (i) eliminate non-existent or fictitious assets from the balance sheet;
- (ii) restate other assets to more realistic values if necessary (for example, stocks may need restating to realisable values and provision may be required against bad or doubtful debts).

8.3 How the reconstruction is achieved

The easy part will usually be deciding the values at which assets should be restated. However, this can only be achieved by a reduction in liabilities or capital or reserves. The first reaction of a creditor will be: why should I accept a scheme which offers me less than I am due? Similarly, a shareholder would ask why he should accept a reduction in the value (albeit the nominal value) of the shares he owns. The answer to both is that by accepting the scheme they will benefit more than by allowing the company to go into liquidation.

Consequently, a reconstruction, after much negotiation, will usually be achieved along all or any of the following lines.

- (i) Creditors (including debenture holders) may accept newly issued shares in lieu of part or all of the amounts owed to them. Alternatively, they may forego part of the debt altogether.
- (ii) Preference shareholders may agree to forego arrears on dividends. They may also accept a reduction in the value of their shares, or the issue of new shares (of a lesser value) in replacement of their existing shares.
- (iii) Ordinary shareholders, because they would receive less in a winding up, must also be prepared to take the majority of the writing down in any reconstruction scheme. As in (ii), this may be achieved by reducing the nominal value of the shares held or cancelling the existing shares and issuing new ones of a lesser value.

The negotiations to achieve the above will often be long and arduous. Once everybody (sometimes only a majority) is in agreement there are then legal requirements which have to be observed. However, any examination question on this topic will be mostly, if not wholly, concerned with the accounting treatment of the reconstruction.

8.4 The reconstruction account

The reconstruction account is at the centre of the accounting treatment, which we will now illustrate.

- (i) Transfer to the reconstruction account any debit balances to be written off or eliminated by
 - Dr. Reconstruction
 - Cr. Asset (or profit and loss where we need to eliminate the debit balance on that account)

Where any asset is only partially being written down, then the above entry will be for the amount of the reduction only.

- (ii) Transfer to the reconstruction account the amount of any shares which are being cancelled, or the value by which they are being reduced, as follows:
 - Dr. Share capital
 - Cr. Reconstruction

Where shares are issued in replacement, then

- Dr. Reconstruction
- Cr. Share capital
- (iii) Transfer to the reconstruction account the amount of any liabilities being foregone by
 - Dr. Liability
 - Cr. Reconstruction

If shares are issued as part of the scheme, then record as in (ii) above.

(iv) Deal with any remaining balance on the reconstruction account as required – for example,

Dr./Cr. Reconstruction Dr./Cr Reserves

8.5 Worked example

Example 8.1

The Anglo Stock plc has been trading as a retailer for a number of years, but has recently been having difficulty in trading. In order to make the company more attractive a scheme for restructuring the capital of the company has been agreed by all the necessary parties involved, with effect from 1 January 1984.

At 31 December 1983, the following were some of the items appearing in the balance sheet:

The terms of the reconstruction have been agreed as follows;

- (a) The nominal value of the ordinary shares shall be reduced to 40p each.
- (b) The preference shares shall be cancelled and replaced by a 3 for 4 issue of new 10 per cent Preference shares redeemable in 2005. The nominal value of the shares is £1.
- (c) The Preference dividend outstanding will be honoured by the issue of Ordinary shares to the preference shareholders.
- (d) The creditors will be offered settlement by a payment of 50p in the £ and new ordinary shares to the balance. Three-quarters of the creditors accept this offer; the remainder are paid in full.
- (e) Sufficient Ordinary Shares shall be issued at 50p, payable in full on application, to bring the issued share capital to its original value. This issue was fully subscribed and the shares were allotted on 25 February 1984.
- (f) The Capital reserves are to be utilised before revenue reserves are used.
- (g) The loan stock interest outstanding is settled by a cash payment.

During the year ending 31 December 1984 the company modernised their retail outlets at a capital cost of £400,000, half of which had been paid by 31 December. Business was boosted by an original advertising campaign which was to be repeated in 1985. The total cost of the campaign was £50,000 and all of this was paid in 1984.

Receipts from Debtors during the year were £1,240,000 and £1,570,000 was paid to creditors and for operating expenses.

The company made profits for the year of £75,000 (after tax and appropriations). Depreciation of £309,000 had been charged; the preference dividend had been paid as had the Loan Stock interest. £10,000 had been transferred to reserves.

The shares were issued on 31 December 1984, but would not qualify for dividend until December 1985.

(3) In order to increase cash funds an issue of debentures was made on 1 January 1985. The terms of the issue were:

£200,000 8% Debenture stock 1996-2000 issued at £98 for £100 of debenture stock, cash payable on issue.

In addition the company's accountant discovered that the following items had not been entered into the company's books.

- (4) A substantial trade debtor owing £50,000 had gone into liquidation on 1 December 1984. The receiver had advised the company that unsecured creditors would not receive any money.
- (5) The directors had recommended dividend payments as follows:

ordinary shareholders: 10p a share preference shareholders: 9% for the year, but the first half year payment of $4\frac{1}{2}$ % had already been paid.

(6) On 28 December 1984 £7,000 of goods bought on credit for stock had been included in the year end stock valuation, but no entry had been made in the purchases day book.

9 Social Accounting

9.1 What is it?

Social accounting has been defined as 'the measurement and reporting, internal or external, of information concerning the impact of an entity and its activities on society'. It is, therefore, concerned with the reporting in accounting statements of a business's activities which affect society. Fundamental to its being is the idea that management's objectives should not solely be the maximisation of profits. They have additional responsibilities, such as:

- (i) to produce safe and reliable products of a high quality;
- (ii) to ensure that they do not cause pollution;
- (iii) to ensure that they do not discriminate against groups of workers such as women and ethnic minorities:
- (iv) to ensure that their employees are not exposed to undue risk;
- (v) to devote some effort towards social programmes.

9.2 The need and demand

(a) Internal

Under this heading we consider directors, management, other employees, local union, public relations department and legal department. In order to ensure that the business's policies are followed and that they are acknowledging their social responsibilities, all of the above need information. Such information might include, for example:

- (i) details of product testing, to ensure that there is no danger to consumer health, as well as details of any reported health risk or damage;
- (ii) the number of internal promotions and recruitments of women and from minority groups;
- (iii) details of energy usage and conservation efforts;
- (iv) details of the effects on the environment of the business's production systems and end products.

(b) External

Here we are concerned with the following:

- (i) investors and creditors;
- (ii) customers;
- (iii) suppliers;

- (iv) government (e.g. Inland Revenue, Central Statistics Office, Department of Trade and Industry, etc.);
- (v) public interest groups;
- (vi) news media;
- (vii) Stock exchanges, in the case of public companies.

9.3 Uses of social accounting

The users listed in Section 9.2 will in various ways use information produced, as follows:

- (i) To ensure that legal requirements are met.
- (ii) To ensure that a business's stated policies are followed.
- (iii) To bring pressure on businesses to act in a socially responsible manner. This pressure may be directly on the business itself or indirectly via the Government or by other methods.

9.4 Worked examples

Example 9.1

Name four likely users of accounting statements of a Public Limited Company, stating in each case what you consider to be the most significant piece of information they would look for.

Example 9.2

Fastfreeze Ltd completed its third year in business as a manufacturer of frozen foods on 31 May 1985. Although selling a wide range of products, 'Icepeel', a frozen pudding, for young children has been particularly successful. 'Icepeel' is made from a variety of ingredients and mixed in a special machine. Two problems concerning the production of 'Icepeel' are facing the company.

- (1) The special machine used for mixing 'Icepeel' was purchased on 1 June 1982 at a cost of £16,000 and now needs replacing. Installation costs of £4,000 were incurred in June 1982 and in addition a service contract was entered into for the life of the machine at a cost of £1,000 per annum. A replacement machine will cost £30,000 plus £5,000 installation costs and will require no service agreement. The existing machine has a trade-in value of £3,000. It is company policy to use the reducing balance method of depreciation at a rate of 20 per cent per annum.
- (2) An article in a leading medical journal has claimed that one of the ingredients used in the production of 'Icepeel' causes excessive decay in children's teeth.

(c) Depreciation is defined in SSAP12 as 'a measure of wearing out, consumption or other loss of value of a fixed asset whether arising from use, effluxion of time or obsolescence through technology and market change'.

The 1985 Companies Act states: '...any fixed asset which has a limited useful economic life. . . shall be reduced by provisions for depreciation calculated to write off that amount systematically over the period of the asset's useful economic life'. The factors to be considered are therefore:

- (i) Cost, including expenses incidental to acquisition.
- (ii) Estimated useful economic life.

- (iii) Estimated residual value.
- (iv) Depreciation method e.g. straight line or reducing balance.
- (d) Refer to the text. The company has a difficulty in that there is conflict between its responsibility to shareholders to earn profit, to the labour force to provide employment and to society to act in a socially responsible way. The company has an obligation to ascertain the validity of the claim in the medical journal; this may involve conducting its own research or employing an outside agency to do it.

- (1) The accountant normally valued stock at cost but he had decided to value the closing stock on 30 June 1986 at market price, as the company was applying for a bank loan. In his view the company's financial position should be presented favourably.
 - The closing stock cost valuation was £50,000 (market price valuation, £80,000).

At 30 June 1985 the following bills had been paid and wholly charged to the 1984/85 profit and loss account:

- (ii) £1,000 for a press advertising campaign which commenced on 1 June 1985 and ended on 31 July 1985.

During June 1986, a bill of £800 was paid for miscellaneous items of stationery. On 30 June 1986, a stock of £530 of the stationery remained. The 1985/86 revenue statement had been charged with £800.

None of the remaining expense items covered any part of another accounting period.

(3) The sales figure for the year included £20,000 for goods sent to customers on a sale or return basis. Customers were debited with the cost price plus 25 per cent. None of these goods had been confirmed as sales as at 30 June 1986.

The new managing director advised the company's accountant that he was not satisfied with many aspects of the accounting policies currently pursued, and that he wanted the Revenue Statement for the year ended 30 June 1986 revised.

He also advised the accountant that in the future he intends to consider social aspects of accounting whenever it appears as a relevant factor.

10 Branch Accounts

10.1 Introduction

Many retailing and wholesaling companies operate from more than one site. These other locations are known as branches. Among many well-known examples might be mentioned such companies as Tesco, Sainsbury, and Marks and Spencer.

The system of accounting falls into two categories:

- (i) where the head office of the company keeps all the accounting records (except branch cash, branch debtors);
- (ii) where the branches operate their own full set of accounting records, as if they were a separate business entity.

We shall look at both of these systems.

10.2 Head office keeps all accounting records

Under this system there are two main accounts which must be prepared in order for the head office to determine the profit or loss made by each branch. They are:
(a) the branch stock account; (b) the branch adjustment account.

The branch stock account shows all movement of stock into and out of the branch. Quite often, after allowing for opening and closing stock, the account will not balance. This is usually because of 'missing' stock. One of the prime purposes of the account is to determine the amount of 'missing' stock. If this is abnormally high, head office can initiate an inquiry into the branch activities.

Usually the branch stock account shows all stock at the branch selling price. This makes it easier for head office, which controls prices, to monitor stock movements. The following account shows the typical debit and credit entries for a branch stock account.

Branch stock account (at branch sales prices)

Opening stock b/d : Sales

Goods from head office : Returns to head office

Returns in : Closing stock c/d

Damaged stock

'Missing' stock

Missing Sto

In most examination questions, the head office uses a mark-up when determining the prices which the branch should charge to its customers. You must be

familiar with the relationship between gross mark-ups and gross margin when dealing with branch accounts (see Chapter 12).

The main function of the *branch adjustment account* is to determine the gross profit earned by the branch. We credit the branch adjustment account with the maximum gross profit it could have made during the period, and debit the account with the reasons why it did not achieve that profit. Obviously, the balance is the gross profit/loss for the period.

10.3 Branches keep independent accounting records

Profit and loss accounts of branches and for the company's overall results are normally required where independent records are kept by branches. There are several major rules to adhere to when compiling the profit and loss accounts.

- (i) There will be a trading, profit and loss account for each branch. These are compiled from the trial balance of each branch (with the usual year-end adjustments). The trading, profit and loss account *must* be compiled as though each branch were an independent business. This is because we are trying to calculate the net profit made by the branch in its own right.
- (ii) There will be a trading, profit and loss account for the head office. Again this is compiled from the trial balance of the head office.

The sales of the head office will be made up of 'sales to branches' and 'sales' (i.e. sales to the public).

The purchases of the head office are made up of all purchases made by the head office, whether for head office use or for eventual use by the branches.

- (iii) In the profit and loss account of the head office we must make an adjustment for the 'provision for unrealised profit': see Section 10.4.
- (iv) There will be a trading, profit and loss account for the company as a whole. We must exclude any intercompany sales and intercompany purchases from the company trading account. Opening and closing stock must be valued at original cost to the company.
- (v) The opening and closing stock of the company must include any 'goods in transit' this is stock which has been sent by the head office to a branch or, vice versa, which has not arrived at its destination, and is therefore not included in the stock of the head office or the branch(es).
- (vi) Apart from the adjustment for the provision for unrealised profit in the head office profit and loss account, the items in the *company* profit and loss account are simply the aggregate of figures in the head office and branches profit and loss account.

10.4 Provision for unrealised profit

Quite often the head office buys stock and then invoices it to the branches for more than the original cost to head office. This is because the head office itself is acting as a profit centre. If some of this stock is still unsold at the branch at the end of the year, there is an unrealised profit in their stock as far as the company profit is concerned. This unrealised profit must be deducted from head office net profit in the head office profit and loss account. (Credit provision for unrealised profit; debit head office profit and loss account.)

As with other provisions, in consecutive periods it is the change in the provision which will be debited or credited to the profit and loss account; the balance of the provision for unrealised profit at the end of the year is deducted from the aggregate stock valuation in the balance sheet for the company.

Example The head office buys stock and then sells it to the branch at a 25 per cent mark-up. At the start of the year the branch had stock from head office, which had been invoiced to the branch at £6,000. At the end of the year, the stock at the branch (from head office) was £9,000.

10.5 Current accounts

To record how much money the head office has invested in a branch, the head office keeps a *branch current* account. This is debited with all monies or resources sent to the branch. It is credited with all remittances sent from the branch to the head office. This is similar to a debtors account. In head office books it would appear as follows:

Branch Current account

The branch keeps a similar record of its indebtedness to the head office - also called a current account. Apart from the problem of time lags between items

being sent and items being received, the balance of the branch current account in the head office books should agree with the head office current account in the branch books.

Current accounts are not shown in the company balance sheet.

There are two types of items in transit: (a) goods in transit; (b) cash in transit. The adjustment for these is usually made in the head office books *only*.

You must remember to include goods in transit in the company stock figure (deducting any unrealised profits). We also must include cash in transit in company current assets.

10.6 The balance sheet

Usually the only balance sheet required by examination questions is the one for the company as a whole.

The assets and liabilities are the simple aggregates of assets and liabilities of branches and head office, allowing for unrealised profit in closing stock.

The capital section of the balance sheet is made up of the capital (+ reserves) from the head office trial balance. The net profit of the branches is added to the net profit of the head office; if it is a limited company, the appropriation of profits, etc., is dealt with in the normal way, through the head office appropriation accounts.

10.7 Worked examples

Example 10.1

Cellgoods Ltd has a branch in Kidlington. All branch transactions are recorded in the head office books but the branch keeps a sales ledger and certain subsidiary books.

All purchases are made by the head office, goods being delivered direct to the branch and charged to it at selling price, which is cost plus 25 per cent.

On 1 January 1986 stock-in-trade at the branch, valued at selling price, amounted to £7,935 and the debtors to £2,061.

During the year ended 31 December 1986 the following transactions took place at the branch:

11 Incomplete Records

11.1 Introduction

Questions on the topic of incomplete records present you with real-life situations where businesses are not keeping a full set of double entry records. The subject is also a favourite with examiners, since giving you the minimum of information and asking you to complete the accounts provides an excellent test of your understanding of accounting.

It is yet another topic that was introduced to you at GCSE and is again examined frequently at A-level, but with increased complexity. You may need to refer to your GCSE studies again but a reminder of the basic principles is given by way of summary below.

11.2 Statement of affairs

The statement of affairs is equivalent to the balance sheet where double entry records are kept. It lists assets and liabilities of a business in arriving at the net worth, which is equivalent to the owner's capital.

Where no other records are maintained, we can calculate the profit by comparing the net worth of the business at the start of a period with that at the end. The profit will be the increase in net worth, plus any drawings by the owner, less any capital introduced by him.

11.3 The trading and profit and loss account

In order to prepare the trading and profit and loss account, it is necessary to work from detailed cash and bank transactions. You should be prepared to reconstruct these from information given. You may have to insert opening or closing cash and/or bank balances as balancing figures. Alternatively, you may be given opening and closing balances but required to insert owner's drawings or expenses as a balancing figure.

Even if not required by the question, you are recommended as a first step in incomplete-record questions to start a workings page with the reconstructed cash and bank transactions. Once this is done, you can then start to calculate the other items as follows.

- (i) Sales will be receipts from debtors and cash sales, plus closing debtors, less opening debtors. Also add back any discounts allowed.
- (ii) *Purchases* will be payments to creditors and cash purchases, plus closing creditors, less opening creditors. Also add back any discounts received.

You may prefer to ascertain the figure by constructing a debtors and/or creditors control account. This would be equally acceptable.

In some questions you may not be given enough information to calculate sales and purchases by the above method. Instead you may be told the margin (gross profit as percentage of sales) or mark-up on purchase price. In this case calculate the figures which you are able to and insert the missing value as a balancing figure.

Example 11.2 illustrates the above technique: in this case we can calculate sales and, hence, gross profit. From this we arrive at the cost of goods sold, and add back closing stock, which gives us a figure representing opening stock plus purchases.

Example 11.2

John Moss has been in business for several years, but has never bothered to keep a complete set of books. On 31 March 1983 he asked you to prepare a set of Final Accounts and a Balance Sheet, as he was thinking of expanding and needed to borrow some money. He thought that his chances would be easier if he could show 'something tangible'.

You find that Moss has not kept many records but was positive that his selling price was cost plus 20 per cent at all times. During the year he had paid £150,000 into the bank, most of which was his proceeds from sales. You also ascertain that at 31 March 1983, Moss has in stock goods for resale which cost him £5,000, which he says is about half what it was at the beginning of the year.

Moss owned his own premises which he valued at £100,000 and fittings which he said cost £80,000 when he bought them in April 1973, but he thought that now they were only worth £40,000. He also had an old van purchased in May 1978 for £2,500, which he was going to give away, as it was worthless.

From the counterfoils of Moss's cheque book you calculate that he has paid the following amounts during the year ending 31 March 1983:

- (i) Motor Van purchased on 30 March 1983 £7,250
- (ii) Rates for the year ending 30 June 1983 £750
- (iii) Wages up to 24 March 1983 £3,060
- (iv) Lighting and Heating for the year £1,890
- (v) Sundry expenses £320
- (vi) Insurance for 18 months to 30 June 1983 £540
- (vii) Personal cheques amounted to £10,400.

You can find no record of cheques sent to suppliers, and Moss explains that he uses a separate cheque book, which he has mislaid, but he has invoices outstanding of £2,450. By checking his Bank statements you calculate that he paid £118,810 to his creditors during the year and that he now has £9,930 in the bank.

Moss has only two credit customers and he has recorded that on 1 April they owed him £250 between them, they always paid in cash eventually, and at 31 March 1983 they owed him £155 each.

Moss won £5,000 at his bookmakers in September 1982, and as he had a few business debts outstanding he paid them from these winnings.

- (c) Wages to a lady who cleans the shop for £8 a week and to a lad who delivers for him for £5 a week.
- (d) £5 a week for his own daily and Sunday papers.

Moss apologises for the mess his records are in but promises to pay you £50 when you have completed your work, with the promise to double it if he gets the loan.

Prepare suitable final accounts for the year ending 31 March 1983 as accurately as you can and a Balance Sheet at that date. Be careful to show all your working and to explain any assumptions that you make.

12 Non-trading Organisations

12.1 Introduction

The topic of non-trading organisations is another of those introduced at GCSE but frequently examined at A-level. The principles of accounting for these organisations, as covered by the GCSE, do not change; however, the worked examples and further exercises will show you the type of question that you should be prepared to tackle.

By their very nature, such organisations will seldom keep full double entry records. For this reason you will bring into use many of the techniques demonstrated in Chapter 11.

12.2 Receipts and payments account

As the name suggests, the receipts and payments account is a record of cash and bank receipts and payments which have actually occurred. It commences with the cash and bank balances at the beginning of the period, adds receipts, deducts payments, and ends with the cash and bank balances at the period end.

12.3 Income and expenditure account

A receipts and payments account only provides us with information on the increase or decrease in bank balances. It does not show us a true surplus or deficit for the year: in order to do this, we must follow the accruals or matching concept described in Chapter 1. That is to say, we should look at the actual income and expenditures relevant to the accounting period. For example, we want to include subscriptions due but not received, and expenses incurred but not paid for. Conversely, we need to exclude subscriptions prepaid in respect of next year and prepayments made in respect of expenses.

The income and expenditure account takes the amounts from the receipts and payment account and adjusts them for accruals and prepayments as given above. It thus gives us a fair picture of the surplus or deficit for the year.

12.4 Accumulated fund

The accumulated fund can be looked upon as equivalent to the capital account in respect of trading organisations. The balance on the income and expenditure account is transferred to this accumulated fund

12.5 Other funds

Apart from the general or accumulated fund, many organisations have other funds for specific purposes. Often these will be represented by specific investments or held in separate accounts. As far as the balance sheet is concerned, these will appear as an asset, while the fund will appear as a liability. Where the fund has income during the year, this will not appear in the income and expenditure account; however, the fund in the balance sheet will increase, as will the investments or bank account representing that fund.

12.6 Worked examples

Example 12.1

The Av One wine society exists for two reasons, to promote the drinking of good wines and to enable members to obtain wines at a reasonable price.

A monthly magazine is issued and sold to the public; members of the society are able to obtain a copy at half price. During the year ending 31 May 1984 the following transactions were recorded by the society treasurer:

- The society has 325 registered members and the annual subscription of £25 per member was received from 304 of them; of these, ten members also paid their subscription to 31 May 1985. Four members (not included above) owed subscriptions for the year to 31 May 1983 and they paid £200 during the year. Of the remaining membership, three had paid two years' subscription during the year ending 31 May 1983.
- 2. 5,000 copies of the magazine had been sold at 75p per copy. None of the members had taken advantage of the half price offer.
- 3. The cost of printing the magazine was £5,240, but advertising revenue from local wine retailers was £1,480. At the end of the year 100 copies of the magazine had not been sold; it was the usual practice to offer these at wine tastings during the following year at 40p per copy. It is anticipated that they will all be sold. Copies of the magazine in stock at 31 May 1983 were valued at £30. These had all been sold at the first wine tasting in September 1983.
- 4. A fund had been set up from donations received to enable a connoisseurs' wine tasting session to be held each year. At 31 May 1983 the fund stood at £525 and during the year further donations to this fund had been received and banked totalling £150, and £15 interest on the special account at the bank had been credited. The expenses of the wine tasting session held during the year, excluding the cost of the wine, were £300. The cost of the wine was covered entirely by the members who had attended the function.
- 5. The society had no premises of their own but were able to hold meetings and functions at the local golf club. The rent for the year was £2,500. The society held stocks of wine for resale on the premises and at 31 May 1983 these were valued at £3,220.
- 6. Payments for wine during the year, purchased for resale, were £182,000 and at 31 May 1984 £2,400 remained unsold. Receipts from sales of wine were £186,000. Payments for wine for ordinary wine tasting sessions held during the year were £8,215; there was none in stock at 31 May 1984.
- 7. Apart from the information that can be obtained from above, the treasurer has kept the following records:
 - (i) At 31 May 1983, cash in hand was £42 and the ordinary current account at the bank had a balance of £3,460. The cash in hand at 31 May 1984 was £42.
 - (ii) Ordinary expenses of running the society paid out of bank were: postage etc. £400, insurance £550, gratuities to golf club staff £150, hire of glasses etc. £1,250, advertising £260.
 - (iii) Sundry expenses had been paid out of cash and during the year £140 had been withdrawn from the bank and held by the treasurer to pay them.

- (iv) Creditors for wine purchased for resale were £1,200 at 31 May 1983 and £1,350 at 31 May 1984.
- (v) At 31 May 1983 members of the society owed £420 for wines purchased and £530 was owing by members at 31 May 1984.

The club has received planning permission to build four squash courts at a total cost of £120,000, and is considering two offers to finance the development.

Swiftshoe Ltd, a sports shoe manufacturer with a large local factory, has offered an interest free loan of £120,000 over five years in return for free membership for fifty of its employees and the exclusive use of the facilities for two weeks per annum without charge to host the Swiftshoe National Squash Championships, an event that regularly attracts 500 spectators per day from throughout the United Kingdom. In addition the firm requires the club to change its name to The Swiftshoe Squash and Tennis Club.

It is expected that £300 per week would be received in court fees and that the annual running costs of the courts would be £5,000.

13 Valuation of Stock

13.1 Introduction

Valuation of stock is subjective. However, there are some established 'methods' and principles which are commonly applied. The physical units or quantities of stock may be valued in several alternative ways, depending on the method applied. This will obviously affect trading profits, in as much as various possible values of opening and closing stock will affect the trading and net profits for each period under review.

13.1 FIFO, LIFO, AVCO

The FIFO (First In First Out) method assumes that stock is issued or sold in the order in which it was purchased or made - i.e. the oldest stock is issued or sold first.

The LIFO (Last In First Out) method assumes that stock is issued or sold in the order of the most recent purchase or units produced -i.e. the newest stock is issued or sold first.

The AVCO (Average Cost) method places an average value on each unit of stock (a weighted average) and simply multiplies this average by the number of units remaining in stock, to arrive at a total stock value.

13.3 Perpetual vs. periodic

Depending on the sophistication of the firm's information and stock control system, a valuation of stocks can be revised after every transaction which involves the movement of stock (perpetual valuation), or a valuation of stock can be made just at the end of each trading period (periodic valuation).

A firm may value its stock by the FIFO, LIFO or AVCO method; it may conduct this valuation either 'perpetually' or 'periodically'.

We can illustrate by applying each of these alternatives to the same data.

	Purchases	Sales
Month 1	400 units at £20 each	300 units at £35 each
Month 2	600 units at £22 each	550 units at £35 each
Month 3	500 units at £23 each	450 units at £35 each

Let us assume that the firm values stock using FIFO, on a perpetual basis. At the end of each month its stock values will be as follows:

```
end of month 1 - (400 - 300) \times £20 = £2,000
end of month 2 - (100 + 600 - 550) \times £22 = £3,300
[The firm assumes that the stock remaining is the newest stock.]
end of month 3 - (150 + 500 - 450) \times £23 = £4,600
```

On a perpetual LIFO basis, the firm would arrive at the following valuations:

```
end of month 1 - (400 - 300) \times £20 = £2,000

end of month 2 - (100 + 600 - 550) \times £20 = £3,000

end of month 3 - (150 + 500 - 450) = 200 units, split as follows:

150 at £20 = £3,000

50 at £22 = £1,100

= £4,100
```

All of the stock purchases in month 3 are assumed to have been sold in month 3 (Last In First Out).

On a perpetual AVCO basis, the firm would arrive at the following valuation:

end of month 1 - (400 - 300) units at an average cost of £20 = £2,000.

During month 2 the firm had

$$100 \text{ at } £20 = £2,000$$

and

$$\frac{600}{700} \text{ at } £22 = £13,200$$

$$£15,200$$

The average cost of these units was £15,200/700 = £21.71. It has 150 units in stock at the end of month 2. Therefore, the value of closing stock at the end of month 2 is $150 \times £21.71 = £3,256.50$.

During month 3, the firm had

$$150 \text{ at } £21.71 = £ 3,256.50$$

and

$$\frac{500}{650}$$
 at £23 = £11,500.00
£14,756.50

The average cost of these units was £14,756.50/650 = £22.70. It has 200 units in stock at the end of month 3. Its value will be $200 \times £22.70 = £4,540$.

We can now examine the periodic valuations.

Periodic FIFO During three months the firm purchased 1,500 units and sold 1,300 units, leaving a closing stock of 200 units; these are assumed to be the newest units - i.e. 200 at £23 = £4,600.

Periodic LIFO Assume a closing stock of 200 of the oldest stock - i.e. 200 at £20 = £4,000.

Periodic AVCO needs a little more calculation. We must calculate the weighted average cost of the stock we had available for sale over the whole period. The firm purchased 1,500 units for a total cost of £32,810. The average cost of these was £32,810/1,500 = £21.87. At the end of month 3, there are 200 units in stock. Their value is $200 \times £21.87 = £4,374$.

Note that in both periodic and perpetual stock valuation the AVCO valuation falls between (but not necessarily exactly in the middle of) the FIFO and LIFO valuations.

13.4 Inflation

If production costs and/or unit purchasing costs are constant, our valuation of stock would be the same under any of the three methods described above. It is only because costs are changing that our valuation of closing stock can vary, depending on the system of valuation used.

It is important to remember a simple rule about changing costs and stock valuation. It is: In periods of rising costs (inflation), the FIFO system will result in a higher value of closing stock than LIFO. This is because the firm is left with the more expensive units of stock, having sold the oldest (and therefore the cheaper) units first.

13.5 Effects on trading profits

There is no hard and fast rule to apply here, apart from remembering the connection between opening and closing stock, costs of goods sold and gross profit — i.e. a simple trading account:

We can see that the higher the value of opening stock the higher will be the cost of goods sold, and thus the lower will be gross profit. The higher the value of closing stock, the higher the value of gross profit.

In a firm's first year of trade, under conditions of rising costs, FIFO will yield higher closing stock values and therefore larger gross profit.

But, remember that the closing stock of one period becomes the opening stock of the next, thus pushing down the gross profit of the second period.

13.6 Cost and net realisable value

An important accounting principle is that of 'conservatism', as regards the valuation of assets or measurement of profit.

Having valued stocks by any one of the methods described above (FIFO, LIFO, AVCO), the firm should compare the result with the net realisable value of the stock - i.e. how much the stock could be sold for, after taking into account any additional costs it would incur to put the stock into a marketable condition. The stock should then be valued at the lower of cost or net realisable value.

Example Using traditional FIFO methods of stock valuation, the closing stock is valued at £5,000, but the maximum price the stock could be sold for is £2,000, and this could only be realised if £200 was spent modifying the stock. The net realisable value is therefore £1,800. The stock should be valued now at the lower of cost (£5,000) and net realisable value (£1,800) — i.e. £1,800.

(b) Applying AVCO to raw materials, particularly on a perpetual basis, produces a constantly changing cost per unit of raw material used. If the firm is not using a standard costing system, its cost of production will also be changing every time new raw materials are received. This yields an uncertainty for the firm in terms of finished goods costs and selling prices, etc.

The system used required several instances of figures being rounded off, where perhaps this degree of accuracy is unnecessary in a raw material turn-over of such small quantities.

Example 13.2

The Reliable Cash and Carry Wholesalers Limited sell a range of household durable goods at a uniform gross profit of 25 per cent above cost. Occasionally goods are damaged in the storerooms or soiled after display use and have to be offered at a lower than normal selling price. The following figures in the company's books refer to the year ended 31 March 1983:

The stock at 1 April 1982 was subsequently sold for £12,306 and is included in the sales figure of £209,853.

14 Marginal Costing

14.1 Introduction

Marginal costing begins to look at costs in a way unfamiliar to many students. When applying marginal costing principles, the overriding objective is to exclude from costing any fixed or unavoidable costs. We must only consider the short-term changes in total costs which will occur when the level of business activity changes - i.e. the marginal costs.

14.2 Marginal and absorption costing

In financial accounting, stock is valued as a sum of the direct costs of making the product (wages + materials), as well as some proportion of the indirect costs (factory overheads) of making that product. Indeed, SSAP9 ('valuation of stock and work in progress') tells us to include in our valuation of stock some proportion of factory overheads. This is known as absorption costing. However, for management accounting purposes, where decisions are being made about future action, the marginal costing approach to valuation of stock should be used - i.e. only the direct or variable production costs are used in the valuation of stock. This method will lead to profit-maximising decisions being made.

14.3 Break-even analysis

The break-even analysis technique takes the concept of marginal costing one stage further. It is a technique used to determine the minimum volume of sales needed before a firm can begin to make a profit. This minimum volume (where the firm is making neither a profit nor a loss) is the *break-even point*. It can be calculated by the formula:

break-even Volume =
$$\frac{\text{total fixed costs p.a.}}{\text{selling price per unit } - \text{variable cost per unit}}$$

The denominator of the fraction is also known as the 'contribution' per unit — i.e. when each unit is sold, it earns a contribution towards the firm's fixed costs. The formula calculates how many of these contributions per unit are needed in order to cover fixed costs.


The break-even point can also be expressed in terms of £s turnover. The formula for this is given by:

break-even turnover = price per unit
$$\times \frac{\text{total fixed costs p.a.}}{\text{contribution per unit}}$$

In the examination, if the question is unclear as to whether it volume or turnover break-even point, give both.

14.4 The break-even chart

The break-even chart is a diagrammatic representation (and method of estimating) the break-even point.



Break-even chart

The total cost line starts at zero volume of production and sales on the horizontal axis, but a certain distance up the vertical axis. This is because, even at zero level of production, a firm (in the short run) still has some *inescapable fixed costs* to meet, such as rent, rates, management costs, etc. The total cost line's slope is determined by the variable cost per unit. If you are asked to sketch a break-even chart, you only need two coordinates for the total cost line.

The first is obviously the one at zero volume with the vertical axis coordinate at the fixed cost level. The second coordinate should be the total cost for a given volume of production. For greater drawing accuracy, choose a volume at the higher end of your scale - e.g. maximum production capacity.

The total revenue line is also constructed using two pairs of coordinates. One pair of coordinates is always at (0, 0) – i.e. for zero production or sales there is zero turnover. The second pair of coordinates must be calculated by assuming a certain volume and then calculating its associated turnover by multiplying the volume by the price per unit. Again, for drawing accuracy, choose a volume close to or at full capacity.

The 'margin of safety' on the above diagram shows, for a given volume of production and sales (V_1) , how much room there is for sales to fall before the firm starts to make a loss. The margin of safety can be expressed in units or £s. Notice that any volume greater than break-even volume results in a profit (since total revenue will be greater than total cost), and vice versa.

The marginal costing approach will mean that fixed costs are treated as a 'period cost' and therefore deducted in total from revenue for the period. Absorption costing treats fixed costs as product costs (the traditional financial accounting approach).

A company is considering its sales budget for the year ending 31 March 1986. The relevant details for the year ended 31 March 1985 are:

(i) The directors' method is based on absorption costing. This follows guidelines in SSAP9 – 'valuation of stocks and work in progress'. This is fine for financial accounting but not suitable for management accounting.

(ii) From: Accountant To: Directors

Subject: Stock Valuation

The present policy of valuing stocks using absorption costing principles is fine for historic financial reporting, but is not suitable as a basis for short-term decisions on pricing and volume, etc. Such decisions should be based on marginal costing principles, which concentrate only on those costs which change in the short run.

Absorption costing carries forward a proportion of fixed factory overheads in our closing stock valuations; this has an effect of inflating reported profits whenever the volume of closing stock increases.

Marginal costing treats factory fixed costs as period costs, rather than product costs, and focuses attention on contribution earned towards these fixed costs from a given sales volume and revenue. Stocks are valued at their direct cost of production - i.e. including those costs which can be directly traced to the product cost. These are the only costs which will change as a result of decisions in the short run.

(d) The closing stock figure of 70,000 units is over 50 per cent of our volume sales of 130,000 units. I advise against producing at full capacity of 200,000 units, if our sales volume is expected to remain at the same level next year.



(a) The profit for the department as a whole is found by simply reading from the profit/volume chart. We can see the profit earned by each of the three product categories, and just aggregate them.



(c) To construct the break-even chart for the department as a whole, we need to determine two coordinates for total revenue and two for total cost so that we can draw the two functions.

When output is zero, turnover is zero; we also know that total turnover reaches £26,000 (adding together A, B and C).

When output is zero, total cost is just the fixed cost of £6,000.

When turnover reaches £26,000, total cost is £20,200. (Total cost = Total revenue – Profit; i.e. £26,000 – £5,800). See graph opposite.



(d) Here we can use the equation for break-even turnover: fixed costs/contribution ratio.

The Contribution ratio is given by Total contribution/Total turnover. We know that when Turnover is £26,000, Fixed costs are £6,000 and Profit is £5,800. Contribution = Turnover — Fixed costs — Profit. Contribution = £26,000 — £6,000 — £5,800. Contribution = £11,800.

Thus the Contribution ratio = 11,800/26,000.

Thus Break-even income = £6,000/(11,800/26,000) = £13, 220.

15 Costing For Decisionmaking

15.1 Relevant costs

The subject matter of this chapter is closely allied to that of Chapter 14, marginal costing. It is costing for decision-making using the concept of marginality - i.e. 'What costs and/or revenues will change as a result of the decision made?'

We must concentrate only on changes. We must ignore those costs that will not change in the short run. These non-changing costs may have a variety of accounting labels.

- (i) Fixed costs Costs which do not change with a change in the level of output or turnover.
- (ii) Sunk costs Expenditure on items already incurred. For example, the firm may have surplus stocks of a raw material, bought and paid for a while ago. If it has only one use for this material, its use will now have a zero cost.
- (iii) Inescapable costs Costs which the firm will incur regardless of its decision. For example, it is committed to a basic wage of £80 per week for 10 men. If for some reason it cannot decrease the number of men, or basic wage, it has inescapable cost of £800 per week.

15.2 'Make or buy' decisions

This is a popular question topic. It uses the concept of marginality. It should, however, be treated with caution. We have the pure quantitative calculations and recommendations, but there is a need to be aware of the non-financial consequences of decisions.

For example, suppose that a firm has the following costs of production for a component it needs in a finished product:

materials – £2 per unit

labour – £5 per unit

departmental overheads - £3 per unit (allocated on the basis of man-hours worked as a proportion of total man-hours)

The firm has established that a subcontractor could supply the component at £9 per unit. Should the firm make or buy?

Well, we must look at the costs which will change as a result of buying-in the component. How much will the firm save?

- (i) It will save materials of £2 per unit.
- (ii) It will probably save labour of £5 per unit.
- (iii) It will not save the departmental overheads.

These are fixed costs, which have been allocated to the product, but they are *not* direct costs. Therefore, by discontinuing production it will save £2 + £5 = £7 per unit for every unit it buys in, but it will have to pay £9 per unit to the subcontractor. Therefore, it will cost £2 more to buy-in than to make itself. Therefore, the firm should reject the offer on numerical/financial grounds. However, it should consider such areas as (a) the quality of its own production compared with that of the subcontractor; (b) any alternative uses to which the raw materials and/or labour could be put.

15.3 **Pricing**

Questions in the area of pricing concentrate on minimum pricing or break-even pricing -i.e. for a given volume of sales, what price should the firm set in order to break-even? Here we need to remember the basic equation or definition of break-even: total costs = total revenue, where total costs = fixed costs + variable costs, and total revenue = volume \times sales price per unit.

Therefore, if we are given all of these except the price, then break-even price is simply

fixed costs + variable costs volume

Another examination topic is that of acceptance or rejection of additional sales orders — i.e. a firm receives a special order, but at a price which is considerably below its 'normal' selling price. Should the firm accept the order? Well, on purely financial grounds the firm should accept the order as long as it yields an additional *contribution* towards its fixed costs, even if that contribution is only small. We must ignore any fixed or inescapable costs, and concentrate on the *relevant* costs of satisfying that additional order.

However, there are non-financial considerations to 'marginal-cost pricing'. By selling an additional order at a price just above its marginal cost, the firm may well be running the risk of alienating its existing customers, to whom it has supplied a product priced on a full-cost (including overheads) basis. The firm must make sure (from a marketing strategy/trade relations aspect) that if it supplies at a price well below the 'normal price', the product is not distributed in the same geographic market as that of its current customers, or, if it is, that it is sold under a different brand name, with its own distinctive labelling/packaging. This is how many large supermarkets are able to sell 'own-label' products along-side 'proprietary brand' products, even though both products are made by the same manufacturer.

15.4 Contraction

The firm may be operating several branches or perhaps several product lines. The reported accounting statements show that some of them appear to be running at a loss. Should they close down all or some of the loss-making areas, and how will this decision affect the firm's profit? Once again, we must concentrate only on those costs which change as a result of our decision/recommendation. The first

thing to do is to rearrange or re-format the accounting statements into 'operating' statements, which will show the contribution earned by each area of operations. Any area yielding a positive contribution should be kept going, unless there is an alternative use of those resources (opportunity cost) which would yield a greater contribution than that at present.

An operating statement for a branch-closure decision would be as follows:

Here each branch is earning a contribution. If, say, C were to be closed down, the firm would lose C's £1,000 contribution, which would result in the firm's net profit reducing to £6,000. Notice that when head office costs are 'allocated' to the branches, the effect is to reduce the reported 'profits' of each branch.

If £3,000 of the head office costs had been allocated to C, it would appear that C was operating at a loss. This might lead to a decision to close C down. This would lead to the firm's profit falling to £6,000, since the allocated £3,000 of head office costs are 'inescapable' – i.e. they will still be incurred, regardless of whether C is open or closed.

15.5 Worked examples

Example 15.1

A company currently makes and sells 1,000 units per month of its product. The selling price is £55 per unit, and unit costs are: direct labour £3; direct materials £7; variable overheads £4. Fixed costs per month are £16,200.

The firm receives two special export orders for completion in the same month. Order A requests 500 units at a special price of £6,500; order B requires 600 units at £12,000. Order A will require no special treatment, but order B will demand extra processing at a cost of £5 per unit. The firm has sufficient productive capacity to undertake either A or B in addition to its current production.

- (a) Show the firm's profits for the month if
 - (i) normal production only takes place
 - (ii) order A is accepted
 - (iii) order B is accepted

- (b) Explain why a company will generally accept an order which makes a positive contribution towards overheads. [8 marks]
- (c) Before accepting an order based upon marginal cost prices, what safeguards must a firm adopt? [5 marks]

Where the company has a choice between alternative orders, it should obviously choose the order which makes the greatest contribution, since this will lead to profit maximisation.
- (c) Before accepting an order based on marginal cost prices, the firm should ensure that the distribution of that order does not take place in its home market, since this will lead to antagonism and loss of goodwill from its home market distributors.

The above figures follow similar results over recent years and Mr Jones, the manager of Retailers, is considering the future of the Fairvale branch. The following additional information is available.

- (1) The Riverdale shop is responsible for the administration of the business and for ordering and handling all of the goods sold by the Fairvale shop. A handling charge of 10 per cent on cost has been added to the Fairvale cost of sales figure and the same amount deducted from the Riverdale cost of sales.
- (2) During the past three years the Fairvale premises have been rented on an annual basis only. The landlord of the premises now insists on a 10-year lease being introduced from 1 June 1984 at an annual rent of £2,500 per annum.
- (3) The fixtures at the Fairvale shop, purchased for £10,000, have been depreciated by £4,000 at 31 May 1984, using the straight line method of depreciation.
- (4) Although the motor van is used for delivery to the Fairvale shop, the van will continue to be required by the Riverdale branch. However, the closure of the Fairvale shop will result in an expected saving of £400 on vehicle running costs.
- (5) Apart from Mr Jones who manages both branches, the Fairvale shop is staffed by parttime assistants. A closure of the Fairvale shop would enable Mr Jones to work fully at Riverdale and reduce other staff salaries at Riverdale by £1,500 per year.
- (6) General expenses are allocated between Riverdale and Fairvale on the basis of turnover. It is estimated that a total saving of £500 on general expenses would result from the closure of the Fairvale shop.
- (7) Just over twelve months ago Mr Smith, a redundant sales executive, offered to purchase the Fairvale shop from Retailers Ltd, the consideration being £1,000 for the fixtures and to purchase the stock at cost. Mr Smith has recently approached Mr Jones again but on learning of the rent increase is prepared to purchase only the stock at cost. Apart from Mr Smith, an active member of the Fairvale Village Association who is determined that the village's only remaining shop will not close, it is unlikely that the shop will be taken over by anyone else.

They have also indicated that they would give serious consideration to co-operation in other cost-saving investigations.

From the above, I would advise the firm to adopt the first suggestion of selling the excess production abroad. This will increase profits by £83,600 -

£77,000 = £6,600 next year. The proposal to reduce the price by 10 per cent and increase advertising does in fact lead to even lower profits than the original budget, cutting them by £13,400 (£77,000 - £63,600).

The new owner, formerly a building contractor operating from one 'yard' only, is perturbed by the reported loss from the depot in the outer region and has formulated the following proposals and forecasts, all of which relate to this depot.

Question 15.3

British International Airlines plc (BIA plc) has combined with a smaller airline company. As a direct result of this BIA plc will lose a route which both companies served. BIA plc use two aircraft on this route and both are used for passenger transportation. Ten cabin staff and four groundstaff are employed by BIA plc on this route.

Management of BIA plc are now considering three options for the use of the aircraft and the staff. In considering these options, the net present value concept is to be ignored.

Option 1

Both aircraft would be converted into commercial cargo carrying planes. A contract has been negotiated with Worldwide Nuclear Fuels (WNF) for the transportation of nuclear waste from a plant in Lipland to Durlan.

The cost of converting the aircraft will be £450,000 each and the conversion will take six months to complete. WNF will supply the finance during the conversion at 5% interest per annum. WNF will require repayment when conversions are complete.

The contract would initially be for four years with anticipated net income of:

Four cabin staff would be made redundant at a cost of £7,000 each and insurance costs of £200,000 per year would be incurred. These costs are not included in the net income figures above.

Option 2

Conversion costs would amount to £170,000 per aircraft.

Report on the 3 proposals

Option 1 would generate significant income, yielding an average rate of return of 41%, and would pay back in 1 yr 8 months. It would also allow BIA to operate independently although heavily dependent on one contract which may not be renewed at the end of the four years.

Option 2 has a longer life of 5 years but pays back after 8.5 months, with a very high average rate of return of 153%.

Option 3 appears to be rather desperate, although it will generate £1,596,000 in the year, but will not generate any income beyond year 1.

Our advice would be adopt proposal 2, since it pays back in the shortest period, involves no redundancies and has the longest life.

16 Budgeting

16.1 **Introduction**

Questions on budgeting usually require an application of common-sense and a clear interpretation of the question. The biggest problem with these questions is that they tend to be rather time-consuming. It is essential that a clear layout be produced, so that it is easy to read, and avoidable errors are not made.

All budgeting questions concern time (usually in months), and timing delays between sales and receipts and between purchases and payments. Look carefully for information concerning periods of credit. If a firm allows two months credit, sales made in January will not become receipts until March.

16.2 Subsidiary budgets

There are many types of subsidiary budgets, such as raw materials stock, production, debtors, creditors and cash.

The raw materials stock and production budgets can be expressed in terms of physical units, or in money measurement. A physical unit budget will allow the firm to forecast how many units it will have in stock at the end of each month and whether this will be sufficient to support the budgeted level of production or sales. If stock falls to zero, we have an 'out-of-stock' position, which will have to be corrected by the firm. When preparing a stock budget, you must determine whether the budget required is for units or monetary value.

A physical stock budget for finished goods will have the following format:

Jan.	Feb.		Dec.

Remember that the closing stock for January will become the opening stock for February, etc.

A debtors budget will have the following format

Again the balance at the end of January becomes the balance at the beginning of February.

16.3 The master budget

'Master budget' is simply another name for a forecast trading profit and loss account for the whole period, and uses aggregate figures for sales, purchases and expenses, as detailed in the subsidiary budgets. The opening and closing stock figures are taken from the stock budget -i.e. stock at the beginning of the budgeted period and stock at the end of the budgeted period.

16.4 The forecast balance sheet

Most of the figures for assets and liabilities are taken from the closing balance figures of the subsidiary budgets — e.g. debtors, creditors, cash, stock. The capital will be the capital from the last balance sheet, plus forecast net profit, less any forecast drawings (for a sole trader) or less any forecast dividends (for a limited company). Fixed assets must, of course, be updated to take account of acquisitions/disposals and depreciation for the budgeted period.

Solution 16.1

(i) The raw material stock budget is a straightforward procedure. Note (g) in the question tells us that, for every unit of production, £8 worth of raw materials will be used up. Note also that we have an opening stock of £12,000 of raw materials, as shown in the 31 December 1982 balance sheet. We must remember that the closing stock of one month is the opening stock of the next month.

(ii) The cash budget will take considerably longer to draft. We must concentrate on timing of receipts and payments, rather than sales purchases, expenses, etc. We can first draft a receipts schedule, then a payments schedule and finally a summarised cash budget.

The receipts of J. Walker consist of cash sales, receipts from debtors, and dividends from investments (note that the investments are shown as an asset in the balance sheet).

The selling price of each unit is £20 (note c); thus the value of sales in January is £20 \times 7,000 units = £140,000. 50 per cent are for cash. The balance is paid in two halves — one in February one in March (note f).

^{*}Note (m) tells us that, of the December debtors, £20,000 is from November sales. These will be two months old by the end of January, and will therefore pay in January. This leaves £80,000-£20,000 = £60,000 of debtors, which must be due to December sales. 50 per cent of these will pay in January (£30,000) and the other 50 per cent in February. This pattern is repeated throughout the budget.

The payments schedule will have a larger variety of items than the receipts. This is only to be expected. Again we must concentrate on timing delays. We must remember that depreciation (note k) is *not* a cash flow.

Payments to trade creditors are straightforward — e.g. January purchases are £57,000 (note e). One-third is paid in January (£19,000) and £19,000 in February and £19,000 in March. On this basis, trade creditors at the end of June should be $\frac{1}{3}$ of May purchases ($\frac{1}{3}$ of £63,000 = £21,000), plus $\frac{2}{3}$ of June ($\frac{2}{3}$ of £75,000 = £50,000), total £71,000. However, note (a) tells us that total creditors at the end of June are £73,000, which is a further £2,000! This can only be the amount owing for fixed expenses (note i). Therefore, fixed expenses will be £2,000 per month, paid one month late.

Production costs per unit are £12 (note d). Of this, £8 is for raw materials (note g). Therefore, the remaining £4 is for labour and other variable overheads.

Notice the diagonal pattern of payments to creditors. This is an easy way to build up the schedule, rather than trying to complete all of the payments for one month before moving on to the next month.

In addition to his payment to the shareholders of Carr Ltd, Norman paid £10,000 into the business bank account on 1 November 1985. The debtors and creditors figures relate to sales and purchases for the month of October 1985.

Forecasts and plans for the four months to 28 February 1986 were as follows.

- (1) Gross profit will be at a constant rate of $33\frac{1}{3}\%$ of sales.
- (2) Sales will be £6,000 per month in November and December, £13,500 in January and £12,000 in February. Although in the past sales have been on one month's credit, Norman will extend the credit period to two months on all sales from 1 November 1985.
- (3) Norman proposes to exercise a strict control over stock levels and to organise his purchases so that his rate of stock turnover for each month is 2. All purchases will be made on terms of one month's credit.
- (4) Wages will be £500 per month payable on the last day of the month.
- (5) General expenses will be £400 per month: one-eighth of the general expenses are outstanding at the end of each month.
- (6) Rent for the year ending 31 October 1986 will be £1,500 and will be payable on 1 June 1986.
- (7) Norman, having opened asset and depreciation accounts with the balances taken over, decided to continue depreciation at the rate of 10 per cent per annum on cost on all assets in use at the end of the financial year.
- (8) During December new fixed assets will be purchased for £3,000 cash and an asset which had been purchased on 1 November 1983 at a cost of £800 will be sold for £200 cash.

Solution 16.2

This question is only slightly different from the previous one. It requires an understanding of gross margin (gross profit as a percentage of sales), and its link with the cost of goods sold. (Sales = gross profit + cost of goods sold.) It also requires an understanding of stock turnover, since note (3) states that the rate of stock turnover for each month will be 2 - i.e.

$$\frac{\text{cost of goods sold}}{\text{average monthly stock}} = 2$$

(a) Before we can draft the stock budget, we need to calculate opening and closing stock, using the information about gross margin and stock turnover. If the gross margin is $33\frac{1}{3}\%$ of sales, it follows that the cost of goods sold is $66\frac{2}{3}\%$ of sales. Thus, we have the following schedule:

For November we have cost of goods sold = £4,000. Therefore, the average stock must be £4,000 \div 2 = £2,000. If the opening stock is £2,000, it follows that the closing stock must be £2,000. Thus, we can establish, on this basis, the following opening and closing stock figures:

The company had developed very rapidly and the directors decided to approach a bank for an overdraft in order to finance the sales of a new generation of micro-computers. The following forecast information was available for the first four months of the next financial year:

In December 1984, 30 old micro-computers had been sold.

The old micro-computers were sold at £300 a unit, but from 1 March 1985 the old units were to be sold at £150 per unit in order to reduce stocks quickly. Cash arising from the sales was always received one month after the sale.

The new generation micro-computers were to be sold at £400 a unit and, in order to encourage sales, the period of credit to be allowed was extended to two months. No sales of new units had been made before 1 January 1985.

(2) Other Projected Sales Revenue

Currently, there were 150 maintenance contracts on units bought by customers at £300 a unit. Customers pay 10 per cent of the unit price annually, half on 1 February and half on 1 August.

No maintenance contracts would be available for the new generation of micro-computers.

Software sales generated £6,000 in the month of December 1984 and would be at the same level in January and February 1985. Thereafter software sales would earn £9,000 a month. All software sales receipts were received one month after sale.

- (3) The gross profit-mark-up on all unit sales (old micros and new generation micros) is 25 per cent on cost.
- (4) The old units were bought at the rate of 30 per month, but no purchases would be made after 31 January since existing stocks were to be cleared.

The new units had been bought at the rate of 100 per month since 1 October 1984 in order to build up stocks, and would continue at the rate of 100 a month in 1985.

Suppliers were always paid in the month following the purchase.

- (5) Staff salaries were paid each month at £3,000 per month.
- (6) Royalty payments were £500 a month payable quarterly in arrears commencing on 1 January each year.
- (7) Other variable overhead was calculated at 5 per cent of each month's computer unit sales revenue only, and was always paid in the month following the sales.

17 Variance Analysis

17.1 Introduction

Variance analysis is a means of comparing the firm's performance over a period against the budget for that period. Its purpose is to highlight areas of poor performance, known as adverse variances, as well as highlighting areas of 'good' performance, known as favourable variances.

Variance reports are usually produced on a monthly basis, so that attempts can be made by those responsible for the areas in which the variances occur to take corrective action. This is known as management by exception.

There are various methods of calculating variances. However, we suggest one particular style or format here, since we believe that it is the easiest one to remember.

Variance analysis compares the actual cost of, say, producing a unit, against how much it *should have* cost to produce a unit. How much it should have cost is known as the *standard cost*.

The cost of production consists of labour, materials, variable overheads and fixed overheads. Each of these items is analysed in detail. Any 'variation' from standard affects the actual profit for the period.

However, profit can also be affected by (a) the price the firm charges for the units sold, and (b) the actual quantity of units sold. Therefore, not only are cost variances important, but so also are sales variances.

17.2 Material variances

Material variances analyse (a) the actual costs of material used against standard cost of material used, and (b) the actual quantity of material used against the standard quantity of material used (for the output actually achieved). Let us look at a simple example.

Firm X	Budget	Actual
Production	1000 units	800 units
kg of raw material	200	175
Price per kg	£10	£10.20
Raw material cost	£2,000	£1,785

At first glance it appears that the firm has actually saved money against budget for raw materials, of £2,000 - £1,785 = £215. However, the firm had budgeted to produce 1,000 units, but it only produced 800. Therefore, it should have calculated how much it should have spent on raw materials for the 800 units actually produced. This is known as a flexed budget.

Flexed budget

kg Raw materials = $(800/1,000) \times 200 = 160 \text{ kg}$ Budgeted price per kg $\frac{£10}{}$ Budgeted raw material cost £1,600

We should now compare the flexed budget with the actual results. This is done using the following format. In the examination you should set it out leaving at first an empty row between lines, as follows:

Actual quantity × actual price = £x
[empty row]
Actual quantity × standard price = £y
[empty row]
Standard quantity × standard price (for output achieved) = £z

The empty rows are then filled with the variances. The first empty row is the raw material price variance = $\pounds(y - x)$. The second empty row is the raw material usage variance = $\pounds(z - y)$.

Thus, for our example, we have:

Actual quantity × Actual price = £1,785 Raw material price variance £35 (A)dverse Actual quantity × standard price = £1,750 Raw material usage variance £150 (A)dverse Standard quantity × standard price = £1,600

Both of the above variances are adverse, since the actual costs were greater than the standard costs.

17.3 Labour variances

Labour variances analyse (a) the wage-rate variance (i.e. how much the firm paid per hour of labour against the standard hourly rate, known as the 'labour rate' variance) and (b) how long it took labour to produce the output against how long it should have taken (i.e. the standard hours for the output achieved, known as the 'labour efficiency' variance).

Example

Budget Actual
Output 4,000 units 3,500 units

Labour 2,000 hours @ £5 = £10,000 1,900 hours at £4.75 = £9,025

We must first 'flex' the budget to 3,500 units:

Output 3,500 units

Labour $(3,500/4,000) \times 2,000 \text{ hours } @ £5 = £8,750$

The labour for labour variances is very similar to that of the raw material variances

Actual hours at actual rate £9,025 Labour rate variance 475 (F) avourable Actual hours at standard rate $[1,900 \times £5]$ = £9,500 Labour efficiency variance 750 (A) Standard hours × standard rate = £8,750

17.4 Variable overhead variances

Variable overheads are incurred usually in relation to the hours worked. Therefore, their variance analysis is very similar to that of the labour variances. The analysis format is as follows:

Actual hours worked x actual variable overhead hourly rate	£x
→ Variable overhead expenditure variance	$\mathbf{f}(\mathbf{y} - \mathbf{x})$
Actual hours worked x standard variable overhead hourly rate	£y
→ Variable overhead efficiency variance	$\mathbf{f}(z-y)$
Standard hours x standard variable overhead hourly rate [for output achieved]	£z

17.5 Fixed overhead variances

Where a firm is using absorption costing for the valuation of finished goods, it includes in the valuation of those goods a certain proportion of fixed costs, based on (a) the budgeted fixed cost, divided by (b) the budgeted output. This is known as the 'standard absorption rate'. If the firm's actual volume of output is greater than budget, it would have charged out those goods with more than the budgeted fixed costs. It would have 'over-recovered' the budgeted fixed costs, otherwise known as a favourable volume variance.

Example

	Budget	Actual
Output	1,000 units	1,200 units
Fixed costs	£5,000	£5,600

The above example gives a standard absorption rate of £5 per unit (£5,000/1,000 units). Thus, we calculate the fixed overheads volume variance as follows:

```
Actual output at standard rate = 1,200 \times £5 = £6,000

\rightarrow Volume variance £1,000(F)

Budgeted output at standard rate = 1,000 \times £5 = £5,000
```

Unlike previous variances, if the actual is greater than budget, we have a favourable volume variance.

(a) Fixed overhead expenditure variance

This is simply the difference between budgeted fixed overheads and actual fixed overheads. In the above example, we have

Budget £5,000 Actual £5,600

Fixed overheads expenditure variance 600 (A)

17.6 Sales variances

The layout for sales variances is similar to those for labour, materials and variable overheads.

Example

	Budget	Actual	
Output/sales	4,000 units	4,800 units	
price	£10	£8.50	
Turnover	£40,000	£40,800	

We look at the change to sales turnover caused by the difference in price, and the change to sales turnover caused by the change in volume. The format is as follows:

Actual volume at actual price	£40,800
→ Sales price variance	7,200 (A)
Actual volume at standard price	48,000
→ Sales volume variance	8,000 (F)
Budgeted volume at standard price	40,000

Notice that the price variance is adverse, because actual price is lower than standard, which has the effect of reducing profits, while the volume variance is favourable, since the firm sold more units than budget, which has the effect of increasing the firm's profits.

The key format for all variance analysis (except fixed overheads) which we have used is:

actual × actual actual × standard standard × standard

If you can remember this key format, you will find variance analysis quite simple.

Solution 17.1

(a) The purpose of standard costing is to provide a quantified objective which various elements of management should try to adhere to — for example, production should attempt to achieve the standard hours, and no more than the standard hours, for each unit produced. Their performance will be measured against the standard, and any adverse variance will reflect on their success or failure in maintaining those standards.

In setting standards, the areas of responsibility where those standards apply should have confidence in their ability in achieving those standards - i.e. the standards should not be viewed as 'unachievable' or else those areas of management will not even attempt to achieve those standards. On the other hand, the standards should not be seen as easily achievable, since this will not 'stretch' the capabilities of management. Therefore, a balanced or optimising standard should be set which is a challenge, drawing on the skills of management.

Other factors, such as inflation, changes in technology, changes in production processes, should also be considered.

(b) This part simply looks at the aggregate figures given in the question.

(d) Steel Here we have a favourable price variance of £275, but an adverse usage variance of £450. This could be due to the fact that the purchasing manager may have bought a cheaper but inferior quality of steel, with a resulting higher wastage factor.

Chrome ore Here we have an adverse price and usage variance. Not only is the firm paying more for the chrome than standard, but also it is having to use more of it than standard. One possible reason for this may be general price increases in that commodity, coupled with a switch to an inferior grade of chrome ore in order to avoid even higher price increases.

(d) We should begin by looking at those jobs with overall adverse net variances – i.e. Job No. 1 has a net variance of £629(A), which, as a percent of its standard cost, is $(629/10,700) \times 100 = 5.9$ per cent. Job No. 5 has a net variance of £170(A), which is 4.1 per cent over the standard cost.

Therefore, we should investigate Job No. 1 and then Job No. 4. After these, we should look at other adverse variances by labour or materials, and assign an order of priority to largest percentage relative variances.

(e) Possible causes for good performances:

overestimation of standard job costs; employment of more efficient labour; use of higher-quality materials.

Possible causes for bad performances:

underestimation of standard job costs; increase in negotiated wage rates; high wastage of materials.



18 Ratio Analysis

18.1 **Introduction**

Ratio analysis is a numerical attempt to analyse the performance and financial position of a business. By converting absolute numbers into ratios, we have the ability to make comparisons between one firm and another, or between one period and another. Indeed, ratio analysis, which is the interpretation of ratios, cannot be meaningfully achieved without some form of comparison.


For example, if a firm's gross profit/sales margin is 60 per cent, we cannot say whether this is 'high' or 'low' or 'good' or 'bad', without considering (a) the gross margin of its competitors and (b) its gross margin last year and in previous years.

In the following sections we shall have a look at the 'key ratios'. When answering examination questions where you are asked to comment on ratios, the golden rule is to state only the obvious. Do not start to make assumptions for which you have no data.

18.2 Pyramid of ratios

The pyramid of ratios is a technique used to analyse a firm's profitability and efficiency, but remember that commentary can only be made if we have enough data for comparisons, either between two firms (known as *static* comparisons) or between two periods (known as *dynamic* comparisons).

The basic pyramid of ratios looks like this:



By using this pyramid, as illustrated in Worked Example 18.1, we can gradually and systematically track down the causes of any adverse performance, and eventually make suggestions as to where management may be able to take action in order to bring about improvements in the future.

Return on capital employed (ROCE) can be calculated by several methods. The most common method is net profit/owner's capital + long-term liabilities \times (100/1).

From here we branch left and right. The left-hand side of the pyramid high-lights pricing (gross margin) and expenses relative to turnover (level of activity). The right-hand side highlights the efficiency in terms of use of resources — e.g. for every £ of plant machinery, how many £s' worth of turnover was generated?

In the working capital section of the pyramid we have some crude ratios, which are here to indicate some possible problem areas. They should be calculated more accurately if we are provided with sufficient data.

- (i) Sales/debtors or debtors turnover ratio should really be calculated as credit sales/average debtors. The result can then be divided into 12 for months' or 365 for days' credit given. For example, a debtors turnover of 10 means that the firm is giving 12/10 = 1.2 months' credit or 365/10 = 36.5 days' credit.
- (ii) Sales/stock or stock turnover should really be calculated as cost of goods sold/average stock.
- (iii) Sales/creditors shows how many £s' worth of turnover was achieved for every £s' worth of credit taken. However, we should also calculate the creditors turn, which is credit purchases/average creditors and show how frequently the firm pays off its creditors.

18.3 Liquidity ratios

Liquidity ratios are designed to assess the firm's relative ability to meet its short-term debts.

The most significant liquidity ratio, also known as the acid test is current assets less stock/current liabilities and shows the clearance, if any, which the firm has in terms of liquid or near-liquid assets over immediate debts. Many textbooks suggest that this ratio should ideally be no less than 1:1; however, many firms are able to operate successfully on a ratio of less than 1:1, since they have a rapid stock turnover and little or no credit sales (e.g. Sainsbury).

The other ratio which is also a test of 'solvency' is the working capital ratio or 'current ratio' (current assets/current liabilities). If this ratio were less than 1:1, it would indicate a negative amount of working capital (current assets — current liabilities). A trading company could find itself in serious difficulties, since it would be unable to pay its ongoing operational expenses, and be able to pay off its creditors.

On the other hand, working capital can be at too high a level. An overinvestment in stock, debtors or cash can imply idle resources which might be used more profitably if transferred to a more long-term investment such as plant or buildings, which can be used to generate production and/or sales.

18.4 Investors' ratios

In this section we shall look at those ratios of interest to shareholders or potential shareholders of limited companies, apart from the ratios already mentioned.

(i) % Dividend =
$$\frac{\text{dividend (in pence) per share}}{\text{nominal value per share}} \times \frac{100}{1}$$

where nominal value is the 'face' value of the share, not the market value.

(ii) % Yield =
$$\frac{\text{dividend per share}}{\text{market value per share}} \times \frac{100}{1}$$

This formula reflects the return, in terms of income, on the current market value of the shareholder's investment.

(iii) Dividend cover =
$$\frac{\text{net profit after tax} - \text{preference share dividends}}{\text{interim} + \text{final dividend}}$$

This formula is a reflection of the 'dividend policy' of the firm. It shows how many times over the firm could have paid the dividends it actually paid. A high cover, say 10, indicates that the firm is retaining 90 per cent of its profits in the business, while a cover of, say, 2 indicates that it is returning 50 per cent of its profits.

(iv) Earnings per share (EPS) =
$$\frac{\text{net profit after tax} - \text{preference dividends}}{\text{number of issued ordinary shares}}$$

This formula signifies how much each ordinary share has earned in terms of profits, and is not affected by dividends.

Price/earnings (P/E) ratio =
$$\frac{\text{market price per share}}{\text{EPS}}$$

This ratio has become increasingly popular recently with financial analysts. Technically it is interpreted as how many years it would take for each share to earn its current market value, if earnings continued at the current level. However, it is really used as a reflection of the market's confidence in the future performance of the company. Many shares of plcs have P/E ratios in the 10–20 range; however, a glance at the financial press will reveal a range from less than 5.0 to more than 90.

18.5 Gearing

Gearing has become a popular topic with examiners. It is a way of looking at the long-term financial structure of a business, in terms of the ratio between fixed-interest capital (such as long-term loans, debentures and preference shares) and equity capital (issued share capital and reserves).


There are two ways of expressing the gearing:

- (i) The gearing ratio is easily remembered as G = F/E, where G = gearing, F = fixed interest borrowing (including preference shares) and E = equity. Thus, a firm with £100,000 of loan capital, £50,000 of issued preference shares and £300,000 issued share capital + reserves can be said to have a gearing ratio of 1.5:3 or 1:2.
- (ii) A second way of expressing gearing is as a percentage:

$$\%G = \frac{F}{F + E} \times \frac{100}{1}$$

In the above example, the gearing is $(150,000/450,000) \times (100/1) = 33$ per cent, which means that 33 per cent of the firm's long-term capital is in the form of fixed interest of fixed dividend certificates.

High gearing (i.e. where at least 50 per cent of the capital is fixed interest) is said to be 'high-risk' structure, for the simple reason that the ordinary share-holder is unlikely to achieve any earnings in periods of 'low profits', owing to relatively high amounts of interest and preference dividends that will have to be paid before there is any amount left over for the ordinary shares. On the other hand, when profits are high, and because of the relatively low number of ordinary shares in a high-geared company, the earning per share will be greater than if the firm had been low-geared (see Worked Example 18.2).



The relationship between earnings and gearing is best illustrated by a diagram. As can be seen, high-geared = greater risk, but possibly much greater returns to the (ordinary) shareholder.

18.6 Worked examples

Martha is the accountant of a trading business. During the past year she produced interim accounts for the six months ended 30 November 1985, and draft final accounts for the year ended 31 May 1986, as follows:

Solution 18.1


In order to explain any changes, we should compare the first six months' performance against that of the second six months. Therefore, we must calculate the second six months' profit and loss by deducting the respective first six months' profit and loss figures from the final profit and loss.

Thus, we have:

Profit and loss: 6 months ended 31 May 1986

	£000s
Sales	196
Cost of sales	_70
Gross profit	126
Expenses	112
Net profit	14

We can now construct a pyramid of ratios; the first six months' figures are in parentheses.



From the above calculations, we can see that the return on capital employed was only 13.5 per cent in the second six months, compared with 46.7 per cent in the first six months. This was mainly due to the relatively high level of expenses in the second six months, which were 57.1 per cent of sales, compared with only 40 per cent of sales in the first six months.

In terms of use of assets, we generated more sales per £ of fixed assets (at book value) in the second period, but this is only to be expected, owing to depreciation.

We have more than doubled our investment in working capital, from £20,000 at the end of November to £41,000 at the end of May. However, we seem to have a relatively high bank balance. This could be reduced, and used for investment in fixed assets.

If the business had not leased the additional premises, sales for the second six months would have been £126,000, yielding a gross profit of £126,000 – $(\frac{3}{5} \times £70,000) = £84,000$, a gross margin of 67 per cent.

The expenses of the business would have been £112,000 - £21,000 = £91,000, and the net profits would have been £84,000 - £91,000 = -£7,000 (a loss!).

Our conclusion is that expenses in the older part of the business have dramatically increased. If the new site had not been leased, then the firm would have made a loss in the second six months.

Recommendation Reduce expenses in established site as a priority. Second, investigate alternative investments, rather than have excess funds in the bank.

(a) The return on capital employed is measured before interest + tax. We can calculate (i) profit before interest and tax, and then (ii) net profit after tax. Finally, we can express this as a percentage of shareholders' capital.

(b) Company C is the most highly geared of the three companies, with a gearing ratio of 11:1. One of the merits of being highly geared is the relative high return to ordinary shareholders when profits are high. In this example, C returns 48.6 per cent, while A returns only 9 per cent. However, in a highly geared firm, the return on shareholders' capital or earnings per share (EPS) is much more volatile than in a low-geared company. Notice how for shareholders in Company A their return falls by 4.5 percentage points when profits fall, but for company C shareholders their return falls from 48.6 per

cent to -12 percent, a fall of 60.6 percentage points, even though the reduction in profits before interest and tax is the same for both companies. See also Further Exercise 19.1.

Answer 18.1

(a) (i) Rate of stock turnover = $\frac{\cos t \text{ of goods sold}}{\text{average stock}}$

We are not told the cost of goods sold, but we can calculate it, since we are given sales and gross profit 'margin' on cost.

For Fresco, the gross profit/cost = 20 per cent. Therefore, sales (cost + profit) = 120 per cent of cost.

:. Cost =

 × sales = $\frac{100}{120}$ × £420,000 = £350,000

Therefore,

Fresco's rate of stock turnover = $\frac{350,000}{50,000}$ = 7 p.a.

(ii) Gross profit/sales for Fresco is determined by his gross profit/cost margin. If this, which is normally called a percentage mark-up, is 20 per cent or $\frac{1}{5}$, then gross profit/sales = $1/(5+1) = \frac{1}{6}$ or $16\frac{2}{3}$ per cent.

For Pick, we must make an adjustment for the reduction in value of stock of £10,000 (note 2). If we ignore this at first, Pick's gross profit would have been $\frac{1}{5}$ of sales (£250,000) = £50,000, but, because of the reduction in stock value, the gross profit is now reduced to £40,000, giving us a gross profit/sales ratio of $(40/250) \times (100/1) = 16$ per cent.

To calculate the net profit/sales percentage, we need to calculate net profit!

Note that there is no need to adjust Fresco's capital for the motor vehicle. It was treated as a business asset, and we assume was paid for from the business bank account.

(b) On the basis of the above calculations, Fresco is a far more attractive investment than Pick. The return on capital for Fresco is nearly 3 times greater than that of Pick. Fresco is able to earn a greater net profit/sales margin, owing to his relatively low overheads, even though Fresco's turnover is £420,000, compared with Pick's £250,000. However, I would suggest that Fresco should attempt to reduce his level of working capital. The ratio of 4.31:1 is far too high. He could perhaps reduce his debtors, since he is giving them an average of two months' credit ([70/420] × [12/1]).

Question 18.2

How does 'stock turn' differ from 'turnover'? What is the importance of stock turn in ratio analysis and how is it calculated?

Answer 18.2

Stock turn is the rate at which stock is replaced or turned over during a period (usually a year), whereas turnover is the level of sales achieved during a period.

Stock turn is an important ratio, since it is an indication of how efficient the firm is in the area of *stock control*. If stock turn is relatively low, it indicates that the firm is holding on average too high a level of stock for the volume of trade achieved. If stock turn is relatively high, it indicates rapid replacement of stock and here the firm may find that it has, on occasion, been 'out-of-stock' on various products.

The stock turn ratio is calculated as follows:

cost of goods sold in the period average stock held in the period

Usually we are only given information on opening and closing stocks, in which case the average stock is simply

opening stock + closing stock
2

If, say, the stock turn for a year's trade is 6, this means that the firm is, on average, replacing stock once every two months (12 months/6).

19 Funds Flow Statements

19.1 Introduction

The purpose of the funds flow statements is to show the movement of funds into and out of the firm for the period (year). In particular, it highlights the size of the increase or decrease in working capital for that period, and what has caused that increase or decrease.

A change in the amount of working capital can only be caused by changes in other sections of the balance sheet. The composition of working capital can change (e.g. less stock and more debtors), but the actual amount of working capital can only change if the total sources of finance (profits, capital, disposal of fixed assets, long-term loans, etc.) is not the same as the total application of funds (purchase of fixed assets, repayments of loans, payment of dividends, payment of tax, etc.)

If the source of funds is greater than the application of funds, this must result in an increase in working capital.

The net profit results in a flow of funds into the firm (sales less cost of goods sold and expenses). Even if the sales were all on credit and still not realised, this will increase our current asset of debtors.

The increase in share capital results in a flow of cash into the firm.

The purchase of fixed assets results in a flow of cash out of the firm, or, if they were bought on short-term credit, must result in a decrease in working capital (current assets less current liabilities).

Therefore, by examining these sources and applications of funds, we can determine their net effect on working capital.

We can then go on to examine the changes that have taken place to each element of working capital and show that in fact the net effect of all these changes (increase/decrease in stock, debtors, creditors, bank) explains the overall change in working capital.

The funds flow statement's main purpose is to explain how a business obtains and uses its funds, and indicates whether a business is generating enough funds to meet its needs or whether it is approaching insolvency.

There are some technical points arising from the above statement.

The adjustments section is there because certain charges made against net profit are not movements of cash, and therefore must be taken into account when arriving at the figure for 'funds generated from operations'.

In the 'application of funds' section, we have 'dividends paid'. This means the actual monies paid to shareholders as dividends during the year. It will be the sum of last year's proposed dividends (which are paid during this year) and this year's interim dividend. It must not include any proposed dividends at the end of this year, since they have not been paid by the end of this year.

The 'tax paid', which is also in the application section, is similar in its treatment to dividends. We show only the tax paid during this year, and we must not include any tax provision made against this year's profits.

20 Capital Budgeting

20.1 Introduction

Capital budgeting is really about how the firm decides which fixed assets are a 'worthwhile' investment or which alternative investments are the most profitable or financially attractive. There are four techniques commonly used:

- (i) The average rate of return
- (ii) Payback
- (iii) Net present value (NPV)
- (iv) Percentage yield or internal rate of return (IRR)

None of these methods needs to be used in isolation. Quite often management will evaluate investment projects using two or more of the above investment appraisal techniques.

20.2 The average rate of return

This method simply looks at the average annual profit earned by a project, and expresses this average profit as a percentage of the original cost of the investment, taking into account any scrap or disposal value at the end of the project's life.

Example

A machine costs£10,000, and shows a net cash inflow for five years of £3,500 p.a. Its scrap value at the end of year 5 is estimated at £400. The average rate of return is therefore

$$\frac{\text{average profit}}{\text{cost}} = \frac{(5 \times 3,500 + 400 - 10,000)/5}{10,000}$$
$$\frac{1,580}{10,000} = 15.8\%$$

By adding back the scrap value and deducting the original cost, we are, in fact, taking into account depreciation in the calculation of the average rate of return.

20.3 Payback

This method looks at how long, in terms of cash flow, it will take for the project to recover its original cost. The calculation often involves parts of years. It assumes that cash is received evenly through each year. From the example used above, we can build up the cumulative cash flow for the end of each year.

	£
end year 1	3,500
year 2	7,000
year 3	10,500
year 4	14,000
year 5	17,500

We can see that the £10,000 original cost is recovered at some point after the end of year 2, but before the end of year 3. Assuming an even cash flow during year 3, the fraction of year 3 that needs to expire before the £10,000 total is achieved is given by

$$\frac{£10,000 - \text{year 2 cumulative total}}{\text{year 3 cash flow}} = \frac{10,000 - 7,000}{3,500} = 0.86$$

Therefore, the payback period for this project will be 2.86 years. Obviously, the shorter the payback period, the more attractive the investment project.

The major criticism of this technique is that it ignores any cash flows beyond the payback point in time. Thus we could have 2 projects, both with the same payback, but one earns £100,000 beyond payback, and the other only £1,000, yet both would be given equal praise under the payback system.

20.4 Net present value (NPV)

The NPV method takes into consideration the cash flows of the whole life of the investment project, and also considers the 'time value' of money.

This takes into consideration the fact that most people would rather have £1 now than £1 in five years' time, since £1 in five years' time will be worth considerably less than £1 now, owing mainly to (a) inflation and (b) the rate of interest, or 'opportunity cost' of money.

The NPV method takes into account the time value of money by 'discounting' further cash flows to an equivalent present value. This is achieved by (a) choosing a percentage discount rate, and (b) using the net present value tables, which are found in books of statistical tables. Here is an extract:

Discount rate	16%	18%	20%
end year 1	0.862	0.847	0.833

From the table we can determine that if the firm uses a discount rate of 18 per cent, then £1 received at the end of year 3 will only be worth 60.9 p (its present value).

The method of calculating the NPV of a stream of cash flows is simply a matter of adding together the discounted values of each year's cash flow.

For example: A machine costs £25,000, and generates the following net cash inflows:

The company uses a 16 per cent discount rate.

We call the time of the original investment year 0. Thus, we have the following:

The NPV of £3,884 is positive and the project is therefore worth while. Notice that the year 0 discount factor is always 1.0.

20.5 Percentage yield or internal rate of return (IRR)

This method of capital investment appraisal has an advantage over the NPV method in that it does not use an assumed (subjective) discount rate, but instead calculates the discount rate which would result in the net present value of discounted cash flows being zero. Once the IRR has been determined, it can be compared with the firm's objective or target rate of return, and the project can be accepted or rejected on that criterion.

The IRR is found by trial and error. Select a discount rate. Calculate the NPV for the project. If this NPV is positive, it implies that the selected discount rate was too low. Select a higher discount rate, until the resulting NPV is negative. The IRR will be between these last two selected discount rates; its value can be found by estimation, using linear proportions.

For example, for a project a 10 per cent discount rate gives a NPV of £500, and a 12 per cent discount rate gives a NPV of -£100. Therefore, the IRR can be estimated by the formula $10\% + [(500/600) \times 2\%] = 11.6\%$ or by drawing a graph.

Solution 20.1

- (a) Net present value (NPV) is the aggregate of a series of annual cash flows which have been discounted using an assumed discount rate. The result can be a positive or negative value. However, the yield or internal rate of return is the percentage discount rate which would result in a series of discounted cash flows having an aggregate value of zero.
- (b) What we have to do here is discount the cash flows and calculate their net present values, using the 16 per cent, 18 per cent and 20 per cent discount rates. If the NPV is negative, the rate of interest is too high.

(b) Report: Ambergate Capital Investment Appraisal

On the basis of two evaluation methods required, it appears that machine P is the most attractive choice, in terms of both payback and net present value.

Machine P pays back after 2.94 years, machine N after 3.39 years, and machine Q after 5.56 years.

In terms of NPV, investment in machine P yields an NPV of £1,364, in machine N -£508, and in machine Q -£3,942.

The payback method of appraisal has one major weakness: it ignores any cash flow beyond the payback point in time, as well as ignoring the 'time value' of money.

The net present value method hasn't these problems, but its major weakness is the choice of the percentage discount rate. How can the firm be sure that the 12 per cent discount rate will be an accurate discount rate for the next 6 years?

Moray Ferries Ltd own a single ship which provides a short sea ferry service for passengers, private vehicles and commercial traffic. The present ship is nearing the end of its useful life and the company is considering the purchase of a new ship.

21 Use of Computers in Accounting

21.1 Introduction

We cannot attempt here to provide a full authoritative text on the use of computers in accounting, but merely an outline of their applications, along with a few definitions and some suggested answers to typical examination questions.

21.2 Applications

Applications fall into two main areas.

(i) Financial accounting Computers and electronic data processing can be used to replace the mundane aspects of a 'book-keeper's' work or 'writing up' the books of accounts. He can, after training, use a suite of computer accounting programs or 'packages' to do this for him. There are 'off the shelf' (prewritten) items of accounting software available to process accounting data.

Many of these accounting packages are 'modular'. This means that a fully integrated computerised accounting system can be built up gradually. This has advantages in terms of cash outflow and flexibility for the smaller businesses. The firm can first buy, say, a sales ledger system, to handle its customer accounts, invoicing, statements, etc., and at a later stage expand the system by adding the payroll module to handle its wages and salaries processing, to produce the payslips, printed cheques, etc. Other modules can be added later — e.g. purchase ledger, nominal ledger and cash book. Once the full system is installed, the firm can be provided with profit and loss statements and balance sheets as frequently as required by the use of a few commands.

(ii) Management accounting In the area of analysis and decision-making, the availability of up-to-date information is invaluable. Thus, immediate access to the latest profit and loss statements has its advantages. In addition, more specialised programs can be used to aid decision-making. For example, computers can be used to generate frequent 'variance' reports, so that action can be taken quickly to reverse adverse results.

One particular type of software which management and management accountants find extremely valuable is known as a 'spreadsheet'. Many brands are available as off-the-shelf packages for micro-computers; among the best-known are Lotus 1-2-3, Visicalc, Supercalc. A spreadsheet is simply a large area of rows and columns, made up from a collection of addressable cells; the spreadsheet is like a grid. Each cell on the grid has a reference number or grid number. Text, numbers or formulas can be entered (via the keyboard) into

any of the cells, and arithmetic and statistical operations performed on the contents of the cells. Management can use spreadsheets for a whole variety of needs, but the most common applications are budgeting, forecasting and statistical analysis of results.

There are many benefits to using spreadsheets, but the biggest advantage is that of 'what if?' calculations — i.e. what if raw material costs increase by 5 per cent, 10 per cent or 15 per cent. How will this affect our budgeted profit? By using a spreadsheet, immediate implications of changes to relevant figures can be seen on the VDU and, if required, printed out on a report.

More recently, computer graphics have become added features of spreadsheets, so that charts can be printed of, say, budgeted monthly sales and profits, for inclusion in management reports.

Note: For the larger computer systems (mainframes) as opposed to the desk-top or 'stand-alone' micros, specialist, tailor-made software is written to suit the firm's individual needs or systems, but the smaller firm, with, say, one or two micros will often find it more economical to buy the 'off-the-shelf' software.

21.3 Worked examples

Example 21.1

Give simple definitions of hardware and software in a computer configuration. Give two examples of each that could be used in a computerised accounting system.

(OLE)

Solution 21.1

The hardware in a computer system is the physical part of the system, such as keyboards, VDUs, processing unit, printers, etc., while software is defined as the programs or sets of instructions given to the computer telling it what operations to perform and how to perform them.

Two examples of hardware in the computerised accounting system would be:

- 1. The keyboard to input the accounting data such as credit sales transactions.
- 2. The VDU to display the details of a debtors account.

Two examples of software would be:

- 1. A payroll program to perform wage calculations, deductions, etc., and produce payslips.
- 2. A sales ledger program to produce invoices, statements, etc., for debtors.

Example 21.2

How does the information in a 'transaction file' differ from that in a 'master file'. Include in your answer examples of such information in a typical accounting computer run.

(OLE)

Solution 21.2

Files are simply areas of stored data. The data used in accounting, like any other data, need to be classified or put into some sensible and usable order.

Transaction files hold transaction data. There will be a transaction for sales. When a transaction (a sale) takes place, it is added to the transaction file, and will be deleted from the file after the transaction has been processed.

A master file holds standing data — that is, data which are used over and over again (e.g. data on customers, such as their name, account number, address, etc.).

Thus, on a typical accounting run data will be taken from the sales transaction file (i.e. sales of goods to customers); they will then be compared with information on the master file to ensure that valid data on customers have been entered in the transaction file, and, once cleared, sales will be recorded in the customer file and an invoice generated.

Example 21.3

What is a posting run in a computer accounting system? Give two examples of such runs and explain what information is being posted. (OLE)

Solution 21.3

A posting run is the processing of data from a transaction file so that the relevant records can be updated. Examples would be:

- 1. A Sale to Solid State Ltd is held on the transaction file. When the processing run takes place, the details of this sale are added to Solid State's account and its balance increased accordingly, and the stock figure reduced accordingly.
- 2. When the firm makes a series of payments to its creditors, the posting run will make appropriate entries in the purchases ledger.

Example 21.4

- (a) Write a brief report to the owners of a business, identifying the advantages that a computerised system would bring to the accounting functions of the business, distinguishing between:
 - (i) the clerical aspects of accounting;
 - (ii) the management accounting function.
- (b) State three limitations of a computerised accounting system.

Solution 21.4

(a)

Report: Computerised Accounting System

Clerical Accounting

Advantages A computerised system would enable clerical staff to become significantly more involved in their tasks, since their work could be reorganised to a more 'whole task' approach — i.e. instead of just concentrating on sales data, or invoices or credit control, or receipts, they could become responsible for a whole group of customers and be responsible for all transactions, rather than just a small portion. This would be likely to improve motivation. There will also be the obvious advantage of automatic rather than manual or calculator-based, calculations.

Management Accounting

Advantages Almost instantaneous access to accounting information, either on paper or VDU, with the added advantage of 'what if?' calculations on alternatives open to management.

(b) Three Limitations

- (i) It can only process the data it is fed. Therefore, there is always the problem of 'rubbish in rubbish out'.
- (ii) Future changes in the business usually imply expensive modifications to software and/or additions to hardware.
- (iii) A breakdown in the equipment can leave management stranded, without essential information on which to base decisions.
