# INTRODUCTION

Research Methods are the tools and techniques for doing research. Research is a term used liberally for any kind of investigation that is intended to uncover interesting or new facts. As with all activities, the rigour with which this activity is carried out will be reflected in the quality of the results. This book presents a basic review of the nature of research and the methods which are used to undertake a variety of investigations relevant to a wide range of subjects, such as the natural sciences, social science, social anthropology, psychology, politics, leisure studies and sport, hospitality, healthcare and nursing studies, the environment, business, education and the humanities.

Just about every university course includes an element of research that students must carry out independently, in the form of projects, dissertations and theses, and the more advanced the degree, the greater the research content. In the workplace there is frequently a need to do research in order to develop or improve the business or service, while some types of businesses rely on doing research projects for their very existence.

Research methods are a range of tools that are used for different types of enquiry, just as a variety of tools are used for doing different practical jobs, for example, a pick for breaking up the ground or a rake for clearing leaves. In all cases, it is necessary to know what the correct tools are for doing the job, and how to use them to best effect. This book provides you with the basic information about the tools used in research, the situations in which they are applied and indicates briefly how they are used by giving practical examples.



I have also included chapters that describe the theoretical background to research and the ways of thinking that lead to the different ways of carrying out investigations and coming to conclusions. Therefore, the book is divided into two basic parts. Part I consists of Chapters 1–5 and provides an introduction to research theory and general practice. Part II contains Chapters 6–11 and explains the main research methods used for collecting and analysing data and gives advice on the practical issues of presenting your research in a clear and attractive manner.

As this book acts as an introduction to the basics of research methods, you will probably want to find out more about many of the issues mentioned, so I have made suggestions for further reading at the end of each chapter ('Where to find out more'). You will notice that research is riddled with technical terms, or what some people would call jargon. The first time any of the terms are used they are highlighted in **bold** and then I normally provide an explanation of the meaning. In order to provide a useful way to remind you of the definitions of the main technical terms used in this book (and for that matter elsewhere too), I have included a glossary at the end which includes all those terms highlighted in bold in the main text plus a few extra ones you may come across in your other reading. You can easily refer to the glossary from anywhere in the book.

Not only will reading this book give you an insight into the different aspects of research theory and practice and help you to understand what is involved in carrying out a research project, it will also help you to evaluate the claims made by academics, experts of all kinds, politicians, advertisers, etc. by judging the quality of the evidence provided by the research on which they base their arguments.

You don't have to read the book from the beginning to the end, like a novel. It can be used as a reference for finding out about the characteristics of a particular research method, the meaning of a certain term or about aspects of theory. However, the chapters are arranged in the approximate sequence of the activities required for carrying out a research project, so it can be used as a step-by-step guide to doing your own research.

Finding out about things and trying to understand events and situations are activities that symbolize the very essence of humanity. At a time when we are bombarded with information, when pressing problems are ever present, when the opportunities for discovery

are all around us, it is really useful, if not essential, to be familiar with the methods for doing research – any research. This book will help you to think clearly, to structure your enquiries and to come to conclusions based on appropriate evidence and sound argument. It will enable you to consolidate your knowledge and understanding of your surroundings, and will also help you to hold your own in a discussion and to critically analyse the claims and arguments made by others.



# PART I

## RESEARCH THEORY AND PRACTICE

One reviewer of my first draft of this book suggested that these first five chapters did not deal with research methods at all. Strictly speaking, if you take a purist's view of what research methods are, he was correct. If you consider that research methods are only specific techniques for collecting and analysing data in such a way that you can come to reliable conclusions, then Part I of this book does not deal with these. However, I believe that unless you know what research is about, and understand the context in which these research methods are used, you will not know which to use and why. Therefore, in Part I of this book, I have provided an overview of the nature of research, its theoretical foundations, what is involved in the process, what you can do with it, and what makes good research.

In order to place research within its context, in Chapter 2 I have provided you with a brief review of the theoretical basis of research as an activity. I consider different ideas about what we can know and how we can know it, and how we can get an understanding of the world around us. You will see that this type of thinking has a long history, probably ever since humans became aware of themselves as being special within nature. The ability to reflect and use abstract ideas set them apart from the animal and plant kingdom. The debate revolves around to what extent humans can be autonomous from their environment and society.

In Chapter 3, I look at how research projects are structured. Of course, not all projects are the same, but they do all share some similar features. For example, they all have some aims and an argument that leads to some conclusions based on evidence of some kind. The ways that the aims can be formulated are described, and the way that arguments can be constructed are discussed.

The important issue of ethics is explored in Chapter 4. The reliability of progress in knowledge is dependent on the honesty of the researchers. It also often depends on the co-operation of members of the public or particular sections of the population, who must be protected from any adverse effects of the research process. Basically, the principle behind ethical research is to cause no harm and, if possible to produce some gain for the participants in the project and in the wider world.

Any piece of research will not be the first of its kind. There is always a context in which the project is carried out and a history of work that has gone before it. In Chapter 5, I consider how to review the literature in relation to your chosen subject, where to find the information and how to assess what you have found in relation to your projected work. This is a basic scholarly exercise, but once you have learned the skills needed to interrogate the accumulated knowledge and theories of a subject, you will find that this is useful in many aspects of life, particularly as we are bombarded from all sides with claims and assertions.

## RESEARCH BASICS

Research is a very general term for an activity that involves finding out, in a more or less systematic way, things you did not know. A more academic interpretation is that research involves finding out about things that no-one else knew either. It is about advancing the frontiers of knowledge.

Research methods are the techniques you use to do research. They represent the tools of the trade, and provide you with ways to collect, sort and analyse information so that you can come to some conclusions. If you use the right sort of methods for your particular type of research, then you should be able to convince other people that your conclusions have some **validity**, and that the new knowledge you have created is soundly based.

It would be really boring to learn about all these tools without being able to try them out – like reading about how to use a plane, chisel, drill etc. and never using them to make something out of a piece of wood. Therefore courses in research methods are commonly linked to assignments that require these methods to be applied – an actual research project that is described in a dissertation or thesis, or a research report. In the workplace, it is often the other way round. When there is a perception that more information and understanding is needed to advance the work or process of work, then ways are sought how research can be carried out to meet this need.

Being a researcher is as much about doing a practical job as being academically competent. Identifying a subject to research, finding and collecting information and analysing it, presents you with a range of practical problems that need to be solved. Over hundreds of years, techniques, or methods, have been evolved to provide solutions to these problems. The practice of research is closely bound up with the theoretical developments that were promoted by philosophers and key thinkers and practitioners in the sciences, right back to the ancient Greeks. The debate about knowledge and how we acquire it is rooted in philosophical thought (discussed in Chapter 2).

## WHAT YOU CAN DO WITH RESEARCH

So what can we use research to do in order to gain this new knowledge? Some of the ways it can be used one to:

- **Categorise.** This involves forming a **typology** of objects, events or concepts, i.e. a set of names or 'boxes' into which these can be sorted. This can be useful in explaining which 'things' belong together and how.
- **Describe.** Descriptive research relies on observation as a means of collecting data. It attempts to examine situations in order to establish what is the norm, i.e. what can be predicted to happen again under the same circumstances.
- **Explain.** This is a descriptive type of research specifically designed to deal with complex issues. It aims to move beyond 'just getting the facts' in order to make sense of the myriad other elements involved, such as human, political, social, cultural and contextual.
- **Evaluate.** This involves making judgements about the quality of objects or events. Quality can be measured either in an absolute sense or on a comparative basis. To be useful, the methods of evaluation must be relevant to the context and intentions of the research.
- **Compare.** Two or more contrasting cases can be examined to highlight differences and similarities between them, leading to a better understanding of phenomena.
- **Correlate.** The relationships between two phenomena are investigated to see whether and how they influence each other. The

relationship might be just a loose link at one extreme or a direct link when one phenomenon causes another. These are measured as levels of association.

- **Predict.** This can sometimes be done in research areas where correlations are already known. **Predictions** of possible future behaviour or events are made on the basis that if there has been a strong relationship between two or more characteristics or events in the past, then these should exist in similar circumstances in the future, leading to predictable outcomes.
- **Control.** Once you understand an event or situation, you may be able to find ways to **control** it. For this you need to know what the cause and effect relationships are and that you are capable of exerting control over the vital ingredients. All of technology relies on this ability to control.

You can combine two or more of these objectives in a research project, with sometimes one objective needing to be successfully achieved before starting the next, for example you usually need to be able to explain how something happens before you can work out how to control it.

## RESEARCH DESIGNS

There are numerous types of research design that are appropriate for the different types of research projects. The choice of which design to apply depends on the nature of the problems posed by the research aims. Each type of research design has a range of research methods that are commonly used to collect and analyse the type of **data** that is generated by the investigations. Here is a list of some of the more common research designs, with a short explanation of the characteristics of each.

### HISTORICAL

This aims at a systematic and objective evaluation and synthesis of evidence in order to establish facts and draw conclusions about past events. It uses primary historical data, such as archaeological remains as well as documentary sources of the past. It is usually necessary to carry out tests in order to check the **authenticity** of these sources.



Apart from informing us about what happened in previous times and re-evaluating beliefs about the past, historical research can be used to find contemporary solutions based on the past and to inform present and future trends. It stresses the importance of interactions and their effects.

#### DESCRIPTIVE

This design relies on observation as a means of collecting data. It attempts to examine situations in order to establish what is the norm, i.e. what can be predicted to happen again under the same circumstances. 'Observation' can take many forms. Depending on the type of information sought, people can be interviewed, questionnaires distributed, visual records made, even sounds and smells recorded. Important is that the observations are written down or recorded in some way, in order that they can be subsequently analysed. The scale of the research is influenced by two major factors: the level of complexity of the survey and the scope or extent of the survey.

#### CORRELATION

This design is used to examine a relationship between two concepts. There are two broad classifications of relational statements: an association between two concepts – where there is some kind of influence of one on the other; and a causal relationship – where one causes changes to occur in the other. **Causal statements** describe what is sometimes called a 'cause and effect' relationship. The cause is referred to as the '**independent variable**', the variable that is affected is referred to as the '**dependent variable**'.

The correlation between two concepts can either be none (no correlation); positive (where an increase in one results in the increase in the other, or decrease results in a decrease); or negative (where the increase in one results in the decrease in the other or vice versa).

The degree of association is often measurable.

#### COMPARATIVE

This design is used to compare past and present or different parallel situations, particularly when the researcher has no control over events. It

can look at situations at different scales, macro (international, national) or micro (community, individual). **Analogy** is used to identify similarities in order to predict results – assuming that if two events are similar in certain characteristics, they could well be similar in others too. In this way comparative design is used to explore and test what conditions were necessary to cause certain events, so that it is possible, for example, to understand the likely effects of making certain decisions.

#### EXPERIMENTAL

Experimental research attempts to isolate and control every relevant condition which determines the events investigated and then observes the effects when the conditions are manipulated. At its simplest, changes are made to an independent variable and the effects are observed on a dependent variable – i.e. cause and effect. Although experiments can be done to explore a particular event, they usually require a hypothesis (prediction) to be formulated first in order to determine what variables are to be tested and how they can be controlled and measured. There are several **classes** of experiment – pre, true, quasi, etc. which are characterized by the amount of checking and control involved in the methods.

#### SIMULATION

**Simulation** involves devising a representation in a small and simplified form (**model**) of a system, which can be manipulated to gauge effects. It is similar to experimental design in the respect of this manipulation, but it provides a more artificial environment in that it does work with original materials at the same scale. Models can be mathematical (number crunching in a computer) or physical, working with two- or three-dimensional materials. The performance of the model must be checked and calibrated against the real system to check that the results are reliable. Simulation enables theoretical situations to be tested – what if?

#### EVALUATION

This descriptive type of research is specifically designed to deal with complex social issues. It aims to move beyond ‘just getting the facts’,

by trying to make sense of the myriad human, political, social, cultural and contextual elements involved. There are a range of different approaches of evaluation models, for example, systems analysis – which is a holistic type of research looking at the complex interplay of many variables; and responsive evaluation – which entails a series of investigative steps to evaluate how responsive a programme is to all those taking part in it. A common purpose of evaluation research is to examine the working of projects from the point of view of levels of awareness, costs and benefits, cost-effectiveness, attainment of objectives and quality assurance. The results are generally used to prescribe changes to improve and develop the situation.

#### ACTION

Essentially, this is an ‘on the spot’ procedure, principally designed to deal with a specific problem found in a particular situation. There is no attempt made to separate the problem from its context in order to study it in isolation. What are thought to be useful changes are made and then constant monitoring and evaluation are carried out to see the effects of the changes. The conclusions from the findings are applied immediately, and further monitored to gauge their effectiveness. Action research depends mainly on observation and behavioural data. Because it is so bound up in a particular situation, it is difficult to generalize the results, i.e. to be confident that the action will be successful in another context.

#### ETHNOLOGICAL

Ethnological research focuses on people. In this approach, the researcher is interested in how the subjects of the research interpret their own behaviour rather than imposing a theory from outside. It takes place in the undisturbed natural settings of the subjects’ environment. It regards the context to be as equally important as the actions it studies, and attempts to represent the totality of the social, cultural and economic situation. This is not easy as much of culture is hidden and rarely made explicit and the cultural background and assumptions of the researcher may unduly influence the interpretations and descriptions. Moreover there can be confusions produced by the use of language and the different meanings which may be given to words by the respondents and researcher.

## FEMINIST

This is more of a perspective than a research design that involves theory and analysis that highlight the differences between men's and women's lives. Researchers who ignore these differences can come to incorrect conclusions. However, everyone is male or female, so value neutrality is impossible as no researcher practises research outside his or her system of values. No specific methods are seen to be particularly feminist, but the methodology used is informed by theories of gender relations. Although feminist research is undertaken with a political commitment to identify and transform gender relations, it is not uniquely political, but exposes all methods of social research as being political.

## CULTURAL

Many of the prevailing theoretical debates (e.g. postmodernism, poststructuralism etc.) are concerned with the subjects of language and cultural interpretation. Cultural research provides methodologies that allow a consistent analysis of cultural texts so that they can be compared, replicated, disproved and generalized. Examples of approaches to the interpretation of cultural texts are: content analysis, semiotics and discourse analysis. The meaning of the term 'cultural texts' has been broadened from that of purely literary works to that of the many different forms of communication, both formal such as opera, TV news programmes, cocktail parties etc., and informal such as how people dress or converse.

## DECIDING ON YOUR TYPE OF RESEARCH

It is your research interest that decides the nature of your research problem, and this will indicate the appropriate type of research to follow. Once the objectives of a research project have been established, the issue of how these objectives can be met leads to a consideration of which research design should be chosen. The research design provides a framework for the collection and analysis of data and subsequently indicates which research methods are appropriate. You can combine two or more types of research design, particularly when your subject combines the study of human behaviour with that of, for example, economics, technology, legislation or organizations.

The different types of research design may involve the use of their own specific types of research methods, developed specifically to solve the problems inherent in that design. However, some methods are widely used across many research types.

## WHERE TO FIND OUT MORE

Apart from continuing to read this book, there are other introductions to research that you may wish to check out. Most books on this subject cover the whole sequence of doing research. The following books are aimed at undergraduate and postgraduate research and selective reading of the preliminary chapters will provide further guidance on research basics. Each gives a slightly different view of the issues, so refer to as many as possible. You can probably do this in the library without even taking the books out on loan.

## RESEARCH THEORY

Research is about acquiring knowledge and developing understanding, collecting facts and interpreting them to build up a picture of the world around us, and even within us. It is fairly obvious then, that we should hold a view on what knowledge is and how we can make sense of our surroundings. These views will be based on the philosophical stance that we take.

Despite this, some people maintain that a study of the philosophy of the natural or human sciences is irrelevant to researchers. They remark that the study of philosophy consists of learning about how theory after theory has been erected, only to be torn down by the subsequent one, and that it has little bearing on the day-to-day practice of research and only causes confusion. So why should you find it necessary to know something about philosophy as a background to your research? Because everyone is a philosopher – everyone has a concept of the world. In fact, the alternative to having a philosophy is not having no philosophy but having a bad philosophy. The ‘unphilosophical’ person has an unconscious philosophy, which they apply in their practice – whether of science or politics or daily life (Collier, 1994: 16).

All philosophical positions and their attendant methodologies, explicitly or implicitly, hold a view about reality. This view, in turn, will determine what can be regarded as legitimate knowledge. Philosophy works by making arguments explicit. You need to develop

sensitivity towards philosophical issues so that you can evaluate research critically. It will help you to discern the underlying, and perhaps contentious, assumptions upon which research reports are based even when these are not explicit, and thus enable you to judge the appropriateness of the methods that have been employed and the validity of the conclusions reached. Obviously, you will also have to consider these aspects in regard to your own research work. Your research, and how you carry it out, is deeply influenced by the theory or philosophy that underpins it.

There are different ways of going about doing research depending on your assumptions about what actually exists in reality and what we can know (metaphysics) and how we can acquire knowledge (epistemology).

## METAPHYSICS AND EPISTEMOLOGY

Metaphysics is concerned with questions such as what it is to be, who we are, what is knowledge, what are things, what is time and space. At one extreme there is:

- **Idealism**, that advocates that reality is all in the mind, that everything that exists is in some way dependent on the activity of the mind. Hence, as phenomena are reliant on mental and social factors they are therefore in a state of constant change e.g. music is not just sound, it is an emotional experience.

and at the other extreme is:

- **Materialism (or reductionism)**, that insists that only physical things and their interactions exist and that our minds and consciousness are wholly due to the active operation of materials. Hence, phenomena are independent of social factors and are therefore stable e.g. music is just vibrations in the air.

As you can imagine, these are opposite ends of a spectrum, with many intermediate positions being held that balance the importance of the mind and material things in different degrees.

**Epistemology** is the theory of knowledge, especially about its validation and the methods used. It deals with how we know things

and what we can regard as acceptable knowledge in a discipline. It is concerned with the reliability of our senses and the power of the mind. As for the methods of acquiring knowledge, there are two basic approaches:

- 1 **empiricism** – knowledge gained by sensory experience (using inductive reasoning);
- 2 **rationalism** – knowledge gained by reasoning (using deductive reasoning).

The relative merits of these approaches have been argued ever since the Ancient Greeks – Aristotle advocating the first and Plato the second.

## INDUCTIVE AND DEDUCTIVE REASONING

The reasoning behind the empirical and rationalist approaches to gaining knowledge also start from opposite ends of a spectrum. Although it is not possible to apply either extreme in a practical way, it is useful to characterize the distinct differences in the two opposing approaches. A more practical approach that goes a long way to overcome the shortcomings of each is the **hypothetico-deductive method**, which uses the features of each in a pragmatic way, in fact, the method used in much scientific enquiry and hence also called ‘**scientific method**’.

### INDUCTIVE REASONING – THE EMPIRICIST’S APPROACH

Inductive **reasoning** starts from specific observations or sensory experiences and then develops a general conclusion from them. This simple example gives an indication of the line of reasoning:

All the giraffes that I have seen (Repeated observations)  
 have very long necks.  
 Therefore I conclude that all (Conclusion)  
 giraffes have long necks.

**Induction** was the earliest and, even now, the commonest popular form of scientific activity. We use it every day in our normal lives as we learn from our surroundings and experiences. We come to conclusions from what we have experienced and then generalize from them, that is, set them up as a rule or belief. The Elizabethan philosopher



Francis Bacon stated that one should consult nature, and not rely on the writings of ancient philosophers such as Aristotle or on the Bible. The scientific revolution in the seventeenth century was based on this approach, led by such scientists as Galileo and Newton (remember the apple that fell on his head from the tree that led to his theory of gravity? Nice story anyway!). Mendel's discovery of genetics and Darwin's theory of evolution are perhaps the most famous generalizations in the form of theories that are, even by them, claimed to be developed through inductive reasoning.

However there are problems with induction. The first is the question of how many observations must be made before we can reasonably draw a conclusion that is reliable enough to generalize from; and the second is how many situations and under which conditions should the observations be made so that true conclusions can be reached? These problems do not stop us from using inductive reasoning every day quite successfully without even thinking about it. But we should be aware that what might at first seem obvious may not be so reliable with making further investigations.

Therefore, in order to be able to rely on the conclusions we come to by using inductive reasoning, we should ensure that we make a large number of observations, we repeat them under a large range of circumstances and conditions and that no observations contradict the generalization we have made from the repeated observations.

#### DEDUCTIVE REASONING – THE RATIONALIST'S APPROACH

Deductive reasoning begins with general statements (premises) and, through logical argument, comes to a specific conclusion. Again, a simple example will provide a guide to how this works:

All living things will eventually die.	(General statement – first premise)
This animal is a living thing.	(Inference – second premise)
Therefore, this animal will eventually die.	(Conclusion)

This is the simplest form of deductive argument, and is called a syllogism. As you can see it consists of a general statement (called the first premise),

followed a more specific statement inferred from this (the second premise), and then a conclusion which follows on logically from the two statements

**Deduction**, as with many philosophical ideas, was first discussed as a way of reasoning by the Ancient Greeks, in particular, Plato. Enquiry is guided by the theory which precedes it. Theories are speculative answers to perceived problems, and are tested by observation and experiment. Whilst it is possible to confirm the possible truth of a theory through observations which support it, theory can be falsified and totally rejected by making observations which are inconsistent with its statement. In this way, science is seen to proceed by trial and error: when one theory is rejected, another is proposed and tested, and thus the fittest theory survives.

In order for a theory to be tested, it must be expressed as a statement called a **hypothesis**. The essential nature of a hypothesis is that it must be falsifiable. This means that it must be logically possible to make true observational statements which conflict with the hypothesis, and thus can falsify it. However, the process of **falsification** leads to a devastating result of total rejection of a theory, requiring a completely new start.

Another problem with deductive reasoning is that the truth of the conclusions depends very much on the truth of the premise on which it is based. For example, in the past many conclusions about the movement of the planets were incorrect due to the premise that the earth was the centre of the universe.

## HYPOTHETICO-DEDUCTIVE REASONING OR SCIENTIFIC METHOD

The hypothetico-deductive method combines inductive and deductive reasoning, resulting in the to-and-fro process of:

- identification or clarification of a problem;
- developing a hypothesis (testable theory) inductively from observations;
- charting their implications by deduction;
- practical or theoretical testing of the hypothesis;
- rejecting or refining it in the light of the results.

It is this combination of experience with deductive and inductive reasoning which is the foundation of modern scientific research, and is commonly referred to as scientific method. It was only by the beginning of the 1960s that Popper (1902–92) formulated the idea of the hypothetico-deductive method, even though it must have been used in practice for decades before.

Of course there are many problems posed by the complexity of testing theories in real life. Realistic scientific theories consist of a combination of statements, each of which relies on assumptions based on previous theories. The methods of testing are likewise based on assumptions and influenced by surrounding conditions. If the predictions of the theory are not borne out in the results of the tests, it could be the underlying premises which are at fault rather than the theory itself.

There are certain assumptions that underlie scientific method that relate to a materialist view of metaphysics and a positivist view of epistemology. These assumptions are:

- **Order** – the universe is an ordered system that can be investigated and the underlying ‘rules’ can be exposed.
- **External reality** – we all share the same reality that does not depend on our existence. We can therefore all equally contribute to and share knowledge that reflects this reality.
- **Reliability** – we can rely on our senses and reasoning to produce facts that reliably interpret reality.
- **Parsimony** – the simpler the explanation the better. Theories should be refined to the most compact formulation .
- **Generality** – the ‘rules’ of reality discovered through research can be applied in all relevant situations regardless of time and place.

However, these assumptions are not accepted by the opposite camp in metaphysics and epistemology. Those with an idealist and relativist point of view insist on the importance of human subjectivity and the social dimension to facts and their meanings. This clash of viewpoints is unlikely ever to be resolved.

A brief review of history will show that this quest for what is reality and what are facts is a constant preoccupation in the enquiry into our relation to existence.

## POSITIVISM, RELATIVISM, POSTMODERNISM AND CRITICAL REALISM

There is an important issue that confronts the study of the social sciences that is not so pertinent in the natural sciences. This is the question of the position of the human subject and researcher, and the status of social phenomena. Is human society subjected to **laws** that exist independent of the human actors that make up society, or do individuals and groups create their own versions of social forces? As briefly mentioned above, the two extremes of approach are termed **positivism** and **interpretivism**. Again, as in the case of ways of reasoning, a middle way has also been formulated that draws on the useful characteristics of both approaches.

### POSITIVISM

The positivist approach to scientific investigation is based on acceptance as fact that the world around us is real, and that we can find out about these realities. There is an order made up of atomistic, discrete and observable events. Knowledge is derived using scientific method and based on sensory experience gained through experiments or comparative analysis. It aims at developing a unique and elegant description of any chosen aspect of the world that is true regardless of what people think. By developing these scientific facts, knowledge is built up in a cumulative fashion, despite some false starts. Science builds on what is already known, for example, even Einstein's radical theories are a development from Newton's.

The approach to knowledge is reductionist in character, by maintaining that less measurable sciences are reducible to more measurable ones. Sociology is reducible to psychology, psychology to biology, biology to chemistry, and chemistry to physics. Social sciences can therefore be value free and objective.

### RELATIVISM (ALSO CALLED INTERPRETIVISM, IDEALISM, CONSTRUCTIVISM OR EVEN CONSTRUCTIONISM)

The alternative approach to research – **relativism** – is based on the philosophical doctrines of idealism and humanism. It maintains that the view of the world that we see around us is the creation of the

mind. This does not mean that the world is not real, but rather that we can only experience it personally through our perceptions which are influenced by our preconceptions, beliefs and values; we are not neutral, disembodied observers but part of society. Unlike the natural sciences, the researcher is not observing phenomena from outside the system, but is inextricably bound into the human situation which he/she is studying. As well as concentrating on the search for constants in human behaviour which highlights the repetitive, predictable and invariant aspect of society the researcher does not ignore what is subjective, individual and creative – facts and values cannot be separated. The researcher encounters a world already interpreted and his/her job is to reveal this according to the meanings created by humans rather than to discover universal laws. Therefore there can be more than one perspective and interpretation of a phenomenon.

Table 2.1 compares the alternative bases for interpreting the world. Table Just because the differences of perspective between positivist and relativist approaches are so radical, don't think that you need to espouse purely one or the other approach. Different aspects of life lend themselves to different methods of interpretation.

#### POSTMODERNISM

**Postmodernism** challenges key issues such as meaning, knowledge and truth which have opened up new perspectives and ideas about the essence of research. It denounces the meta-narratives (all embracing theories) of the modern movement as a product of the Enlightenment, and insists on the inseparable links between knowledge and power. In fact, there is no universal knowledge or truth. Science is just a construct and only one of many types of knowledge that are all subjects of continual reinvention and change.

It is a complex combination of ideas that emerged in a fragmented fashion at the end of the nineteenth century but became highly developed by French social theorists such as Saussure, Barthes, Derrida, Foucault, Baudrillard and Leotard in the latter part of the twentieth century.

One of the strands of postmodernism examines the structure of language and how it is used. It challenges the assumption that language can be precisely used to represent reality. Meanings of words are ambiguous, as words are only signs or labels given to concepts (what is signified) and therefore there is no necessary correspondence between the word and the meaning, the signifier and the signified. The use of signs (words) and their meanings can vary depending on

the flow of the text in which they are used, leading to the possibility of 'deconstructing' text to reveal its underlying inconsistencies. This approach can be applied to all forms representation – pictures, films etc. that gain added or alternative meanings by the overlaying of references to previous uses. This can be seen particularly in the media where it is difficult to distinguish the real from the unreal – everything is representation, there is no reality.

In another strand of postmodernism, Foucault maintained that representations of knowledge are developed through types of discourse – discussions that are framed by the current accepted norms of institutions that are in positions of power within the intellectual establishment; such as universities, government bodies and funding institutions. In this way, scientific enquiry and the application of the knowledge gained by it, rather than being freely conducted, are channelled towards supporting the interests of these institutions. Science is now a sort of game bound up with money, power and technology instead of being a simple search for truths.

These attitudes imply that the grand, monolithic structure of science and knowledge built up over the centuries, the striving after facts and laws that represent universal truths, and the steady progress towards greater understanding of the world and control of it through technology, is an impossible mission. Enquiry must be broken down into much smaller, localized and limited explanations, stressing different influences, ideologies and identities and the overwhelming complexity of our existence. There can be no over-arching theories and no universal truths – all is relative(see Table 2.2).

#### CRITICAL REALISM

Inevitably, there has been a reaction to this postmodernist challenge to traditional science which threatens a descent into chaos and powerlessness to act because of lack of possibility of agreement on truths and reality. This has been labelled **critical reality** based on critical reasoning.

Critical reasoning can be seen as a reconciliatory approach, which recognizes, like the positivists, the existence of a natural order in social events and discourse, but claims that this order cannot be detected by merely observing a pattern of events. The underlying order must be discovered through the process of **interpretation** while doing theoretical and practical work particularly in the social sciences. Unlike the positivists, critical realists do not claim that there

is a direct link between the concepts they develop and the observable phenomena. Concepts and theories about social events are developed on the basis of their observable effects, and interpreted in such a way that they can be understood and acted upon, even if the interpretation is open to revision as understanding grows. This also distinguishes critical realists from relativists, who deny the existence of such general structures divorced from the specific event or situation and the context of the research and researcher.

## KEY FIGURES

To summarize the above, here is a short guide to some key figures that have influenced thinking about research.

**Plato (427–347 BC) and Aristotle (348–322 BC)** – these represent the two contrasting approaches to acquiring knowledge and understanding the world (epistemology). Plato argued for deductive thinking (starting with theory to make sense of what we observe) and Aristotle for the opposite, inductive thinking (starting with observations in order to build theories).



**René Descartes (1596–1650)** – provided the starting point for modern philosophy by using a method of systematic doubt; that we cannot rely on our senses or logic, and therefore he challenged all who sought for the basis of certainty and knowledge. His famous maxim is ‘I think, therefore I am’, that is – I can only be sure of my own existence, the rest must be doubted.

**John Locke (1632–1704)** – made the distinction between bodies or objects that can be directly measured, and therefore have a physical existence, and those abstract qualities that are generated by our perceptions and feelings.

**George Berkeley (1685–1753)** – argued that all things that exist are only mental phenomena. They exist by being perceived. This is ‘our’ world.

**David Hume (1711–1776)** – made a distinction between systems of ideas that can provide certainty – e.g. maths – and those that rely on our perceptions (empirical evidence) which are not certain. He recognized the importance of inductive thinking in the advancement of scientific knowledge, but highlighted its restrictions in finding the truth.

**Immanuel Kant (1724–1804)** – held that our minds organize our experiences to make sense of the world. Therefore ‘facts’ are not independent of the way we see things and interpret them.

**Karl Popper (1902–1994)** – formulated a combination of deductive and inductive thinking in the hypothetico-deductive method, commonly known as scientific method. This method aims to refine theories to get closer to the truth.

**Auguste Comte (1789–1857)** – maintained that society can be analysed empirically just like any other subjects of scientific enquiry. Social laws and theories are based on psychology and biology.

**Karl Marx (1818–1883)** – defined moral and social aspects of humanity in terms of material forces.

**Emil Durkheim (1858–1917)** – argued that society develops its own system of collectively shared norms and beliefs – these were ‘social facts’.

**Max Weber (1864–1920)** – insisted that we need to understand the values and meanings of subjects without making judgements – ‘*verstehen*’ was the term he coined for this which is German for ‘understanding’.

**Thomas Kuhn (1922–1995)** – revealed that scientific research cannot be separated from human influences and is subject to social norms.

**Michel Foucault (1926–1984)** – argued that there was no progress in science, only changing perspectives, as the practice of science is shown to control what is permitted to count as knowledge. He demonstrated how discourse is used to make social regulation and control appear natural.

**Jacques Derrida (1930–2004)** – stated that there is no external or fixed meaning to text, nor is there a subject who exists prior to language and to particular experiences. You cannot get outside or beyond the structure. This approach led to the movement called Deconstruction.

## WHERE TO FIND OUT MORE

There is much written about the philosophy of knowledge and research and it is advisable to have a good general knowledge of the debate about the philosophy of scientific knowledge and its detractors, in order to place your research within the philosophical context. When compiling this chapter, I found the following books useful and well worth a browse. The titles give an indication of the subject tackled. I have put the more approachable ones first.

## STRUCTURING THE RESEARCH PROJECT

Research projects are set up in order to explain a phenomenon or to test a theory. Research methods are the practical techniques used to carry out research. They are the 'tools of the trade' that make it possible to collect information and to analyse it. What information you collect and how you analyse it depends on the nature of the **research problem**, the central generating point of a research project. Hence the need for total clarity in defining the problem and limiting its scope in order to enable a practical research project with defined outcomes to be devised.

Mostly, research methods courses at undergraduate and more advanced levels culminate, not in an exam, but in a research project or dissertation where you can demonstrate how you have understood the process of research and how various research methods are applied. Hence the need to be clear about the process as a whole so that the methods can be seen within the context of a project.

### THE RESEARCH PROCESS

It is necessary to first define some kind of research problem in order to provide a reason for doing the research. The problem will generate the subject of the research, its aims and objectives, and will indicate what sort

of data need to be collected in order to investigate the issues raised and what kind of analysis is suitable to enable you to come to conclusions that provide answers to the questions raised in the problem.

This process is common to virtually all research projects, whatever their size and complexity. And they can be very different. These differences are due to their subject matters; for example compare an investigation into sub-nuclear particles with a study of different teaching methods, differences in scales of time and resources, and extent of pioneering qualities and rigour. Some projects are aimed at testing and refining existing knowledge, others at creating new knowledge.

The answers to four important questions underpin the framework of any research project:

- What are you going to do? The subject of your research.
- Why are you going to do it? The reason for this research being necessary or interesting.
- How are you going to do it? The research methods that you will use to carry out the project.
- When are you going to do it? The programme of the work.

The answers to these questions will provide a framework for the actual doing of the research. The answers to these questions are not simple. This book has been written to give you an indication of what is involved in answering these questions.

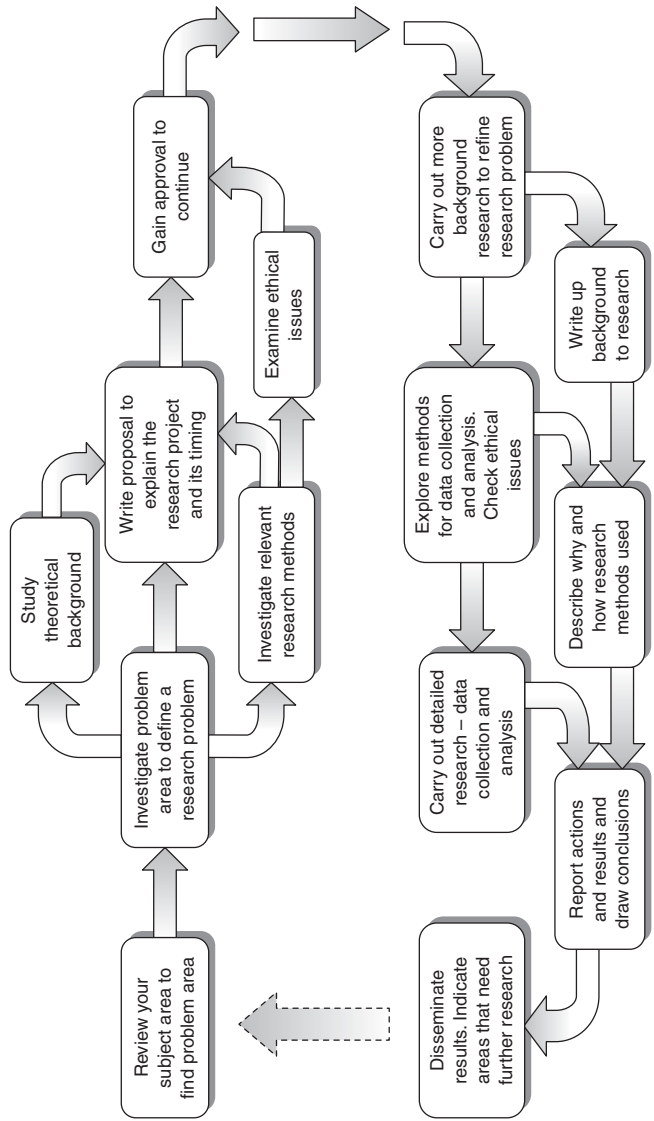


Figure 3.1 Structure of a typical research project

Figure 3.1 shows the structure of a typical research project. This shows a rather linear sequence of tasks which is far tidier than what happens in reality. As knowledge and understanding increases during the course of the project, it is subject to constant reiteration. However, a diagram is useful in order to explain the main order of the different stages in the research, and can be used in order to plan out a programme of work in the form of a timetable. The progress of the project can then be gauged by comparing the current stage of work with the steps in the process.

## THE RESEARCH PROBLEM

There is no shortage of problems throughout the world, but for a problem to be researchable, it needs to have several crucial features. It must be:

- stated clearly and concisely;
- significant i.e. not trivial or a repeat of previous work;
- delineated, in order to limit its scope to practical investigation;
- possible to obtain the information required to explore the problem;
- possible to draw conclusions related to the problem, as the point of research is to find some answers.

A research problem can be based on a question, an unresolved controversy, a gap in knowledge or an unrequited need within the chosen subject. An awareness of current issues in the subject and an inquisitive and questioning mind and an ability to express yourself clearly is required in order to find and formulate a problem that is suitable for a research project.

Initially, it is useful to define no more than a problem area within the general body of knowledge or subject, rather than a specific research problem, e.g. school truancy, energy saving in buildings, homecare for the elderly etc. Then, by examining the different aspects of the problem area, you can hone in on an aspect that is of particular interest to you, is controversial, or is of particular significance. Then a rationale for the research problem can be defined. This can be done, for example, by raising a question, defining some research objectives or formulating a hypothesis.

## DEFINING THE RESEARCH PROBLEM

Here are several forms in which the research problem can be expressed to indicate the method of investigation.

### QUESTION OR QUESTIONS

Probably the simplest way to set up a research problem is to ask a question. This might be quite abstract in nature, so will require to be broken down into several sub-questions that can be practically investigated. The nice thing about questions is that they demand answers – a good incentive to do some research! Here is an example of a research problem expressed as a main question:

Main question: Are school exam results a true test of a student's intelligence?

Questions can then be used to break the main problem down into questions to define sub-problems. The different things you can do to split up the main question are to:

- Split it down into different aspects that can be investigated separately, e.g. political, economic, cultural, technical.
- Explore different personal or group perspectives, e.g. employers, employees.
- Investigate different concepts used, e.g. health, wealth, confidence, sustainability.
- Consider the question at different scales, e.g. the individual, group, organization.
- Compare the outcomes of different aspects from the above ways of splitting down.

In this case the sub-questions could concentrate on:

- What constitutes intelligence? (Investigating a concept, i.e. 'intelligence'.)
- What ways of testing intelligence are there? (Exploring different perspectives – i.e. other intelligence tests, and thus investigating the concept 'test'.)
- What sort of school exams are there and how are they marked? (Investigating another concept – i.e. 'exams'.)
- How do school exam criteria match those of the criteria of other intelligence tests? (Split into aspects – in this case, criteria of exams and other intelligence tests.)

Note how all the sub-questions relate directly to the main question and break down the rather abstract question into practical questions that can be investigated individually and build up to an answer to the main question. For smaller scale studies, an exploratory approach may be used. The subject and scope of the exploration can be expressed in a statement of intent. Again, this must be derived from the research problem, imply a method of approach and indicate the outcome. An example of this form of research definition is:



This study examines the problem of career development of women engineers in the automotive industry in Britain. It focuses on the identification of specific barriers (established conventions, prejudices, procedures, career paths) and explores the effectiveness of specific initiatives that have been aimed at breaking down these barriers.

Note how the problem, in this case of career development, is narrowly delimited in order to put a boundary around the scope of the work, for example only women engineers, only in the automotive industry, and only in Britain. It also lists the practical tasks to be carried out, i.e. identification of specific barriers, and exploration of initiatives. This list of barriers stipulates in more detail the actual subjects of the investigation.

#### HYPOTHESES

The research problem in research projects that use the hypothetico-deductive method is expressed in terms of the testing of a particular hypothesis.

Hypotheses are nothing unusual; we make them all the time. If something happens in our everyday life, we tend to suggest a reason for its occurrence by making rational guesses. These reasonable guesses can be expressed in the form of **statement**. This is a hypothesis. If, on further examination, a particular hypothesis is found to be supported, i.e. the reasons for its occurrence seem to be correct, we have got a good chance that we can predict what will happen in the same situation in the future, or can devise actions to prevent it happening again. If the investigation shows that the guess was wrong, then it can be rejected as false. Many of the greatest discoveries in science were based on hypotheses: Newton's theory of gravity, Einstein's general theory of relativity and a host of others.

A good hypothesis is a very useful aid to organizing the research effort, but it must have certain qualities. It must be a statement that can be put to the test. It must specifically limit the enquiry to the interaction of certain factors (usually called variables) and suggest the methods appropriate for collecting, analysing and interpreting the data, and the resultant confirmation or rejection of the hypothesis through empirical or experimental testing must give a clear indication of the extent of knowledge gained.

So, to express the above example of a research question in the form of a hypothesis it would need to be written simply like this as a statement:

School exam results are a true test of a student's intelligence.

The formulation of the hypothesis is usually made on an abstract or conceptual level in order to enable the results of the research to be generalized beyond the specific conditions of the particular study. However, one of the fundamental criteria of a hypothesis that it is testable but formulated on a conceptual level cannot be directly tested; it is too abstract. It is therefore necessary to convert it to an operational level. This is called **operationalization**.

Often, the first step is to break down the main hypothesis into two or more sub-hypotheses. These represent components or aspects of the main hypothesis and together should add up to its totality. Each sub-hypothesis will intimate a different method of testing and therefore implies different research methods that might be appropriate. This is a similar process to breaking down main research questions into sub-questions. For example:

The intelligence of students can be measured.

Tests have been devised to accurately measure levels of intelligence.

School exams contain suitable tests to measure students' intelligence.

The accuracy of school exams to test intelligence is commensurate with specially devised intelligence tests.

The operationalization of the sub-hypotheses follows four steps in the progression from the most abstract to the most concrete expressions by defining concepts, indicators, variables and values. These are described in more detail in Chapter 6.

## PROPOSITIONS

Focusing a research study on a set of **propositions**, rather than on a hypothesis, allows the study to concentrate on particular relationships between events, without having to comply with the rigorous characteristics required of hypotheses. The first proposition is a statement of a particular situation, which is then followed with further

propositions that point out factors or events that are related to it and ending with one that indicates a conclusion that could be drawn from these interrelationships. An example will help explain this.

The main research problem was formulated in the form of three interrelated propositions:

- Specifically designed public sector housing provided for disabled people continues to be designed according to the government recommendations and standards for disabled people's housing.
- The recommendations and standards are not based on an accurate perception of the needs of disabled people.
- Therefore there is a mismatch between the specifically designed public sector housing provided for disabled people and their accommodation requirements.

In this example it is clear that the research must investigate what the actual accommodation requirements of disabled people are, what the government perception of their needs is, and how they compare.

## THE USE OF ARGUMENT

The whole point of doing a research project is to identify a particular question or problem, to collect information and to present some answers or solutions. In order to convince the reader that you have collected information relevant to the question or problem and that you have based your answers and conclusions on the correct analysis of this information you will need to use some logical **argument**.

You might want to defend or challenge a particular point of view or propose a new or improved one. You will have to play the part of a detective making a case in court. The detective will set out to solve the problem (who committed the crime and how?) by analysing the situation (the scene and events of the crime, the possible suspects), collecting and reviewing the evidence, then making a case for his/her conclusions about 'who-done-it' and how. The jury will have to decide whether the argument is convincing and that the evidence is sufficiently strong. In the case of a research project, you will be setting the problem and laying out your case, and the reader of your report, dissertation or thesis will be your jury.

As mentioned in the previous chapter, there are two basic stages to an argument: the **premises**, which are statements in the form of propositions or assertions which form the basis of the argument (this can be seen as the evidence) and the **conclusion**, which is a proposition that expresses the inference drawn by logical steps from the original premises.

Arguments are based on logical reasoning of which, as explained in the previous chapter, there are two basic types: inductive reasoning, which entails moving from particular repeated observations to a general conclusion, and deductive reasoning, which entails going from a general principal (called a premise) to a conclusion about a particular case. The hypothetico-deductive method or scientific method is a further development of logical reasoning based on the principle that we can never be completely sure of any premises or conclusions that we make, but we can be more confident about some than others. The more a premise or a conclusion has been tested and supported by repeated investigations, the more likely it is to be true. Also, conclusions can be refined if they are only seen to be true in particular situations. All scientific facts, such as the theory of gravity, are based on this approach.

It is important to be aware of the type of reasoning that you will use to make your argument, or if you are reading through the research literature, what type of reasoning is used by each of the writers. Of course, it is not always easy to detect the simple steps of the argument as described above, so it is worth knowing what to look out for when doing your background reading. There are also pitfalls that can occur to weaken or even invalidate the value of an argument, however persuasive it might seem at first reading.

#### RECOGNIZING AND TESTING ARGUMENTS

As well as constructing arguments to support your research conclusions, it is also necessary to recognize and scrutinize other people's arguments, particularly those on whose work you are basing your research.

#### RECOGNIZING ARGUMENTS

In many types of writing and other forms of discourse, e.g. conversation, TV programmes, speeches, etc., the argument may be poorly expressed

or submerged within the content. In order to recognize when an argument is being made, look for words that indicate a premise such as:

- since
- because
- if
- assuming that
- given that, etc.

Then look for words that indicate that a conclusion follows, such as:

- therefore
- this proves that
- then
- consequently
- thus, etc.

Then look for any logical reasoning and evidence that is given to link the two.

#### *TESTING ARGUMENTS*

There are techniques that can be used to detect the valid from the fallacious arguments, i.e. those whose logic follows the correct rules and those that do not. Fallacies fall into two main categories: formal and informal.

**Formal fallacies** are those where the logical structure underpinning the argument is faulty in some way. There are many ways that logical structures can be faulty, too many to consider here, but for one example, consider the following simple argument:

No lawyers are criminals.  
John is not a lawyer.  
Therefore, John is a criminal.

This makes a hidden assumption that all people who are not lawyers are criminals. This is not one of the premises. If a first line was added that went 'All non-lawyers are criminals' then the logic of the argument

and its conclusion would be sound, despite the preposterous premises. Just like with computer programs: rubbish in – rubbish out!

**Informal fallacies** also come in many guises. These are misleading not so much because the logical steps are incorrect, but they make false analogies, use emotional and misleading claims, and jump to unjustified conclusions on evidence that is skimpy, irrelevant or untrue. The following example makes false analogies:

The ship of government, like any ship, works best when there is a strong captain in charge of it. That is why government by dictatorship is more effective.

Is a ship really sufficiently like a government to make this claim?

#### CONSTRUCTING AN ARGUMENT

Although Bonnett provides a choice of six types of argument (2001: 9), I reckon that there are only two basic aims of argumentation. One is to argue for a statement by providing evidence that will support it. The other is to refute a statement by providing evidence that undermines it. Between these opposites can be a combination of the two, which entails a less black and white approach by arguing for a revision or refinement of the statement to get nearer to the truth, again based on the evidence presented. Another combination compares two statements, usually stating the opposite, and argues that one is right and the other is wrong.

To argue in support of a concluding statement, you need to demonstrate that the premises are true. This may not be straightforward as truth is often difficult to pin down. Evidence in the form of data confirmation or agreement amongst experts will help to substantiate the strength of your claim. In research, evidence will often be new data generated by the project, so the reliability of sources and the methods of data collection must be clearly explained and justified. You then must employ a sound logical progression of steps to bring you to the conclusions. The conclusions must be based exclusively on the premises. If it is not possible to be absolutely certain that the conclusions are inevitable, you have the option to soften the concluding statement with conditions such as 'it is likely that', 'it is probable that' etc.

To refute a concluding statement requires you to show that the conclusion is false or untrue. This can be done by challenging the logic of the argument, challenging the truth of evidence on which the argument is based, or questioning the relevance or completeness of the evidence. Another way to challenge an argument is to produce counter-examples that are deployed against either the premises or/and conclusions. This will undermine the universality of the argument i.e. demonstrating that it does not hold in all cases. Alternatively, you might be able to demonstrate that the conclusions drawn will lead to absurdity if taken far enough.

Constructing an argument and coming to conclusions about a research project is a cumulative process. It is unlikely that the chosen problem is simple, with questions raised that can be answered with a simple yes or no. Even if they can, you will be required to describe why it is one or the other and make an argument to support your case. Normally, the problem is divided down into smaller components requiring separate investigations. Conclusions about these components will occur in various sections of the analysis part of the report or dissertation. Skill is then required to gather these up at the end in the concluding section to fit them together into a 'mosaic' that will present the complete picture of the conclusion to the main problem.

## WHERE TO FIND OUT MORE

You can quickly get into deep water on the subject of thinking and argument. I would recommend Brink-Budgen or Bonnett to start with, and perhaps follow up the references in there if you want to find out more on specific issues. The others I have listed require you to have either a special interest or that you have chosen a topic that focuses on aspects of these subjects.

## RESEARCH ETHICS

Research, however novel its discoveries, is only of any value if it is carried out honestly. We cannot trust the results of a research project if we suspect that the researchers have not acted with integrity. Although it might be easy enough to take short cuts or even to cheat, it really is not worth it. Not only will your research be discredited when you are found out, but you will suffer severe penalties and humiliation.

It is a simple matter to follow the clear guidelines in citation that will prevent you being accused of passing off other people's work as your own – called plagiarism. In fact, to refer to or quote other people's work is seen as a virtue, and demonstrates that you have read widely about your subject and are knowledgeable about the most important people and their ideas.

Working with human participants in your research always raises **ethical** issues about how you treat them. People should be treated with respect, which has many implications for how exactly how you deal with them before, during and after the research. Educational and professional organizations who oversee research projects have strict ethical guidelines that must be followed. However, the issues can become quite complicated, with no clear-cut solutions. It is therefore important that you consult with others, especially advisers appointed for that purpose.

Even if you are not using human participants in your research, there is still the question of honesty in the way you collect, analyse and interpret data. By explaining exactly how you arrived at your conclusions you can avoid accusations of cover-ups or false reasoning.

There are two aspects of ethical issues in research:

- 1 The individual values of the researcher relating to honesty and frankness and personal integrity.
- 2 The researcher's treatment of other people involved in the research, relating to informed consent, confidentiality, anonymity and courtesy.

Although the principles underpinning ethical practice are fairly straightforward and easy to understand, their application can be quite difficult in certain situations. Not all decisions can be clear-cut in the realm of human relations.

#### ORGANIZATIONS AND ETHICS COMMITTEES

All organizations that are involved in research involving human participants have set up a code of practice for their researchers. To see typical examples of these types of guidelines, you can refer to the web page produced by the British Educational Research Association ([www.bera.ac.uk/guidelines.htm](http://www.bera.ac.uk/guidelines.htm)) or the British Sociological Association statement of ethical practice ([www.britisoc.co.uk/index](http://www.britisoc.co.uk/index)). Universities will have their own codes of practice.

The role of ethics committees is to oversee the research carried out in their organizations in relation to ethical issues. It is they who formulate the research ethics code of conduct and monitor its application in the research carried out by members of their organizations. Applying for ethics approval inevitably involves filling in forms.

#### HONESTY IN YOUR WORK

Honesty is essential, not only to enable straightforward, above-board communication, but to engender a level of trust and credibility in the outcomes of the research. This applies to all researchers, no matter what subject they are investigating. Although honesty must be

maintained in all aspects of the research work, it is worth focusing here on several of the most important issues.

#### INTELLECTUAL OWNERSHIP AND PLAGIARISM

Unless otherwise stated, what you write will be regarded as your own work; the ideas will be considered your own unless you say to the contrary. The worst offence against honesty in this respect is called **plagiarism**: directly copying someone else's work into your report, thesis etc. and letting it be assumed that it is your own. Using the thoughts, ideas and works of others without acknowledging their source, even if you paraphrased into your own words, is unethical. Equally serious is claiming sole authorship of work which is in fact the result of collaboration or amanuensis ('ghosting').

#### ACKNOWLEDGEMENT AND CITATION

Obviously, in no field of research can you rely entirely on your own ideas, concepts and theories. You can avoid accusations of plagiarism by acknowledging the sources of these features and their originators within your own text. This is called **citation**. Although there are several well established citation methods, they all consist of brief annotations or numbers placed within the text that identify the cited material, and a list of references at the end of the text that give the full publication details of the source material. These methods of reference cater for direct quotations or ideas etc. from the work of others gathered from a wide variety of sources (such as books, journals, conferences, talks, interviews, TV programmes etc.), and should be meticulously used. You should also indicate the assistance of others and any collaboration with others, usually in the form of a written acknowledgement at the beginning or end of the report.

#### RESPONSIBILITY AND ACCOUNTABILITY OF THE RESEARCHER

Apart from correct attribution, honesty is essential in the substance of what you write. You do have responsibilities to fellow researchers, respondents, the public and the academic community. Accurate descriptions are required of what you have done, how you have done it, the information you obtained, the techniques you used, the analysis

you carried out, and the results of experiments – a myriad of details concerning every part of your work.

#### DATA AND INTERPRETATIONS

Although it is difficult, and some maintain that it is impossible, to be free from bias, distorting your data or results knowingly is a serious lapse of honesty. Scientific objectivity should be maintained as much as possible. If you can see any reason for a possibility of bias in any aspect of the research, it should be acknowledged and explained. If the study involves personal judgements and assessments, the basis for these should be given. Silently rejecting or ignoring evidence which happens to be contrary to one's beliefs, or being too selective in the data used and in presenting the results of the analysis constitutes a breach of integrity.

The sources of financial support for the research activities should be mentioned, and pressure and sponsorship from sources which might influence the impartiality of the research outcomes should be avoided.

#### WHERE DO YOU STAND?

The theoretical perspective, or epistemology, of the researcher should be made clear at the outset of the research so that the 'ground rules' or assumptions that underpin the research can be understood by the readers, and in some instances, the subjects of the research. One of the principal functions of doing background research is to explore just this aspect, and to come to decisions on theory that will form the basis of your research approach. The theoretical approach will influence the type of data collection and analysis used. These methods are not ethically neutral so they will raise ethical issues.

#### SITUATIONS THAT RAISE ETHICAL ISSUES

Social research, and other forms of research which study people and their relationships to each other and to the world, need to be particularly sensitive about issues of ethical behaviour. As this kind of research often impinges on the sensibilities and rights of other

people, researchers must be aware of necessary ethical standards which should be observed to avoid any harm which might be caused by carrying out or publishing the results of the research project.

#### RESEARCH AIMS

Although research aimed merely at gaining greater knowledge and understanding of a phenomenon has little or no ethical consequences – the expansion of scientific knowledge is generally regarded as a good thing – applied research is more easily subjected to ethical investigation. Will the results of the research benefit society, or at least not harm it? Will there be losers as well as gainers? The research aims and their consequences must be clearly stated. Normally you will have to argue that the aims of your research are in accordance with the ethical standards prescribed by your university or organization.

#### USE OF LANGUAGE

How you use language has an important influence when doing and writing up research. You should aim to be as neutral as possible in the way you use terminology involving people – who and what they are, and what they do. Guard against being patronizing or disparaging, and avoid bias, stereotyping, discrimination, prejudice, intolerance and discrimination. You will notice that acceptable terminology changes with time, so be aware that terms used in some older literature are not suitable for use now. You need to be constantly aware of the real meaning of terms, and their use within the particular context.

#### PRESENTATION

This relates to how you present yourself in the role of the researcher which might influence the attitude and expectations of the people you involve in your project. Student-researchers should present themselves as just that, and give the correct impression that they are doing the research as an academic exercise which does not have the institutional or political backing to cause immediate action. Practitioner researchers, such as teachers, nurses or social workers, have a professional status that lends more authority and possibly power to instigate change. Do not raise false expectations.

The research situation can also be influential. Stopping people in the street and asking a few standardized questions will not raise any expectations about actions, but if you spend a lot of time with a, perhaps lonely, old person delving into her personal history, the more intimate situation might give rise to a more personal relationship that could go beyond the simple research context. Even more expectations can be raised if you are working in a context of deprivation or inequality – will the subjects begin to expect you to do something to improve their situation?

#### DEALING WITH PARTICIPANTS

You should treat participants with due ethical consideration, in the way you choose them, deal with them personally and how you use the information they provide. In many cases, participants choose freely whether to take part in a survey by simply responding to the form or not. However, friends or relatives may feel that they have an obligation to help you despite reservations they may have and could result in a restriction of their freedom to refuse. Pressure might be exerted on participants if they are left too little time for due consideration which might also result in them regretting taking part. Obviously, you should avoid dishonest means of persuasion, such as posing as an official, making unrealistic and untrue promises, being unduly persistent, and targeting people in vulnerable situations. This could occur almost inadvertently if you are not alert to people's situations and reactions.

Participants will decide whether to take part according to the information they receive about the research. The form that this information takes will depend on the type of person, the nature of the research process and the context. It should be clear and easily understood so they can make a fair assessment of the project in order to give an **informed consent**. Particular attention is needed when getting consent from vulnerable people such as children, the elderly or ill, foreign language speakers and those who are illiterate.

When working within organizations, managers or other people with overall responsibilities may need to be consulted, with the result that several layers of consent will be required. Make it clear and get agreement at all levels about what issues are to be discussed, how the investigation will be conducted, how confidentiality will be

maintained. Be aware that there may be conflicts of interest between the management and employees so there must be some obvious form of protection for those making criticisms of the organization or systems of work or conditions.

Although verbal explanations may be sufficient in informal situations, a written résumé on a flyer could be useful. Questionnaires should always provide the necessary written information as an introduction. Participants must have the right to terminate their participation at any time.

## CARRYING OUT THE RESEARCH

### POTENTIAL HARM AND GAIN

The principle behind ethical research is to cause no harm and, if possible, to produce some gain for the participants in the project and the wider field. Therefore the researcher should assess the potential of the chosen research methods and their outcomes for causing harm or gain. This involves recognizing what the risks might be and choosing methods that minimize these risks, and avoiding making any revelations that could in any way be harmful to the reputation, dignity or privacy of the subjects.

### RECORDING DATA

There is a danger of simplifying transcripts when writing up data from interviews and open questions. When you clean up and organize the data, you can start to impose your own interpretation, ignoring vocal inflections, repetitions, asides, and subtleties of humour, thereby losing some the meanings. Further distortion can be introduced by being governed by one's own particular assumptions.

### PARTICIPANT INVOLVEMENT

Questions about rapport are raised if your research entails close communication between you, the researcher, and the participants. Will those involved understand the motivation for your actions and do these conform to your own practice? You should not take familiarity

so far as to deceive in order to extract information that the participant might later regret giving. Neither should you raise unrealistic expectations in order to ingratiate yourself.

#### SENSITIVE MATERIAL

Information can be thrown up that is of a sensitive nature which, if revealed, could do damage to the participants or to other people. Every case will have to be judged individually, but if this information is relevant to the research, it must be presented in such a way that individuals are not damaged by assuring confidentiality and anonymity. In cases of, for example, unfairness, victimization or bullying, it is unwise to get personally involved, but it may be possible to give advice to the participant about who to contact for help, such as a school tutor, trade union or ombudsman.

#### HONESTY, DECEPTION AND COVERT METHODS

Honesty is a basic tenet of ethically sound research so any type of deception and use of covert methods should be ruled out. Although you might argue that certain information of benefit to society can only be gained by these methods due to obstruction by people or organizations that are not willing to risk being scrutinized, how can you be sure of the benign consequences of the actions? The risks involved make the use of deception and covert methods extremely questionable, and in some cases even dangerous.

#### STORING AND TRANSMITTING DATA

The Data Protection Act 1998 in the UK and equivalent regulations elsewhere cover the conditions regarding collections of personal data in whatever form and at whatever scale. They spell out the rights of the subjects and responsibilities of the compilers and holders of the data. The data that you have collected may well contain confidential details about people and/or organizations. It is therefore important to devise a storage system that is safe and only accessible to you. If you need to transmit data, take measures that the method of transmission is secure and not open to unauthorized access.



### CHECKING DATA AND DRAFTS

It is appropriate to pass the drafts of your research report on to colleagues or supervisors for comment, but only with the proviso that the content is kept confidential, particularly as it is not ready for publication and dissemination at this stage. The intellectual independence of the findings of the report could be undermined if you allow sponsors to make comments on a draft and they demand changes to be made to conclusions that are contrary to their interests. It is not practical to let respondents read and edit large amounts of primary data.

### DISSEMINATION

Dissemination of your results in the form of conference or journal papers, a website or other types of publication inevitably involves reducing the length of the material, and perhaps changing the style of the writing. You must therefore be careful that the publication remains true to the original and avoid oversimplification, bias towards particular results or even sensationalization.

### DISPOSING OF RECORDS

A suitable time and method should be decided for disposing of the records at the end of the research project. Ideally, the matter will have been agreed with the participants as a part of their informed consent, so the decision will have been made much earlier. The basic policy is to ensure that all the data is anonymous and non-attributable. This can be done by removing all labels and titles that could lead to identification. Better still, data should be disposed of in such a way as to be completely indecipherable. This might entail shredding documents, formatting discs and erasing tapes.

### WHERE TO FIND OUT MORE

Although ethical behaviour should underlie all academic work, it is in the social sciences (as well as medicine etc.) that the really difficult issues arise. Researching people and society raises many ethical questions that are discussed in the books below. The first set of books are aimed generally at student and professional researchers, the second set

are examples of more specialized books – though the issues remain much the same for whoever is doing research involving human participants.

Oliver, P. (2003) *The Student's Guide to Research Ethics*. Maidenhead: Open University Press.

This is an excellent review of the subject, going into detail on all aspects of ethics in research, and providing useful examples of situations where ethical questions are raised. It demonstrates that there are not always simple answers to these questions, but suggests precautions that can be taken to avoid transgressions.

Laine, M. de. (2000) *Fieldwork, Participation and Practice: Ethics and Dilemmas in Qualitative Research*. London: Sage.

The main purposes of this book are to promote an understanding of the harmful possibilities of fieldwork; and to provide ways of dealing with ethical problems and dilemmas. Examples of actual fieldwork are provided that address ethical problems and dilemmas, and show ways of dealing with them.

Mauthner, M. (ed.) (2002) *Ethics in Qualitative Research*. London: Sage.

This book explores ethical issues in research from a range of angles, including: access and informed consent, negotiating participation, rapport, the intentions of feminist research, epistemology and data analysis, tensions between being a professional researcher and a 'caring' professional. The book includes practical guidelines to aid ethical decision-making rooted in feminist ethics of care.

Lee-Treweek, G. and Linkogle, S. eds. (2000) *Danger in the Field: Ethics and Risk in Social Research*. London: Routledge.

Read this if you are going into situations that might be ethically hazardous.

## FINDING AND REVIEWING THE LITERATURE

The most important reason for doing research is to produce new knowledge and understanding, and to disseminate it to make it available to everyone. When planning a research project, it is essential to know what the current state of knowledge is in your chosen subject as it is obviously a waste of time to spend months producing knowledge that is already freely available. Therefore, one of the first steps in planning a research project is to do a literature review: that is, to trawl through all the available information sources in order to track down the latest knowledge, and to assess it for relevance, quality, controversy and gaps. The last two will indicate where additional research is required – to try to resolve a controversy or to fill a gap. This chapter explains where to find the necessary information and how to analyse it and present it so that you can devise a solid basis for your research project.

### LOADS OF INFORMATION!

We are in an age of radical information expansion. Whatever your subject, there can be no excuse that you are faced with a lack of information. The problem lies in where to find relevant information of the right quality. Any trawl through the Internet will demonstrate what a lot of rubbish there is on every subject under the sun. Even a visit to the library or a good bookshop can be a daunting experience.

Luckily, you can easily learn how to use sophisticated methods of trawling for the information you need. No need to spend hours in dusty archives, no need to buy lots of expensive books, but there is a need to get skilled in search-and-find techniques and in methods of appraisal.

Where you look will depend on the subject you have chosen. Some sources cover most subjects, others are specialized in a narrow range, and will hence provide more detail. Here is a list of places you can search.

#### LIBRARIES

Your university or college library – this should be your first choice. Here you will find a huge amount of information and also about all the other information sources listed below. There are also specialist libraries, such as subject libraries in university departments, professional libraries in professional institutions, technical libraries in technical (research) establishments. Local libraries sometimes have special collections of local interest. Try to get the latest publications, unless you have special reasons not to, e.g. historical studies. The information in fast moving subjects, such as management, business, science and technology will become rapidly obsolete, but in the humanities older publications can have lasting value.

It is no longer sufficient just to visit the shelves to see what is there, even if you have consulted the online catalogue first. There will be a wide range of electronic resources and search facilities provided backed up by training sessions and leaflets in the use of these. Being adept at making searches will save you lots of time and frustration, as well as ensuring that you get hold of all the latest information you need.

Here are some of the facilities you should investigate:

- **Library catalogue.** Most libraries now have an electronic catalogue accessed through their computer terminals, often accessible online from elsewhere too via the Intra- and/or Internet.
- **Journals and newspapers.** These are often catalogued and stored separately to the books and may be available online. As they appear regularly, they tend to be very up to date.
- **Electronic databases.** These are computer-based lists of publications, on CD-ROM or on the university Intranet or the Internet.

They contain huge numbers of sources, usually searched by using keywords. Some provide only titles, publication details and abstracts, others provide the full text. Citation indexes list the publications in which certain books, articles, have been used as a reference.

- **Librarians.** There are often Subject Librarians who have specialist knowledge in specific subject areas – they will be able to help you explore more elusive sources. University libraries usually run free training sessions on all aspects of searching for information.

#### INFORMATION SERVICES

Government departments such as Standards Institutes, Records Offices, Statistical Offices provide information for the public. Pressure groups and voluntary organizations often produce publications about their work. Research establishments, professional and trade organizations also release details about latest research.

#### MUSEUMS AND GALLERIES – NATIONAL AND LOCAL

Apart from the exhibits, museums and galleries usually produce a range of printed and electronic information. They may also have many artefacts that are in store and only accessible by arrangement. Private collections of historical records and artefacts might be found.

#### PEOPLE

There are experts in every field. Some will be willing to advise you. Try the members of your own university staff at first, many of whom will be involved in research. Your library will contain guides to professionals and experts. In some cases, local knowledge will be needed – search out the relevant local experts (e.g. local historians, social workers, ornithologists etc.).

#### INTRANETS

Your own university or organization's Intranet. These often provide lecture and presentation notes as well as other specialist information produced by their staff e.g. research papers, professorial lectures.

## THE INTERNET

The full gamut of the World Wide Web. With thousands of pages being added every day, the World Wide Web (WWW) is the biggest single source of information in the world. However, the content is of extremely variable quality, and the biggest challenge when using it is to track down good quality material. You can easily waste hours trawling through rubbish in search of the goodies. Careful use of search terms helps to eliminate the trash. Usually, the more precise your search parameters, the more manageable the search results will be. Not all information on the WWW is free.

Published Internet guides can help you to make the best of this resource (try your library for lists devoted to subject areas). Some are specifically aimed at students and list useful search engines, sites and databases. Any Internet guide becomes quickly outdated. Specialized search engines such as Google Scholar will filter out much of the dross by listing academic and technical papers from proven sources.

## EVALUATING WEB SOURCES

Anyone can add pages to the World Wide Web, so how can you judge if the information you have found is reliable? Here are seven different tests you can make to judge the quality of the contents.

- 1 Is it accurate? Does it say what sources the data are based on? Compare the data with other sources. If it diverges greatly, is there some explanation for this?
- 2 What authority is it based on? Find out who authored the pages, and whether they are recognized experts or are issued by a reputable organization. Check if other publications are cited or if they provide a bibliography of other articles, reports or books. You may need to track down the 'home page' to get to the details. Web addresses that end in 'ac' (meaning academic) are likely to be university or college addresses and therefore point to some intellectual credibility – no guarantee of quality but nevertheless a useful indicator.
- 3 Is it biased? Many pressure groups and commercial organizations use the Web to promote their ideas and products, and present

- information in a one-sided way. Can you detect a vested interest in the subject on the part of the author? Find out more about the authors – e.g. does the information about animal experiments come from an antivivisection league, a cosmetics company, or an independent research institute?
- 4 How detailed is the information? Is the information so general that it is of little use, or so detailed and specialized that it is difficult to understand? Investigate whether it is only fragmentary and misses out important issues in the subject, and whether the evidence is backed up by relevant data. There may be useful links to further information, other websites or printed publications.
  - 5 Is it out of date? Pages stay on the Web until they are removed. Some have obviously been forgotten and are hopelessly out of date. Try to find a date or when it was updated (perhaps on the View-Page Info option on your web browser). Note that some updates might not update all the contents. Check any links provided to see if they work.
  - 6 Have you cross-checked? Compare the contents with other sources of information such as books, articles, official statistics and other websites. Does the information tally with or contradict these. If the latter, can you see why?
  - 7 Have you tried pre-evaluated 'subject gateways'? The information on these sites has been vetted by experts in the relevant subjects so can be relied upon to be of high quality. Try BUBL Link ([www.bubl.ac.uk/link/](http://www.bubl.ac.uk/link/)).

## DOING A LITERATURE REVIEW

The oft-repeated instruction to 'do a literature review' belies some of the complexities of the task. But why should you do one? The review that forms part of research proposal, paper, thesis or dissertation is an important introduction to the research project and underpins the argument about why the project is worth doing. It therefore forms a distinctly recognizable section near the beginning and leads on to the more specific and practical description of the research activities. In the dissertation or thesis, usually, one of the first chapters consists of a critical appraisal of the research literature relevant to the research subject under consideration. This is a more extended version of what is required for a proposal.

In order to understand the present 'state of the art' you too need to read what other people have written about research in your subject and make some kind of an assessment of where your research will fit into that body of work. You need to establish that what you are proposing has not been done in the same way before. To do this you obviously need to find out what has been researched, and how, within the area that you want to investigate. The 'how' is important, because the way previous research has been conducted will provide a useful source of experience in using relevant research methods for collecting and analysing data.

The review can be used to show where you have gained inspiration to develop your ideas – and that does not just have to be only from academic sources. It should also demonstrate that you have a good understanding of the current conceptual frameworks in your subject, and that you can take a stance in placing your work within these. The literature review tends to reveal a lot about the attitude of the researcher and the seriousness of his/her intentions, as well as the level of organization and clarity of thought achieved.

Below is an extract from a much more extended literature review for a PhD thesis by Alma Clavin. Here she looks at the literature about an important aspect of her study – the health and well-being benefits of gardening and horticulture.

**Gardens, horticulture and allotments for promoting  
health and well-being**

'Horticultural therapy' describes the use of plants by trained professions to reach clinically defined goals (Growth Point, 1999). 'Therapeutic horticulture' describes the process where individuals can develop their well-being using plants and horticulture and can be achieved through active or passive involvement (Lewis, 1996; Frumkin, 2001, 2004; Sempik *et al.*, 2002). These concepts have also been linked to the notion of 'therapeutic landscapes' advanced by geographers (Gesler, 1992; Henwood, 2003). Palka (1999: 30) defines therapeutic landscapes as places that 'promote wellness by facilitating relaxation and restoration and enhancing

some combination of physical, mental and spiritual healing'. It is in this context that therapeutic environments (such as gardening and allotments) are used to assist people suffering from physical or mental ill health.

The first study to explore the link between horticulture and mental health in 1955 demonstrated significant increases in improved self-esteem, self-confidence and social interaction amongst people with mental health problems and learning difficulties (O'Reilly and Handforth, 1955). The use of green environments as a form of therapy has a strong tradition in the institutional health care arena for people with poor mental health and vulnerable groups such as the elderly (Parr, 2005; Smyth, 2005). There are a multitude of schemes where gardens, allotments and working in natural environments (woodlands, country parks etc.) are being used as a form of therapy to treat mental illness.

The reported well-being benefits of garden work amongst vulnerable groups span physical, mental and social well-being effects. These include improved self-esteem and self-confidence, development of work and social skills, improved independence, opportunities for emotional expression and reflection, enhanced spiritual and sensory awareness, useful employment, increased physical activity and exercise, better nutrition from the consumption of healthy food, improved opportunities for social interaction (Sempik *et al.*, 2002; Morris, 2003).

In today's high-stress society, there is increasing recognition that horticultural activity need not be strictly clinically-orientated but can be used in a generalized way to improve the well-being of the individual (Parr, 2005; Sempik *et al.*, 2002). This is seen in the establishment of over 1160 community garden sites in the UK and Ireland (Source: FCFCG). Holland (2004: 285) states that such sites could act as a model for the implementation of social, economic and environmental policies at a local level.

Doing a literature review means not only tracking down all the relevant information but also taking a critical position on the ideas

contained therein. The latter is an important step in determining the quality of research evidence. The process involves an objective critique and evaluation of the strengths and weaknesses of a document, to determine its design quality and merits, and its relevance for your research topic.

You will need to evaluate and consider the relevance of the document to your own dissertation question and study objectives. The literature review will need to be carried out in four major directions, not just narrowly confined to your specific subject area. Here they are, arranged from the general to the particular, their relative importance depending on the nature of your subject:

- Research theory and philosophy – to establish the intellectual context(s) of research related to your subject.
- History of developments in your subject – to trace the background to present thinking.
- Latest research and developments in your subject – to inform about the current issues being investigated and the latest thinking and practice, to discuss the conflicting arguments, and to detect a gap in knowledge.
- Research methods – to explore practical techniques that have been used, particularly those that might be relevant to your project.

Here is a checklist of useful points for your review:

- Compile an overview of the literature to illustrate the interplay of ideas and major steps in the development of your subject.
- Introduce the important issues of your research problem through the analysis of the literature.
- Explain the general theoretical background to help the reader understand the attitudes behind the reviewed literature and your own philosophical stance.
- Make links across discipline boundaries when doing an interdisciplinary review, rather than keeping each separate and examined in turn. You may even suggest some new links that need to be investigated.
- Include some account of how the previous research was done, so that you have a precedent for your own approach to methodology.

How many references should you have? This depends on the subject and extent of the review. As the literature review part of a research proposal has to be very short and compact due to limitation of space, you are unlikely to be able to cite more than 15–20 authors, 5–10 might even be sufficient in a narrowly defined field. For a literature review chapter of a dissertation or research project, 20–35 references are more likely. The important thing is to select those that are really significant for your work.

## ANALYSING THE TEXT

A distinction must be made between a review of the literature as a preliminary to a research project, and the detailed analysis of each piece of literature. The latter is a quality control exercise that helps you to choose the best and most relevant pieces of information to use in the review. The point of the detailed analysis is not just to find fault with the style of writing or ideas, but to present a critique, an analysis, or an examination of them, to give your own personal and professional appraisal of the content and quality of the content in question. A description is not enough.

Critical appraisal requires lots of in-depth reading and is a skill that has to be learnt and practised which can initially be quite time consuming. The main steps can be summarized as:

- 1 Thoroughly read the original research article and decide if it is relevant to your study. Assess whether the purpose of the research is well defined and that the research methods are made clear. Identify the data collection and analysis methods, the findings and the conclusions and make an assessment of their clarity.
- 2 Reveal the assumptions upon which the writings and arguments are based. All writing is rooted in theory and based on values. Sometimes these are quite clearly stated at the beginning of the text, sometimes they are obscured or not mentioned. Some knowledge of the different theoretical positions is required in order to be able to detect them and know what they imply, e.g. a feminist approach in social science, a Keynesian approach in economics, a Modernist approach in architecture and a Freudian approach in Psychology.
- 3 Trace the logic of the argument to ascertain whether the steps in the argument lead from the evidence to the conclusions. You can

do this by first detecting the conclusion indicators (e.g. therefore, it follows that etc.) in order to pinpoint the conclusion(s). The main conclusions should normally appear towards the end of the work, though there may be intermediate conclusions scattered throughout. You can then investigate what evidence is given to support the conclusions and whether the evidence is credible, i.e. does it come from reliable sources?

- 4 Compare it with other work. As there are no absolute values to which you can appeal in order to make assessments and no clear rules about what is right and wrong, make comparisons between texts in order to highlight the different approaches, levels of thoroughness, contradictions, strength of arguments, implications of theoretical stances and accepted values and types of conclusions.

#### PRESENTING YOUR ANALYSIS

A review of the literature should provide an introduction to the latest concepts and advances in thinking in the chosen subject by citing relevant papers and publications and authors to underpin the description. However, a thorough critical appraisal of the papers investigated will require a more systematic approach. You will need to make a summary that briefly covers your critical appraisal and assessment of the quality of each research paper. It is a good idea to standardize the form of your appraisals using standard headings, such as:

- Study design and assumptions
- Methods of data collection
- Analytical methods
- Main findings
- Conclusions
- The study's strengths and limitations
  - clarity
  - logic
  - scope

Using this list of headings you can produce a table with the summaries of the results of your critical appraisal of each of the studies so that you can scan across the set of papers. This will then provide a clear and simple framework for making a comparative assessment of

the papers. There are several very useful tools and checklists available in the books recommended below, that consist of detailed sets of questions in the form of checklists. Some critical appraisal tools are general, while others focus specifically on appraising particular types of research, such as quantitative research, systematic reviews, qualitative research evidence etc.

## WHERE TO FIND OUT MORE

The following books provide some really useful detail about doing literature reviews. The titles say what they are about.

Ridley, D. (2008) *The Literature Review: A Step-by-Step Guide for Students*. London: Sage.

Useful strategies are described for efficient reading, conducting searches, organizing information, and writing the review itself. Examples of best and worst practice drawn from real literature reviews are included throughout to demonstrate how the guidance can be put into practice.

## **PART II**

# **THE MAIN RESEARCH METHODS**

In the following chapters I look specifically at different types of research methods that are commonly used in academic and applied research. You will have gathered from the previous chapters that there is a variety of opinions about what knowledge is and how we can acquire it, so the techniques for collecting data and analysing it are consequently varied.

To start with, in Chapter 6, I look at the raw material of research – data. In order to collect and analyse them, it is important to understand what they are and what their characteristics are and how they can be measured. I also consider how statements about data can be expressed at different levels of abstraction, from the up-in-the-sky theoretical to the down-to-earth practical.

People have been collecting data on just about everything, and in this information age, it is easier to access these collections than ever before. So in Chapter 7, I explain that you do not always need to do the data collection yourself but can rely on that collected by others. Where to find it and how to analyse it is explored, and also how to test it for reliability. But if you do want to collect your own original data, then I describe in Chapter 8 a range of methods for doing so, from asking questions, making observations, to generating your own data through experiments and simulations.

I dedicate Chapters 9 and 10 to the analysis of data. There are distinct differences in how to deal with quantitative and qualitative data, so they have a separate chapter each. Statistics is the science by which quantitative data is most easily analysed, and there is a vast array of tests that can be applied according to the nature of the data and what you want to interrogate it for. In Chapter 9 I briefly explain some of the most common types.

The analysis of qualitative data has not been developed into such an exact science, primarily due to the more imprecise nature of the data. Different disciplines tend to favour particular types of analysis that accord best with their concerns and the nature of their data. However, in all cases there is a need to summarize the mass of raw data and display it in a way that you can detect patterns or trends. I explain a range of analytical methods that can be applied to qualitative data in Chapter 10.

In Chapter 11, I discuss the practical issues that you face when you want to write about your research. Before starting your project, you need to be very clear about what you want to research, why and how. A research proposal is a written account that should make this all clear, not only to yourself, but to your supervisor, client or promoter. I therefore give some useful guidance about how to formulate and structure the proposal. The written report, paper, dissertation or thesis that marks the end of the research is an essential part of the research process. After all, what is the point of doing research if no one is told of the outcomes? I explain the art and science of writing up the account of the project, and provide some useful advice on the techniques you can use to make this process easier.

## THE NATURE OF DATA

We are all aware that we live in an information age. It is said that the amount of information in the world is doubling every month, or is it every week? Who knows? One thing is for sure – we are deluged with the stuff every day. Data is another word for bits of information (singular – datum). Research uses data as the raw material in order to come to conclusions about some issue. It depends on the issue being investigated what data needs to be collected.

Although much data seem to be solid fact and permanently represents the truth, this is not the case. Data are not only elusive, but also ephemeral. They may be true for a time in a particular place as observed by a particular person, but might be quite different the next day. Take for example, a daily survey of people's voting intentions in a forthcoming general election. The results will be different every day even if exactly the same people are asked, because some change their minds because of what they have heard or seen in the interim period.

Data are not only ephemeral, but also corruptible. Hearsay, second hand reports and biased views are often paraded as facts. The further away you get from the event the more likely it is that inconsistencies and inaccuracies creep in. Memory fades, details are lost, recording methods do not allow a full picture to be given, and distortions of interpretations occur.



Because it is dangerous for a researcher to insist that his or her data, and findings derived from them are infallible, the outcomes of research are often couched in 'soft' statements, such as 'it seems that', 'it is likely that', 'one is lead to believe that' etc. This does not mean, however, that the knowledge gained is useless, only that it is not absolutely certain, like most things in life.

## LEVELS OF ABSTRACTION

How do data, the raw materials of research, relate to knowledge as a whole? They are part of a hierarchy of information, going from the general to the particular, from abstract to concrete. Understanding this hierarchy makes it possible to break down research problems expressed in theoretical language to more practical components that can be measured in some way. This hierarchy can be expressed like this:

- **Theory** – abstract statements that make claims about the world and how it works. Research problems are usually stated at a theoretical level.
- **Concepts** – building blocks of the theory which are usually abstract and cannot be directly measured.
- **Indicators** – phenomena which point to the existence of the concepts.
- **Variables** – components of the indicators which can be measured.
- **Values** – actual units of measurement of the variables. These are data in their most concrete form.

You can see that the briefest statement of a theory will be the most general and abstract, whilst the detailed components of the statement will become increasingly particular and concrete. Each theory will contain several concepts, each concept several indicators, each indicator several variables, and each variable several values. For example:

- Theory – poverty leads to poor health.
- Concepts – poverty, poor health.
- Indicators of poverty – low income, poor living conditions, restricted diet, etc.

- Variables of poor living conditions – levels of overcrowding, provision of sanitary facilities, infestations of vermin, levels of litter, etc.
- Values of levels of overcrowding – numbers of people per room, floor areas of dwellings, numbers of dwellings per hectare, etc.

## THEORY

Although the meaning of the term theory is rather imprecise, in research it refers to a statement that makes a claim about a phenomenon. Theories can range from complex, large-scale, well-researched and substantiated claims developed through academic research, to informal guesses or hunches about specific situations. Our understanding of how the world works is based on theories, and much of research is concerned with challenging, refining extending existing theories, or developing new ones.

As theories statements tend to be expressed in abstract terms, it is necessary to break them down into their constituent parts in order to examine them. The statements are usually made up of concepts and how they relate.

## CONCEPTS

A concept is a term for particular phenomenon, often quite abstract, such as alienation, socialism, equilibrium, society, but can also be quite concrete, such as animal, town, and income.

We use concepts all the time as they are an essential part of understanding the world and communicating with other people. Many common concepts are shared by everyone in a society, though there are variations in meaning between different cultures and languages. For example, the concept 'respect' will mean something different to a streetwise rapper than to a noble lord. Some concepts can only be understood by experts in particular disciplines, e.g. dermatoglyphics, milfoil, parachronism, anticipatory socialization, etc.

Concepts should be clearly defined so that they can be understood in the same way by everyone. This is relatively easy in the natural sciences where precise definitions of concepts such as radio waves, acceleration and elements are possible. In the humanities and social

sciences this may be much more difficult – e.g. concepts such as beauty, honour, motivation, kinship etc. – as their meanings are often based on opinions, emotions, values, traditions etc.

#### INDICATORS

Concepts that are abstract in nature can be difficult to detect, evaluate or measure. Take ‘anxiety’ as an example. How could you detect this in a person? The answer is to look for indicators – those perceivable phenomena that give an indication that the concept is present. In this example the signs that might indicate anxiety might be – trembling, worried facial expression, pacing up and down, sweating, short breath etc. In most scientific and technical subjects, indicators are usually well defined and universally accepted. In the humanities and social sciences, these usually need to be carefully defined in each research project as this consensus is often lacking.

#### VARIABLES

In order to gauge the extent or degree of an indicator, you will need to find a measurable component. In the case of anxiety above, it would be very difficult to measure the level of worry of the expression, but you could easily measure a person’s rate of breathing

In the natural sciences, the identification of variables is usually relatively simple. Area, temperature, speed, velocity are some examples. Some of these may be appropriate to the social sciences, particularly in quantitative studies, e.g. number of people in a demonstration, type of occupation, income etc.

#### VALUES

The values used are the units of measurement used to gauge the variables. The level of the precision of measurement depends on the nature of the variable and the type of values that are appropriate. Certain scientific studies require that variables are measured incredibly accurately, whilst some social variables might only be gauged on a three-point scale such as ‘agree’, ‘neutral’, ‘disagree’.

Data, seen as bits of information, can be at any level of abstraction. Research projects usually start at the more abstract end of the

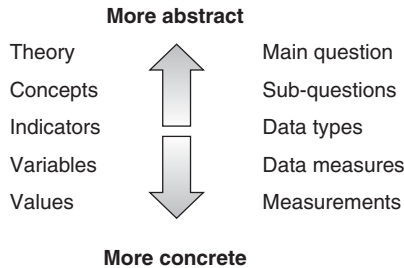


Figure 6.1 Diagram of levels of abstraction

spectrum, move to the more concrete during the investigation, and return to the abstract in the conclusions. Data that can be manipulated, measured and analysed tends to be more at the values level, but in many subjects in the humanities and social sciences, the variables may be difficult or even impossible to measure with precise values.

You can relate these levels of abstraction to how to structure your research. Your title and main research question will be expressed at a theoretical level, and your sub-questions will be about the separate concepts. In order to investigate these, you will need to find out what type of measures can be used to assess the existence and scale of the concepts, then the scales that can be used in the measures, i.e. the type of measurements, and finally the actual measurements that provide the basic data for analysis. Figure 6.1 provides a simple diagram to illustrate the levels of abstraction in your research structure.

## PRIMARY AND SECONDARY DATA

Data come in two main forms, depending on its closeness to the event recorded. Data that has been observed, experienced or recorded close to the event are the nearest one can get to the truth, and are called **primary data**. Written sources that interpret or record primary data are called **secondary sources**, which tend to be less reliable. For example, reading about a fire in your own house in the newspaper a day after will

probably give you less accurate information than what you gained by experiencing the event yourself. You will be more informed about the facts and these will not be distorted by someone else's interpretation.

#### PRIMARY DATA

We are being bombarded with primary data all day. Sounds, sights, tastes, tactile things are constantly stimulating our senses. We also have instruments to measure what we cannot so accurately judge through our senses, such as clocks, barometers, business accounts etc.

There are four basic types of primary data, distinguished by the way they are collected:

- 1 Measurement – collections of numbers indicating amounts, e.g. voting polls, exam results, car mileages, oven temperatures etc.
- 2 Observation – records of events, situations or things experienced with your own senses and perhaps with the help of an instrument, e.g. camera, tape recorder, microscope, etc.
- 3 Interrogation – data gained by asking and probing, e.g. information about people's convictions, likes and dislikes etc.
- 4 Participation – data gained by experiences of doing things e.g. the experience of learning to ride a bike tells you different things about balance, dealing with traffic etc., rather than just observing.

The primary data are the first and most immediate recording of a situation. Without this kind of recorded data it would be difficult to make sense of anything but the simplest phenomenon and be able to communicate the facts to others.

Primary data can provide information about virtually any facet of our life and surroundings. However, collecting primary data is time consuming and not always possible. Although more data usually means more reliability, it is costly to organize large surveys and other studies. Furthermore, it is not always possible to get direct access to the subject of research. For example, many historical events have left no direct evidence.

#### SECONDARY DATA

Secondary data are data that have been interpreted and recorded. Just as we are bombarded with primary data, we are cascaded with

secondary data in the form of news bulletins, magazines, newspapers, documentaries, advertising, the Internet etc. The data are wrapped, packed and spun into pithy articles or digestible sound bites. The quality of the data depends on the source and the methods of presentation. Refereed journals containing papers vetted by leading experts, serious journals, such as some professional and trade journals will have authoritative articles by leading figures. Magazines can contain useful and reliable information or be entirely flippant. The same goes for books – millions of them! They range from the most erudite and deeply researched volumes to ranting polemics and commercial pap. Television and radio programmes vary likewise, as does information on the Internet.

A major aspect of using secondary data is making an assessment of the quality of the information or opinions provided. This is done by reviewing the quality of evidence that has been presented in the arguments, and the validity of the arguments themselves, as well as the reputation and qualifications of the writer or presenter. It is also good practice to compare the data from different sources. This will help to identify bias, inaccuracies and pure imagination. It will also show up different interpretations that have been made of the event or phenomenon.

## QUANTITATIVE AND QUALITATIVE DATA AND LEVELS OF MEASUREMENT

Data are also divided into two other categories, referring not to their source but to their characteristics; basically whether they can be reduced to numbers or presented only in words. This affects the way that they are collected, recorded and analysed.

Numbers are used to record much information about science and society, for example pressures, bending forces, population densities, cost indices etc. This type of data is called **quantitative data**. Numbers can be analysed using the techniques of statistics. However, a lot of useful information cannot be reduced to numbers. People's judgements, feelings of comfort, emotions, ideas, beliefs etc. can only be described in words. These record qualities rather than quantities, hence they are called **qualitative data**. Words cannot be manipulated mathematically, so require quite different analytical techniques.

#### QUANTITATIVE DATA

Quantitative data can be measured, more or less accurately because it contains some form of magnitude, usually expressed in numbers. You can use mathematical procedures to analyse the numerical data. These can be extremely simple, such as counts or percentages, or more sophisticated, such as statistical tests or mathematical models.

Although some forms of data are obviously expressed as numbers, e.g. population counts, economic data, scientific measurements etc. Others that seem remote from quantitative measures can also be converted to numbers. For example, people's opinions about the performance of political parties look difficult to quantify. But if a set choice of answers is given in a questionnaire then you can then count the numbers of the various responses. The data can then be treated as quantitative.

Census figures (population, income, living density, etc.), economic data (share prices, gross national product, tax regimes, etc.), performance data (e.g. sport statistics, medical measurements, engineering calculations, etc.) and all measurements in scientific endeavour are all typical examples of quantitative data. Table 6.1 provides a simple example of a set of quantitative data, in this case, referring to scores achieved by seven cases in three tests.

#### QUALITATIVE DATA

Qualitative data cannot be accurately measured and counted, and are generally expressed in words rather than numbers. Essentially human activities and attributes such as ideas, customs, mores, beliefs,

that are investigated in the study of human beings and their societies and cultures cannot be pinned down and measured in any exact way. These kinds of data are therefore descriptive in character. This does not mean that they are any less valuable than quantitative data; in fact their richness and subtlety lead to great insights into human society.

Qualitative research depends on careful definition of the meaning of words, the development of concepts and variables, and the plotting of interrelationships between these. Concepts such as affluence, happiness, comradeship, loyalty etc. are real and detectable, even if they are difficult to record and measure.

Observation notes, interview transcripts, literary texts, minutes of meetings, historical records, memos and recollections, documentary films, are all typical examples of qualitative data. Some are recorded very close to the events or phenomena, whilst others may be remote and highly edited interpretations, so assessments of the reliability must be made. Also qualitative data rely on human interpretation and evaluation and cannot be dispassionately measured in a standard way. Checks on the reliability and completeness of qualitative data can be made by consulting a variety of sources of data relating to the same event – this is called triangulation. Table 6.2 illustrates an example of qualitative data, in this case the personal reactions to a change of work practices in a factory of various individuals in different roles.

Research, particularly when about human beings, often combines the examination of both qualitative and quantitative data. In fact, there are many types of data that can be seen from both perspectives. For example, a questionnaire exploring people's attitudes to work may provide a rich source of qualitative data about their aspirations and beliefs, but might also provide useful quantitative data about levels of skills and commitment. What is important is the appropriate analytical methods are used for the different the types of data that you are dealing with.

## MEASUREMENT OF DATA

Data can be measured in different ways depending on their nature. These are commonly referred to as levels of measurement – **nominal**, **ordinal**, **interval** and **ratio**.

## NOMINAL LEVEL

Nominal measurement is very basic – it divides the data into separate categories that can then be compared with each other. By sorting out the data using names or labels you can build up a classification of types or categories. This enables you to include or exclude particular cases into the types and also to compare them. For example, buildings may be classified into many types, e.g. commercial, industrial, educational, religious etc. Some definitions allow only two types, e.g. sex (male or female), while others fall into a set number such as marital status (single, married, separated, divorced or widowed). What is important is that every category is distinctive, that there is no overlap between them which makes it difficult to decide where to place a particular piece of datum. Ideally, all the data should be able to be categorized, though sometimes you will need a ‘remainders’ category for all those that cannot be.

Nominal data can be analysed using only simple graphic and statistical techniques. Bar graphs, for example, can be used to compare the sizes of categories and simple statistical properties such as the percentage relationship of one subgroup to another or of one subgroup to the total group can be explored

## ORDINAL LEVEL

This type of measurement puts the data into order with regard to a particular property that they all share, such as size, income, strength, etc. Precise measurement of the property is not required, only the perception of whether one is more or less than the other.

For example, a class of children can be lined up in order of size without measuring their heights; the runners in a marathon can be sorted by the order in which they finished the race. Likewise, we can measure members of the workforce on an ordinal scale by calling them unskilled, semi-skilled or skilled.

The ordinal scale of measurement increases the range of statistical techniques that can be applied to the data.

## INTERVAL LEVEL

With this form of measurement, the data must be able to be measured precisely on a regular scale of some sort, without there being a meaningful

zero. For example temperature scales, in the Fahrenheit, Celsius and Rankine scales, the gradation between each degree is equal to all the others, but the zero point has been established arbitrarily. They each precisely measure the temperature, but the nought degrees of each are different. Another example is the calendar date – compare the Chinese and Western calendars.

In the social sciences, some variables, such as attitudes, are frequently measured on a scale like this:

Unfavourable -4 -3 -2 -1 0 +1 +2 +3 +4 Favourable

Despite appearances, you must be cautious to interpret this as a true interval scale, as the numbers are not precise measurements and indicate preferences on an essentially ordinal scale.

The interval level of measurement allows yet more sophisticated statistical analysis to be carried out.

#### RATIO LEVEL

The ratio level of measurement is the most complete level of measurement, having a true zero: the point where the value is truly equal to nought. Most familiar concepts in physical science are both theoretically and operationally conceptualized at a ratio level of quantification, e.g. time, distance, velocity, mass etc.

A characteristic difference between the ratio scale and all other scales is that the ratio scale can express values in terms of multiples of fractional parts, and the ratios are true ratios. For example, a metre is a multiple (by 100) of a centimetre distance, a millimetre is a tenth (a fractional part) of a centimetre. The ratios are 1:100 and 1:10. There is no ambiguity in the statements 'twice as far', 'twice as fast' and 'twice as heavy'. Of all levels of measurement, the ratio scale is amenable to the greatest range of statistical tests.

In summary, you can use the following simple test to determine which kind of data measurement that you can use on the values of a variable. If you can say that:

- one value is different from another, you have a **nominal scale**;
- one value is bigger, better or more of anything than another, you have an **ordinal scale**;

- one value is so many units (degrees, inches) more or less than another, you have an **interval scale**;
- one value is so many times as big or bright or tall or heavy as another, you have a **ratio scale**.

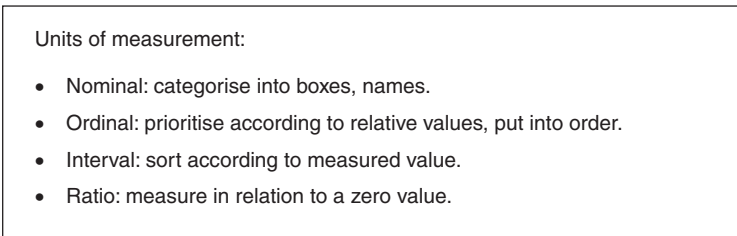


Figure 6.2 Levels of measurement

Figure 6.2 provides a summary of the levels of measurement.

## COLLECTING AND ANALYSING SECONDARY DATA

All research studies require secondary data for the background to the study. You will inevitably need to ascertain what the context of your research question/problem is, and also get an idea of the current theories and ideas. No type of project is done in a vacuum, not even a pure work of art. However, it is quite common in student level research to rely on secondary data for the actual research investigations rather than generating new primary data from the field. Wherever there exists a body of recorded information, there are subjects for study. You can imagine using existing resources when doing an historical study (i.e. of any past events, ideas or objects, even the very recent past) or a nationwide or even a local study that uses official statistics as the principle data.

The advantage of using sets of secondary data is that it has been produced by teams of expert researchers, often with large budgets and extensive resources way beyond the means of a single student, so it cuts out the need for time consuming fieldwork. Data that has been collected over a long period of time will provide the opportunity to do a longitudinal study (tracing the developments over time), impossible to do with data collected in short projects. Secondary data can also be used to compare with primary data you may have collected, in order to triangulate the findings and put your data into a larger

context. Data in the public realm are also open to scrutiny by others and is a permanent resource on which to base your research.

The disadvantage is that you miss out on the experiences and skills gained by having to generate your own primary data from real-life situations. The data will also have been collected with a purpose that might not match easily with what you need for your research focus. Though many sources of data are free, others are costly to acquire and may be difficult to access. When using data from a variety of sources, there are likely to be mismatches in terminology and the way the data has been collected and analysed, making aggregation of the data difficult or open to challenge.

As a researcher, you will face several problems when seeking previously recorded historical and data. The main of these are that of:

- locating and accessing them
- authenticating the sources
- assessing credibility
- gauging how representative they are
- selecting methods to interpret them.

Locating secondary data can be an enormous topic. Activities can involve anything from rummaging through dusty archives in an obscure library to downloading the latest government statistical data from the Internet or even unearthing city ruins in the desert. Even current data might be difficult to get hold of. For instance, much current economic data are restricted and expensive to buy. To be really useful, data sets should have good documentation that includes descriptions of all the variables and codes, as well as the recording methods that were used.

## TYPES AND SOURCES OF SECONDARY DATA

There are numerous types of secondary data, the main being documentary sources in the form of written and non-written materials, and survey data in the form of statistical information.

- Written materials – organizational records such as internal reports, annual reports, production records, personnel data, committee reports and minutes of meetings; communications such as emails,

letters, notes; publications, such as books, journals, newspapers, advertising copy, government publications of all kinds etc.

- Non-written materials – television programmes, radio programmes, tape recordings, video tapes, films of all types, including documentary, live reporting, interviews, etc. works of art, historical artefacts etc.
- Survey data – government census of population, employment, household surveys, economic data, organizational surveys of markets, sales, economic forecasts, employee attitudes. These may be carried out on a periodic basis, with frequent regularity or continuously, or ad hoc or one-off occasions. They may also be limited to sector, time, area.

It sometimes depends on how you want to use the data whether they should be regarded as primary or secondary data. For example, if you are analysing a work of art in the form of a painting, you could use it as primary data by looking at the subject, materials and techniques used in the painting, the proportions, etc. particular to that particular painting or artist. Alternatively you could use it as secondary data when examining it for aesthetic trends, as evidence for developments in art history, or as a commentary on the society of the time. The same could be said for pieces of music, films or television programmes.

It is impossible to give a full description of all sources of secondary data, as the detailed nature of the subject of research determines the appropriate source, and, of course, the possible range of subjects is enormous. However, here are some of the principle types of data and the sources where they can be found.

#### DATA SETS ONLINE

There are several online sites that provide access to data sets from a variety of sources, such as The Data Archive ([www.data-archive.ac.uk](http://www.data-archive.ac.uk)) that supplies over 4,000 data sets from sources worldwide, such as government, opinion poll organizations, academic researchers etc. The European Union publish their statistical information on <http://europa.eu.int/comm.eurostat>. For international economic and business information there are sites such as provided by FT info (<http://news.ft.com>), Hoovers Online ([www.hoovers.com](http://www.hoovers.com)), and Global Market Information Database ([www.gmid.uromonitor.com](http://www.gmid.uromonitor.com)).

For UK government data sets, see the UK Data Archive ([www.natcen.ac.uk](http://www.natcen.ac.uk)) which provides details of the results of surveys such as British Social Attitudes, Company Level Industrial Relations, Eurobarometer, the General Household Survey, International Social Survey Programme, Labour Force Survey etc. Within this is a source directed more at social science issues, supplying access to data from major social surveys – CASS (The Centre for Applied Social Surveys – [www.natcen.ac.uk/cass](http://www.natcen.ac.uk/cass)). The Office for National Statistics ([www.statistics.gov.uk](http://www.statistics.gov.uk)) is also a good source for data, such as the Annual Employment Survey, UK New Earnings Survey and the Expenditure and Food Survey. The Census Registration Service ([www.census.ac.uk](http://www.census.ac.uk)) gives details of the national census results held every ten years since 1801. Other countries provide a similar range of their own statistical data, such as France ([www.insee.fr](http://www.insee.fr)) and Germany ([www.destatis.de](http://www.destatis.de)).

There are also numerous organizations that provide survey data ranging from professional bodies such as the Confederation of British Industry ([www.cbi.org.uk](http://www.cbi.org.uk)) and the American Marketing Association ([www.marketingpower.com](http://www.marketingpower.com)) to international organizations such as the Organization for Economic Cooperation and Development ([www.oecd.org](http://www.oecd.org)) and the United Nations ([www.un.org](http://www.un.org)), and advisory and regulating bodies such as Advisory, Conciliation and Arbitration Service ([www.acas.org.uk](http://www.acas.org.uk)) and the Advertising Standards Authority ([www.asa.uk](http://www.asa.uk)).

Don't forget that not all data sets are in the form of lists of statistics. Spatial information is contained on maps and charts. One rich mine of information is the Geographic Information System (GIS) which is a source of much geographical and demographic data for areas throughout the world based on mapping techniques.

## DOCUMENTARY DATA

### *CULTURAL TEXTS*

Many of the prevailing theoretical debates (e.g. postmodernism, post-structuralism) are concerned with the subjects of language and cultural interpretation, with the result that these issues have frequently become central to sociological studies. The need has therefore arisen for methodologies that allow analysis of cultural texts to be compared, replicated, disproved and generalized. From the late 1950s, language has been analysed from several basic viewpoints: the structural



properties of language (notably Chomsky, Sacks, Schegloff), language as an action in its contextual environment (notably Wittgenstein, Austin and Searle) and sociolinguistics and the 'ethnography of speaking' (Hymes, Bernstein, Labov and many others).

However, the meaning of the term 'cultural texts' has been broadened from that of purely literary works to that of the many manifestations of cultural exchange, be they formal such as opera, TV news programmes, cocktail parties etc., or informal such as how people dress or converse. The main criterion for cultural texts is that one should be able to 'read' some meanings into the phenomena. Texts can therefore include tactile, visual and aural aspects, even smells and tastes. They can be current or historical and may be descriptive or statistical in nature. Any of them can be quantitative or qualitative in nature.

Here are some examples of documentary data that come from a wide range of sources:

- personal documents
- oral histories
- commentaries
- diaries
- letters
- autobiographies
- official published documents
- state documents and records
- official statistics
- commercial or organizational documents
- mass media outputs
- newspapers and journals
- maps
- drawings, comics and photographs
- fiction
- non-fiction
- academic output
- journal articles and conference papers
- lecture notes
- critiques
- research reports
- textbooks

- artistic output
- theatrical productions – plays, opera, musicals
- artistic critiques
- programmes, playbills, notes and other ephemera
- virtual outputs
- web pages
- databases.

#### LIBRARIES, MUSEUMS AND OTHER ARCHIVES

These are generally equipped with sophisticated catalogue systems which facilitate the tracking down of particular pieces of data or enable a trawl to be made to identify anything which may be relevant. Local libraries often store data and collections of local interest. Museums, galleries and collections: these often have efficient cataloguing systems that will help your search. Larger museums often have their own research departments that can be of help. Apart from public and academic institutions, much valuable historical material is contained in more obscure and less organized collections, in remote areas and old houses and specialist organizations. However, problems may be encountered with searching and access in less organized and private and restricted private collections. The attributes of a detective are often required to track down relevant material, and that of a diplomat to gain access to the private or restricted collections.

#### COMMERCIAL AND PROFESSIONAL BODIES

These often hold much statistical information, both current and historic. Companies will devise records on many aspects of their business for their own internal use, which might be difficult to access unless you are a trusted employee. However, trade organizations that represent different branches of industry and commerce usually publish general statistics that refer to the activities of their sector. This is the same with professional bodies, who record many aspects of professional life of their members, such as employment trends, levels of commissions and income data.

The data from these bodies are commonly published in report form, both printed and electronic, which can be accessed through their web pages.

## SUITABILITY OF DATA FOR YOUR PROJECT

It is worth making several checks before you commit yourself to using secondary data to make sure that the characteristics of the data can fulfil your research objectives and answer your questions:

- Do measures match those you need, e.g. economic, demographic, social statistics?
- Coverage – is there sufficient data of required type, and can unwanted data be excluded?
- Population – is it the same as required for your chosen research?
- What variables are covered – the precise nature of these might not be so important for descriptive work but could be essential for statistical tests or explanatory research?
- Will benefits be greater than your costs?
- Will you be allowed access?

## AUTHENTICATION AND CREDIBILITY

When you use data from a source where you have had no control in its collection, you will have to assure yourself that the data is reliable and sufficiently comprehensive and suitable for your needs. With regard to reliability, a quick assessment can be made by examining the source of the data – what is the reputation of the organization supplying the data? Government statistics and data provided by large, well known organizations are likely to be authoritative, as their continued existence relies on maintaining credibility. Records held by smaller organizations or commercial companies will be more difficult to check for reliability. In these cases, it is important to make a check on the person or institution responsible for the data, and to explore whether there are any printed publications relating to the research which might give them more credibility.

Although it may be impossible in the case of commercial providers of statistical data, in other cases you should try to make an assessment of the methods of data collection and analysis used to produce the data. Internet-based data sets may provide this information through hyperlinks, and reports will normally have a section devoted to the research methods used. Issues to be assessed are the sampling method used, the response rate of surveys, the context in which the

data were collected and recorded and the analytical methods used to process the data.

The wealth of purely statistical data contained in the archives, especially those of more recent date, provide a powerful resource for research into many issues. You will often find, however, that the recorded data are not exactly in the form that you require (for example, when making international comparisons on housing provision, the data might be compiled in different ways in the different countries under consideration). In order to extract the exact data you require you will have to extrapolate from the existing data.

Authentication of historical data can be a complex process, and is usually carried out by experts. A wide range of techniques are used, for example textual analysis, carbon dating, paper analysis, locational checks, cross referencing and many others.

Credibility of data refers to their freedom from error or bias. Many documents are written in order to put across a particular message and can be selective of the truth. This may be the case of data acquired from particular interest groups, or reports compiled by those who wish to create a certain impression or achieve particular targets: '[Documents] should never be taken at face value. In other words, they must be regarded as information that is context specific and as data which must be contextualized with other forms of research. They should, therefore, only be used with caution' (Forster, 1994: 149). Much important contextual data can be missing from such documents as reports of spoken events, where the pauses, hesitations and gestures are not recorded. The degree of representativeness of the documents should be assessed. This will enable judgements of the generalizability of any conclusions drawn from them to be made.

When using data sets that have been gathered over a period of time, perhaps over years, check that the data collection and analysis methods have remained constant. Any changes in these will alter the resulting data, making comparisons across time more difficult and unreliable. While government and official sources are likely to record this kind of change, company and non-official sources are less likely to do so.

## ANALYSING SECONDARY DATA

Analysis of secondary data can aim at looking for patterns or trends across the results, to track progressions through time, or to seek out

repetition of certain results to build up a strong case. Of the many different ways to analyse secondary data, many are no different from those used for primary data, which are described in the later chapters. However, it is worth mentioning three methods that are particularly suitable for secondary sources; content analysis, data mining and meta-analysis.

#### CONTENT ANALYSIS

Content analysis is a quantitative form of analysis that consists of an examination of what can be counted in text of any form (articles, advertisements, news items etc.) or other media such as pictures, television or radio programmes or films, and live situations such as interviews, plays, concerts. The analysis is done very often, but not necessarily, from secondary sources. The method was developed from the mid-1900s chiefly in America, and is a rather positivistic attempt to apply order to the subjective domain of cultural meaning. It is done by counting the frequency of phenomena within a case in order to gauge its importance in comparison with other cases. As a simple example, in a study of racial equality, one could compare the frequency of different races in the illustrations in fashion magazines in various European countries. Much importance is given to careful sampling and rigorous categorization and coding in order to achieve a level of objectivity, reliability and generalizability and the development of theories.

There are several basic stages to this method:

- State the research problem i.e. what is to be counted and why? This will relate to the subject of the study and the relevant contents of the documentary source.
- Employ sampling methods in order to produce representative findings. This will relate to the choice of publications or other media, the examples selected and the sections within the examples that are investigated.
- Devise the units of analysis. These are the aspects of the content that will be retrieved and recorded in the form of a coding schedule.
- Describe and number the codes that are a measure of the units of analysis in the form of a coding manual.

- Retrieve the coded fragments. This can be done manually, but computer based search systems are more commonly used when the text can be digitized.
- Do quality checks on interpretation. This covers issues of:
  - the units of analysis (can the selected aspects or themes really be divided from the rest of the text?);
  - classification (are the units counted really all similar enough to be counted together?);
  - combination of data and formation of ‘100 per cents’ (how can the units counted be weighted by length/detail/authoritativeness and how is the totality of the elements to be calculated?).
- Analyse the data (what methods of interpretation will you use?).

#### *CODING SCHEDULE, CODING MANUAL AND TABULATION OF RESULTS*

The relevant units of analysis are devised by a preliminary review of the cases, consisting of examples of a type of publication, programme or film. A coding schedule in the form of a table is then set up, with each column being headed by a unit of analysis used to investigate each case. Figure 7.1 is an example of a coding schedule devised for an analysis of the contents of a local television evening news programme and how the items are reported and illustrated.

These units of analysis are then broken down in order to establish codes that can be used to describe or measure them. A coding manual can then be produced that lists descriptions or measurements in the form of numbered codes that will be searched for and recorded. The codes can consist of a word or a phrase. An example of a possible coding manual derived from the coding schedule in Figure 7.1 is shown in Figure 7.2.

#### TABULATION OF RESULTS

The numerical data that forms the results of a content analysis are most conveniently presented in tabular form. A separate table is produced for each case based on the coding schedule, with the columns listing the codes filled in (see Figure 7.3). When the results of all the cases has been tabulated, the frequency of the occurrence of the different codes throughout all the cases can then be counted.

What content analysis on its own cannot do is to discover the effects that the publications, programmes, films etc. have on their audience.

Other research methods (e.g. questionnaires, interviews etc.) must be used to gain this type of information. What it can uncover, however, is how the communications are constructed and which styles and conventions of communication are used by authors to produce particular effects. This form of analysis allows large quantities of data to be analysed in order to make generalizations.

#### DATA MINING

Data mining is a technique used extensively by business managements to extract meaningful information from the huge databases that are generated by electronic and other methods in modern businesses. It is often the starting point in decision based research. Company data are stored in databases called data warehouses or data marts, containing data from all over the world in international companies.

Data mining uses statistical tools to explore the data for interesting relationships that can be exploited by the business, such as finding a gap in the market or pinpointing areas of increasing demand. This involves pattern discovery and the prediction of trends and behaviours.

Data visualization techniques help the analyst to gain a clear understanding of the data in pictorial form. These may involve the representation of the data in clusters, networks or tree models, or the arrangement of a set of classifications (for example of the characteristics of creditworthy customers). Underlying patterns in the data may be displayed in the form of associations, often based on market analysis. The patterns might also be considered by taking in the time element and presenting a sequence based analysis. More complex



mining operations employ fuzzy logic, genetic algorithms and fractal based transformations.

#### META-ANALYSIS

**Meta-analysis** consists of making an analysis of the results of a number of results of previous research – an analysis of a collection of analyses, hence ‘meta’-analysis. This is not the same as a literature review, as it is a statistical analysis of the accumulated data from the results of previous studies rather than a commentary and critical appraisal of the research projects and their outcomes.

The stages in this type of analysis are to:

- 1 Define the issue to be investigated – e.g. the effects of class size on student learning.
- 2 Collect the studies according to issue defined at the outset. These may be published or unpublished research results. Care must be taken to select similar studies of good quality, to avoid very different types and qualities of data.
- 3 Find common methods of measurement of variables used to detect significant relationships.
- 4 Select the purpose of analysis of results data, either a comparison to detect how much the results of the studies varied, or to track a particular variable across all the studies and accumulate the results to indicate its importance.
- 5 Carry out the statistical analysis to compare or compute significance levels. An estimation of the size of the effect of one variable on another is another aspect to be explored. Sometimes it may be useful to divide the studies into sub-groups to clarify the outcomes.
- 6 Report the results and discuss the limitations of the research and recommend further research in the subject.

There are plenty of problems associated with meta-analysis. The main one is that the wide range of methods and statistical techniques used in the various studies make comparison and combination difficult to justify. Another is that the published works only record successful outcomes where statistically significant results are achieved, leaving all the other test results unrecorded. This can lead to an over-optimistic

result in the meta-analysis. Despite these, it is a useful way to assimilate the results of numerous studies dedicated to one issue.

## COLLECTING PRIMARY DATA

Although we are surrounded by data, in fact, bombarded with them every day from the TV, posters, radio, newspapers, magazines and books, it is not so straightforward to collect the correct data for your purposes. It needs a plan of action that identifies what data you need, where the necessary data are to be found and what are the most effective and appropriate methods of collecting that data. You will need to consider whether to get information from people, in single or large numbers, or whether to observe and/or measure things or phenomena. You may need to do several of these, for example in sport, you may need to examine both the people, their attitudes and fitness, and the equipment they use, or in commerce, you may be looking at both the product and the production system as well as marketing, sales and distribution – the people and the processes.

There are several basic methods used to collect primary data; here are the main ones:

- asking questions
- conducting interviews
- observing without getting involved
- immersing oneself in a situation
- doing experiments
- manipulating models.

Different disciplines use one or several of these ways to collect data, and customize them to cater for their needs. For example, experiments in social research might be conducted in a natural setting well away from a laboratory, while chemical research might require absolutely controlled conditions to be successful.

Before we explore the different methods of data collection, we need to consider the issue of selecting who to question or what to examine when faced with a large number of cases.

## SAMPLING

If you want to get information about a large group of individual people or things, for example, students or cars, it is normally impossible to get all of them to answer your questions or to examine all the things – it would take much too long and be far too expensive. The solution is to just ask or examine some of them and hope that the data you get are **representative** (or typical) of all the rest. If the data you collect really are the same as you would get from the rest, then you can draw conclusions from those answers which you can relate to the whole group. This process of selecting just a small group of cases from out of a large group is called **sampling**.

In other situations you may want to examine the dynamics within different groups rather than individuals, for instance the social interactions within different neighbourhoods or the processes within different production systems. Here, the individual cases will be groups rather than the single people or the things that make them up. Again, if you want to draw conclusions about all the cases, you will need to select a few typical ones for detailed study, called '**case studies**' using a sampling method. However, in some situations all the cases may be unique, for example different ethnic groups, so it is not possible to find a representative sample. What you can do then is to take a comparative approach by selecting several very different ones, e.g. those showing extreme characteristics, those at each end of the spectrum and perhaps one that is somewhere in the middle and compare their characteristics. Alternatively, choose an 'exemplifying' or 'critical' case, one that will provide a good setting for answering the research questions. Results from individual groups might then be compared rather than making generalizations about all the groups. Both quantitative and

qualitative methods are appropriate for case study designs, and multiple methods of data collection are often applied.

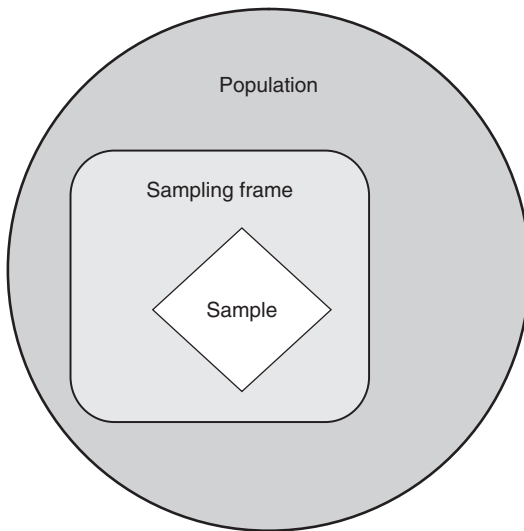


Figure 8.1 Sampling frame in relation to population and sample

When doing a survey, the question inevitably arises: how representative is the sample of the whole population, in other words, how similar are characteristics of the small group of cases that are chosen for the survey to those of all of the cases in the whole group? When we talk about **population** in research, it does not necessarily mean a number of people, it is a collective term used to describe the total quantity of things (or cases) of the type which are the subject of your study. So a population can consist of certain types of objects, organizations, people or even events. Within this population, there will probably be only certain groups that will be of interest to your study, for instance, of all school buildings only those in cities, or of all limited companies, only small to medium sized companies. This selected category is your **sampling frame**. It is from this sampling frame that the sample is selected, as shown in Figure 8.1.

Difficulties are encountered if the characteristics of the population are not known, or if it is not possible to reach sectors of it.

Non-representative samples cannot be used to make accurate generalizations about the population. Populations can have the following characteristics:

- homogeneous – all cases are similar, e.g. bottles of beer on a production line;
- stratified – contain strata or layers, e.g. people with different levels of income: low, medium, high;
- proportional stratified – contains strata of known proportions e.g. percentages of different nationalities of students in a university;
- grouped by type – contains distinctive groups, e.g. of apartment buildings – towers, slabs, villas, tenement blocks;
- grouped by location – different groups according to where they are e.g. animals in different habitats – desert, equatorial forest, savannah, tundra.

It is generally accepted that conclusions reached from the study of a large sample are more convincing than those from a small one. However, the preference for a large sample must be balanced against the practicalities of the research resources, i.e. cost, time and effort. If the population is very homogeneous, and the study is not very detailed, then a small sample will give a fairly representative view of the whole. If statistical tests are to be used to analyse the data, there are usually minimum sample sizes specified from which any significant results can be obtained. The size of the sample also should be in direct relationship to the number of variables to be studied.

No sample will be exactly representative of a population. If different samples, using identical methods, are taken from the same population, there are bound to be differences in the mean (average) values of each sample owing to the chance selection of different individuals. The measured difference between the mean value of a sample and that of the population is called the **sampling error**, which will lead to bias in the results. **Bias** is the unwanted distortion of the results of a survey due to parts of the population being more strongly represented than others.

There are basically two types of sampling procedure:

- 1 Probability sampling
- 2 Non-probability sampling

Probability sampling techniques give the most reliable representation of the whole population, while non-probability techniques, relying on the judgement of the researcher or on accident, cannot generally be used to make generalizations about the whole population.

#### PROBABILITY SAMPLING

This is based on using random methods to select the sample. Populations are not always quite as uniform or one-dimensional as, say, a particular type of component in a production run, so simple random selection methods are not always appropriate. The select procedure should aim to guarantee that each element (person, group, class, type etc.) has an equal chance of being selected and that every possible combination of the elements also has an equal chance of being selected. Therefore, the first question to be asked is about the nature of the population: is it homogeneous or are there distinctly different classes of cases within it, and if so, how are they distributed within the population (e.g. are they grouped in different locations, found at different levels in a hierarchy or are they all mixed up together)? Specific techniques are used for selecting representative samples from populations of the different characteristics, such as simple random sampling, stratified sampling, cluster sampling etc.

#### NON-PROBABILITY SAMPLING

Non-probability sampling is based on selection by non-random means. This can be useful for certain studies, for example, for quick surveys or where it is difficult to get access to the whole population, but it provides only a weak basis for generalization. There is a variety of techniques that can be used, such as **accidental sampling**, **quota sampling** and snowball technique.

#### DATA COLLECTION METHODS

The following sections explore the different methods of primary data collection and briefly describe how they might be applied.

## ASKING QUESTIONS

Asking questions is an obvious method of collecting both quantitative and qualitative information from people. Questionnaires are a particularly suitable tool for gaining quantitative data but can also be used for qualitative data. This method of data collection is usually called a **survey**. Using a questionnaire enables you to organize the questions and receive replies without actually having to talk to every respondent. As a method of data collection, the questionnaire is a very flexible tool, that has the advantages of having a structured format, is easy and convenient for respondents, and is cheap and quick to administer to a large number of cases covering large geographical areas. There is also no personal influence of the researcher, and embarrassing questions can be asked with a fair chance of getting a true reply. However, they do require a lot of time and skill to design and develop. They need to be short and simple to follow, so complex question structures are not possible. Not everyone is able to complete questionnaires.

There are three methods of delivering questionnaires, personally and by post or through the Internet. The advantages of personal delivery are that respondents can be helped to overcome difficulties with the questions, and can be persuaded and reminded in order to ensure a high response rate. Obviously, there are problems both in time and geographical location that limit the scope and extent to which this method of delivery can be used. Postal questionnaires are used when a large number of responses are sought, particularly when they are in different locations. The correct address for each respondent is required and postal costs must also be taken into account. The rate of response for postal questionnaires is difficult to predict or control, particularly if there is no system of follow-up. Internet questionnaires are the cheapest and least time consuming method of delivery. Although it is easy to get a blanket coverage by random delivery, response rates tend to be very low and it is difficult to know how representative the sample will be. For more structured deliveries, email addresses are required to pinpoint responses from the chosen sample. Follow up reminders are easily administered.

There are basically two question types:

- 1 **Closed format questions.** The respondent must choose from a set of given answers. These tend to be quick to answer, easy to code



and require no special writing skills from the respondent. However, they do limit the range of possible answers.

Example: Here are important qualities a prime minister should possess. Number them 1–5 in order of importance – 1 being the most important.

Honesty Humour Intelligence Consistency Experience.

- 2 **Open format questions.** The respondent is free to answer in their own content and style. These tend to permit freedom of expression and allow the respondents to qualify their responses. This freedom leads to a lack of bias but the answers are more open to researcher interpretation. They are also more demanding and time consuming for respondent and more difficult to code.

Example: What are the most important qualities a prime minister should possess?

It is common practice to pre-test the questionnaire on a small number of people before it is used in earnest. This is called a **pilot study**.

Questionnaires are commonly used in disciplines that are concerned with people, particularly as part of society. Research in social sciences, politics, business, healthcare etc. often needs to gain the opinions, feelings and reactions of a large number of people, most easily done with a survey. When the government wants to get answers from everyone in the population, then this kind of survey is called a **census**.

#### ACCOUNTS AND DIARIES

Asking people to relate their account of a situation or getting them to keep diaries is perhaps the most open form of a questionnaire. These qualitative data collection methods are used to find information on people's actions and feelings by asking them to give their own interpretation, or account, of what they experience. Accounts can consist of a variety of data sources: people's spoken explanations, behaviour (such as gestures), personal records of experiences and conversations, letters and personal diaries. As long as the accounts are authentic, there should be no reason why they cannot be used as an argued explanation of people's actions.

For example: Trainee nurses are asked to keep a diary of all their activities during a week-long work experience session in a hospital. They are asked to record what they have done in each hour of their working days, and make comments on what they have learned at the end of each day.

Since the information must come directly from the respondents, you must take care to avoid leading questions, excessive guidance and other factors which may cause distortion. You can check the authenticity of the accounts by cross-checking with other people involved in the events, examining the physical records of the events (e.g. papers, documents etc.) and checking with the respondents during the account gathering process. You will need to transform the collected accounts into working documents that can be coded and analysed.

#### CONDUCTING INTERVIEWS

While questionnaire surveys are relatively easy to organize they do have certain limitations, particularly in the lack of flexibility of response. Interviews are more suitable for questions that require probing to obtain adequate information.

The use of interviews to question samples of people is a very flexible tool with a wide range of applications. Three types of interview are often mentioned:

- 1 **Structured interview** – standardized questions read out by the interviewer according to an interview schedule. Answers may be closed format.
- 2 **Unstructured interview** – a flexible format, usually based on a question guide but where the format remains the choice of the interviewer, who can allow the interview to ‘ramble’ in order to get insights into the attitudes of the interviewee. No closed format questions.
- 3 **Semi-structured interview** – one that contains structured and unstructured sections with standardized and open type questions.

Though suitable for quantitative data collection, interviews are particularly useful when qualitative data are required. Interviews can be used for subjects, both general or specific in nature and even, with the correct preparation, for very sensitive topics. They can be

one-off or repeated several times over a period to track developments. The interviewer is in a good position to judge the quality of the responses, to notice if a question has not been properly understood and to encourage the respondent to be full in his/her answers.

**Face-to-face interviews** can be carried out in a variety of situations: in the home, at work, outdoors, on the move (e.g. while travelling) and can be used to interview people both singly and in groups. Using visual signs, such as nods, smiles etc., helps to get good responses. **Focus groups** can be seen as a type of group interview, but one that tends to concentrate in depth on a particular theme or topic with an element of interaction. The group is often made up of people who have particular experience or knowledge about the subject of the research, or those that have a particular interest in it e.g. consumers or customers. **Telephone interviews** avoid the necessity of travelling to the respondents and can therefore be carried out more quickly than face-to-face. However, you cannot use visual aids to explain questions, and there are no visual clues. For interviewing very busy people, it is best to pre-arrange a suitable time to ring – modern communications technology is making it more and more difficult to talk with an actual person on the phone!

Interviews can be audio recorded in many instances in order to retain a full, uninterpreted record of what was said. However, in order to analyse the data, the recording will have to be transcribed – a lengthy process if done in full. Recording and transcribing interviews do not rely on memory and repeated checking of what was said is possible. The raw data are also available for different analysis by others.

#### OBSERVING WITHOUT GETTING INVOLVED

This is a method of gathering data through observation rather than asking questions. The aim is to take a detached view of the phenomena, and be 'invisible', either in fact or in effect (i.e. by being ignored by people or animals). When studying humans or animals, this detachment assumes an absence of involvement in the group even if the subjects are aware that the observation is taking place. Observation can be used for recording data about events and activities, and the nature or conditions of objects, such as buildings or artefacts. This type of observation is often referred to as a survey (not to be

confused with a questionnaire survey), and can range from a preliminary visual survey to a detailed survey using a range of instruments for measurement.

Observation is a basic data collecting activity for many branches of research, particularly the natural and technical sciences, for example, observing the results of experiments, the behaviour of models, the appearance of materials, plants and animals. It is also useful in the social sciences where people and their activities are studied. Observation can record how people react to questions, and whether they act differently to what they say or intend. They can sometimes demonstrate their understanding of a process better by their actions than by verbally explaining their knowledge. Observation can be used to record both quantitative and qualitative data.

Observation is not limited to the visual sense. Any sense – e.g. smell, touch, hearing – can be involved, and these need not be restricted to the range perceptible by the human senses. A microscope or telescope can be used to extend the capacity of the eye, just as a moisture meter can increase sensitivity to the feeling of dampness. Instruments have been developed in every discipline to extend the observational limits of the human senses.

For example: A researcher studying primary education methods records every hour how the space is being used in an infants' open plan classroom. This is done by describing and sketching the location of the activities on a plan drawing of the room, listing the equipment used and the number of children engaged in each activity.

Observations of objects can be a quick and efficient method of gaining preliminary knowledge or making a preliminary assessment of its state or condition. For example, after an earthquake, a quick visual assessment of the amount and type of damage to buildings can be made before a detailed survey is undertaken. On the other hand, observation can be very time consuming and difficult when the activity observed is not constant (i.e. much time can be wasted waiting for things to happen, or so much happens at once that it is impossible to observe it all and record it). Instrumentation can sometimes be devised to overcome the problem of infrequent or spasmodic activity e.g. automatic cameras and other sensors.

Events and objects are usually complicated, so it is necessary to identify the variables that are to be studied, and to concentrate on

these. It is important to devise a simple and efficient method of recording the information accurately, particularly when recording frequent or fast-moving events. Instrumentation should be used when appropriate; those that make an automatic record of their measurements are to be preferred in many situations.

#### IMMERSING ONESELF IN A SITUATION

This is a process of gathering primary data that not only involves observation, but also **experience** in every sense of the word. It is based on the techniques devised by anthropologists to study social life and cultural practices of communities by immersing themselves in the day-to-day life of their subjects.

Obviously, the observations must be carried out in the natural setting. The researcher tries to 'fit in' as much as possible so as to see and understand the situation from the viewpoints of the group being studied. At its most extreme, the subjects of the study will not be aware that they are being observed. Covert methods are used to disguise the role of the observer.

For example: A researcher wants to find out what the group dynamics are amongst homeless people living on the streets in a large city. He/she poses as a homeless person and joins them in their habitual locations at night, and makes notes on the observations about relationships between the people each day.

In anthropological studies, data are usually collected in phases over an extended time. Frequent behaviours, events etc. tend to be focused on to permit the development of understanding of their significance. Although mostly associated with qualitative approaches there is no reason why quantitative data are not relevant.

Much of this kind of research is based on **grounded theory** which takes the approach of collecting data in order to evolve theory rather than to test or refine an existing one. The main emphasis is on a continuous data collection process interlaced with periodic pauses for analysis. The analysis is used to tease out categories in the data on which the subsequent data collection can be based. This reciprocal procedure continues until these categories are 'saturated', i.e. the new data no longer provide new evidence. From these results, concepts and theoretical frameworks can be developed. This gradual emergence and refinement of theory based on observations is the basis for the 'grounded' label of this approach.

## DOING EXPERIMENTS

Data can be collected about processes by devising experiments. An experiment aims to isolate a particular event so that it can be investigated without disturbance from its surroundings. They are primarily aimed at gaining data about causes and effects – to find out what happens if you make a change, why and when it happens and how.

Experiments are used in many different subject areas, whether these are primarily to do with how things (objects, substances, systems, etc.) interact with each other, or how people interact with things, and even how people interact with other people. Although experiments are commonly associated with work in laboratories where it is easiest to impose control, they can be carried out in almost any other location. It may not even be possible to move the event to be studied into the laboratory, or doing so might unduly influence the outcome of the experiment. For example, some events in nature or social occurrences are so rooted in their context that they cannot be transferred to the laboratory. The design of experiments and models depends very much on the type of event investigated, the sort of variables involved, and the level of accuracy and reliability aimed at practical issues such as time and resources available.

The first step is to identify the essential factors which create the event so that all others can be eliminated or neutralized, something that may be difficult if the context is complicated and you do not know what all the variables are and how they act or are being acted upon. Data are generated when you isolate and manipulate one or more variables that supply the causes (independent variables) and observe the effects of this manipulation on variables that are affected by the causes (dependent variables).

It is important to check that the assumptions you make on which you base your experiment are valid. You can do this by introducing a control group, an identical setup that runs parallel to your experiment, but in which you do not manipulate the independent variables. A common example of this is the use of placebo pills for one group of patients when gauging the effect of a drug on another group. The condition of the patients taking the placebos acts as a 'baseline' against which to measure the effects of the drug on the condition of the other patients.

*INTERNAL AND EXTERNAL VALIDITY*

In order to be able to generalize the results beyond the confines of the experiment itself, the experiment should really reflect the situation in the real world – i.e. it should possess both **internal validity** (the extent to which the ideas about cause and effect are supported by the study) and **external validity** (the extent to which findings can be generalized to populations or to other settings).

Internal validity can be undermined by faulty sampling of test materials, the interference of unnoticed factors, deterioration or change in the nature of materials during or between tests and faulty instruments. External validity can also be compromised by faulty sampling and unnoticed interfering factors, as well as poor description of the process which makes replicating the experiment impossible, and, when people are the subject of the experiment, changes in the way they act because of the artificiality of the experimental situation.

*LABORATORY AND FIELD EXPERIMENTS*

It is not always easy to distinguish between laboratory and field experiments, for example, a social science experiment can take place in realistic simulations of a room in a laboratory, or use a normal setting as a laboratory. There may also be a sense of artificiality in a natural setting when people are organized for the purposes of the experiment, or people are just aware that they are subjects of investigation.

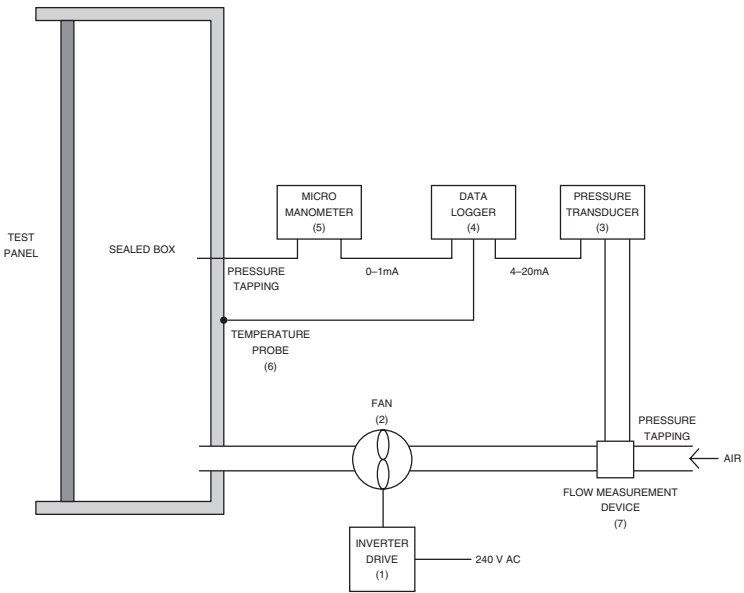


Figure 8.2 Laboratory experiment: testing the airtightness of a cladding system

Laboratory experiments have the advantage of providing a good degree of control over the environment, and of studying the effects on the material or subjects involved. Figure 8.2 shows a laboratory experiment set up to test how much air gets through the joints in a metal cladding system for buildings. Air pressure is raised in the box under the cladding and instruments measure how much pressure is lost due to leakage. This sort of arrangement is ideal when experimenting on inanimate materials, but suffers several possible shortcomings when humans are involved. The experiment can appear too artificial and oversimplify the situation and the experimenter and subjects can introduce bias by their subjective reactions.

In field experiments, subjects are more likely to react and behave normally rather than being affected by artificial conditions. They may also be more willing to take part in the research because they

don't need to attend at a particular place and time. External validity is obviously more easily achieved when the experiments are carried out in normal life settings. However, the lack of control and ethical issues can raise some problems. Figure 8.3 shows a hospital waiting area before and after internal planting is added. This was done for an experiment to find out if internal planting reduced people's anxiety while they were waiting for a consultation or treatment.

#### TYPES OF EXPERIMENTS

Experiments are commonly categorized into four types:

- 1 **True experimental designs** are characterized by careful random selection of all the cases to be tested, and the use of a control group parallel to the experimental group, which is used to compare outcomes. The groups are also tested before the experiment to determine their properties. All the variables are carefully controlled or neutralized. These are the most reliable designs of experiments, and the data gathered can be relied on to make generalizations.
- 2 **Quasi-experimental designs** are used when random selection of groups cannot be achieved. However, the control group and the experimental group are matched as nearly as possible. If a control group is not used, then parallel groups are experimented on to compare the consistency of the outcomes. The results of these designs are not as reliable as true experimental designs.
- 3 **Pre-experimental designs** do not have control groups to compare with those that have been experimented on, and some do not even test the experimental group before the experiment. Random selection of the samples may also be omitted. These designs are used when it is not possible to fulfil the conditions of true experimental designs, but the lack of control of the variables can seriously affect the outcomes.
- 4 **Ex post facto** is not really an experimental approach in that the investigation begins after the event has occurred so no control over the event is possible. The search for the cause of the event, e.g. a plane crash or the outbreak of an unknown disease, relies on the search for, and analysis of, relevant data. The most likely cause has to be discovered from amongst all possible causes, so there are many opportunities to search in the wrong area!

#### MANIPULATING MODELS OR SIMULATIONS

A model, like an experiment, aims to isolate and simplify an event in order to inspect it in detail and gain useful data. The difference is that

models only provide a representation of the event – a simulation – that shows relationships between variables. Models are used to mimic a phenomenon (rather than isolating it as in an experiment) in a form that can be manipulated, in order to obtain data about the effects of the manipulations. The purpose of a model can be to describe a phenomenon, to serve as a structure for organizing and analysing data, or to explore or test a hypothesis.

As with experiments, it is essential to understand the system that lies behind the phenomena to be modelled and what are the important variables and how they interact. The actual form of the model can be diagrammatic, physical, or mathematical. Qualitative models emphasize the relationships between entities without trying to quantify them, while quantitative models not only describe the relationships but also accurately measure their magnitude. It is common practice to check the accuracy of the model by comparing the data obtained by using a model against data collected from the actual case that it is modelling.

There are three basic types of models:

- 1 diagrammatic models
- 2 physical models
- 3 mathematical (or simulation) models.

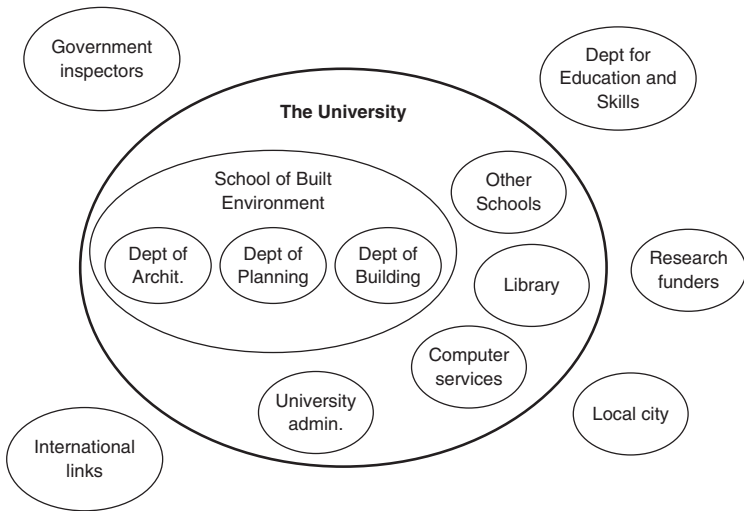


Figure 8.4 Diagrammatic model: systems map of part of a university

**Diagrammatic models** show the interrelationships of the variables in a system on paper. The most familiar type is a technical drawing or a map. Others portray the components of a system and its environment, or show the causal or other links between variables in a system, charts an organization or even provides a diagrammatic record of a person's thoughts about a particular issue or situation. Diagramming is commonly used to explore a real-life situation in order to investigate what the important variables in the system are and the manner in which they influence each other. It promotes understanding of complicated situations and interrelationships. The understanding gained can often then be used in the construction of a physical or mathematical model. Figure 8.4 is a simple map of the School of the Built Environment within Oxford Brookes University system.

**Physical models** are three-dimensional representations of an object at a reduced scale. Models devised for the purpose of research are specifically designed to test the variables that are central to the

problem being investigated. Physical models can be qualitative or quantitative in nature. One of the main problems when designing physical models for producing quantitative data is the problem of scaling. It raises the question: do materials and forms of energy behave identically at any scale? Usually, the answer is no, so the different behaviour of materials at small scale must be compensated for. To overcome the scaling problem, full-scale prototypes are used where possible. Figure 8.5 shows a three-section wooden model of the Festival Hall in London made to scale in order to test the acoustic qualities of the internal space. The sounds, materials and reverberation times all had to be scaled to take account of the smaller size.

**Mathematical models** or **simulations** show the effects of different inputs into a system and predict the resultant outcomes. They are used to predict the weather, predict the performance of materials under certain conditions, and combined with physical models can mimic flying an aeroplane. They are invariably quantitative models and are divided into two major categories, deterministic and stochastic models. These categories relate to the predictability of the

input–deterministic models deal only with predetermined inputs within a closed system, stochastic models are designed to deal with unpredictable inputs such as the effect of chance or of influences from outside

the system being modelled. The computer is an invaluable tool in the construction of mathematical models. Spreadsheet programs provide a systematic two-dimensional framework for devising models, and furnish facilities for cross calculations, random number generation, setting of variable values, and the build-up of series of formulae.

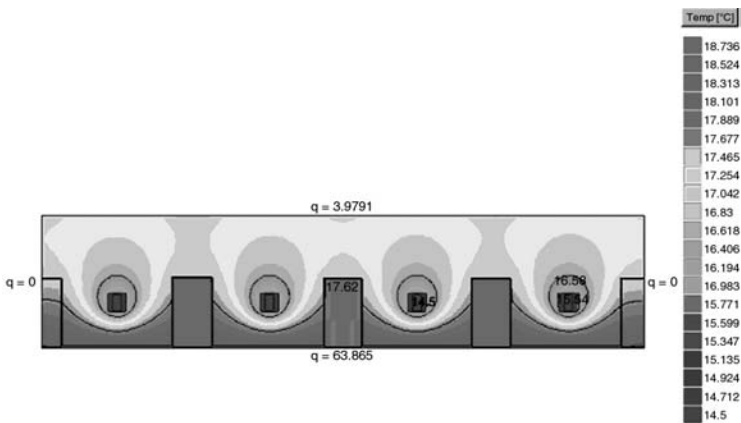


Figure 8.6 Computer building simulation output of heatflow through a concrete floor slab

Figure 8.6 shows the output from a simulation model that shows the heat flow through a concrete floor slab cooled by buried cold water pipes. You can see by the shaded areas that the slab is coldest around the pipes.

The essential qualities of any model are that it should be constructed for a particular purpose and that it should, in some way, reduce the complexity of the real situation. It is important to clearly explain the purposes of the model and the assumptions on which it is built and the scope of applicability. The same object or event can be modelled in a number of different ways. Models are never perfect because of the limitations faced by the researcher. These limitations are lack of complete understanding of the variables, inaccuracies of the way their interactions are modelled, and the cumulative effect of small errors in the initial settings of the model.

## QUANTITATIVE DATA ANALYSIS

Quantitative analysis deals with data in the form of numbers and uses mathematical operations to investigate their properties. The levels of measurement used in the collection of the data i.e. nominal, ordinal, interval and ratio, are an important factor in choosing the type of analysis that is applicable, as is the numbers of cases involved. Statistics is the name given to this type of analysis, and is defined in this sense as follows:

Some of the primary purposes of quantitative analysis are to:

- measure
- make comparisons
- examine relationships
- make forecasts
- test hypotheses
- construct concepts and theories
- explore
- control
- explain.

Most surveys result in quantitative data, e.g. numbers of people who believed this or that, how many children of what age do which sports, levels of family income, etc. However, not all quantitative data originate from surveys. For example, content analysis is a specific method



of examining records of all kinds (e.g. documents or publications, radio and TV programmes, films, etc.) that entails counting.

You do not have to be a mathematician to use statistical techniques, as user-friendly computer packages (such as Excel and SPSS – Statistical Package for the Social Sciences) will do all the calculations and presentations for you. However, you must be able to understand the relevance and function of the various tests and displays to your own sets of data.

The range of statistical tests is enormous, so only some of the most often used are mentioned here. An important factor to be taken into account when selecting suitable statistical tests is the number of cases about which you have data. Generally, statistical tests are more reliable the greater the number of cases. Usually, more than about twenty cases are required to make any sense of the analysis, though some tests are designed to work with less.

## CREATING A DATA SET

In order to manipulate the data, they should be compiled in an easily read form. Although the data will have been organized as part of the collection process, further compilation may be needed before analysis is possible. If the data on the forms cannot be machine read, then it will be necessary to enter the data manually. The fewer steps required in the creation of data sets, the fewer possibilities there are for errors to creep in. Adding codes to response choices on the questionnaire sheet will simplify the transfer of data.

The use of rows and columns on a spreadsheet is the most common technique. A row is given to each record or case and each column is given to a variable, allowing each cell to contain the data for the case/variable. The data might be in the form of integers (whole numbers), real numbers (numbers with decimal points) or categories (nominal units e.g. gender, of which 'male' and 'female' are the elements). Missing data also need to be indicated, distinguishing between genuine missing data and a 'don't know' response. It is easy to make mistakes in the rather tedious process of transferring data. It is therefore important to check on the accuracy of the data entry. Figure 9.1 shows an example of a simple data spreadsheet with personal details of a range of cases. The numbers are shortcuts to the values listed in the key.

## PARAMETRIC AND NON-PARAMETRIC STATISTICS

The two major classes of statistics are parametric and non-parametric statistics. You need to understand the meaning of a **parameter** in order to appreciate the difference between these two types.

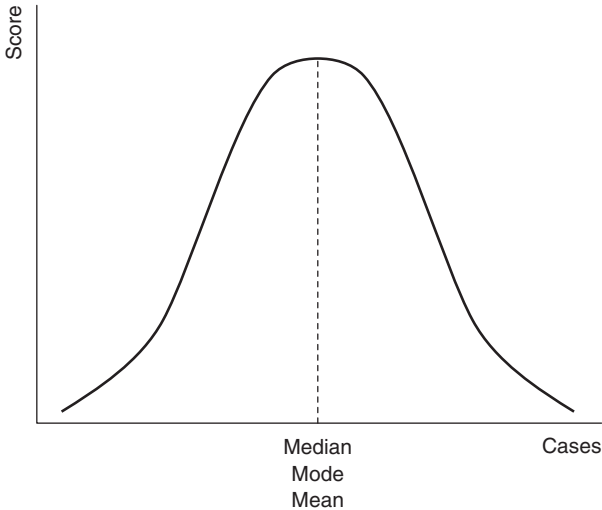


Figure 9.2 Gaussian curve

A parameter of a population (i.e. the things or people you are surveying) is a constant feature that it shares with other populations. The most common one is the '**bell**' or '**Gaussian**' curve of normal frequency distribution (see Figure 9.2).

This parameter reveals that most populations display a large number of more or less 'average' cases with extreme cases tailing off at each end. Although the shape of this curve varies from case to case (e.g. flatter or steeper, lopsided to the left or right) this feature is so common amongst populations that statisticians take it as a constant – a basic parameter. Calculations of parametric statistics are based on this feature. Not all data are parametric, i.e. populations sometimes do not behave in the form of a Gaussian curve.

Data measured by nominal and ordinal methods will not be organized in a curve form. Nominal data tend to be in groups (e.g. this is a cow

or a sheep or goat), while ordinal data can be displayed in the form of a set of steps (e.g. the first, second and third positions on a winners' podium). For those cases where this parameter is absent, non-parametric statistics may be applicable.

Non-parametric statistical tests have been devised to recognize the particular characteristics of non-curve data and to take into account these singular characteristics by specialized methods. In general, these types of test are less sensitive and powerful than parametric tests; they need larger samples in order to generate the same level of significance.

## STATISTICAL TESTS (PARAMETRIC)

There are two classes of parametric statistical tests: **descriptive** and **inferential**. Descriptive tests will reveal the 'shape' of the data in the sense of how the values of a variable are distributed. Inferential tests will suggest (i.e. infer) results from a sample in relation to a population.

Distinction is also made between the number of variables considered in relation to each other:

- **Univariate analysis** – analyses the qualities of one variable at a time. Only descriptive tests can be used in this type of analysis.
- **Bivariate analysis** – considers the properties of two variables in relation to each other. Inferences can be drawn from this type of analysis.
- **Multivariate analysis** – looks at the relationships between more than two variables. Again, inferences can be drawn from results.

#### UNIVARIATE ANALYSIS

A range of properties of one variable can be examined using the following measures.

#### FREQUENCY DISTRIBUTION

Usually presented as a table, **frequency distribution** simply shows the values for each variable expressed as a number and as a percentage of the total of cases (see Figure 9.3).

#### MEASURE OF CENTRAL TENDENCY

**Central tendency** is one number that denotes various ‘averages’ of the values for a variable. There are several measures that can be used, such as the arithmetic mean (average), the median (the mathematical middle between the highest and lowest value) and the mode (the most frequently occurring value). Normal distribution is when the mean, median and mode are located at the same value. This produces a

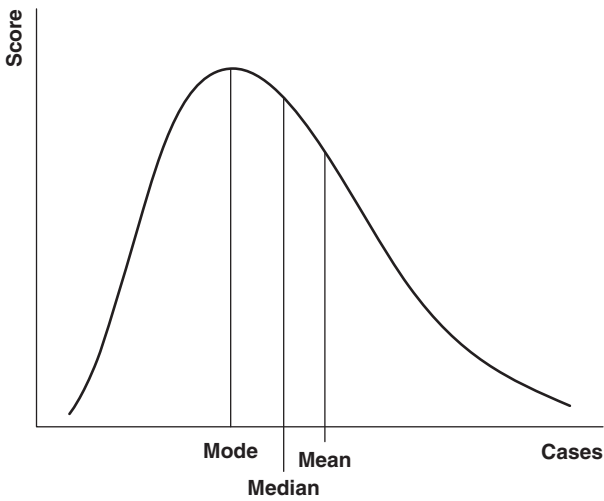
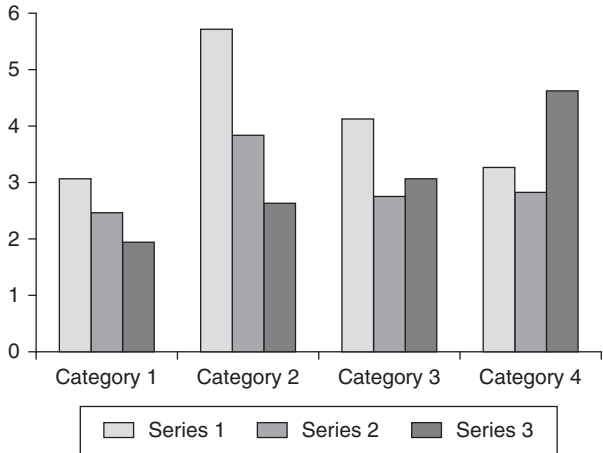
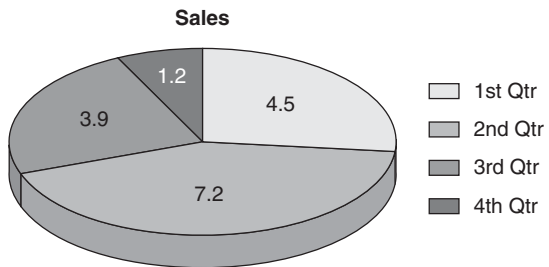


Figure 9.4 Skewness and measures of central tendency

symmetrical curve (see Figure 9.2). Skewness occurs when the mean is pushed to one side of the median (see Figure 9.4). If there are two modes to each side of the mean and median points, then it is a bimodal distribution. The curve will have two peaks and a valley between.

#### MEASURES OF DISPERSION (OR VARIABILITY)

The above measures are influenced by the nature of dispersion of the values, how values are spread out or are bunched up, and the presence of solitary extreme values. Measurements of dispersion can be expressed in several ways: range (the distance between the highest and lowest value), interquartile range (the distance between the top and bottom quarters of the values) and other more mathematical measures such as standard deviation and standard error. These measures do not mean much on their own unless they are compared with some expected measures or those of other variables.

The computer programs provide a choice of display options to illustrate the above measures. The most basic is a summary table of descriptive statistics which gives figures for all of the measures. However, more graphical options make comparisons between variables clearer, some of the simpler being:

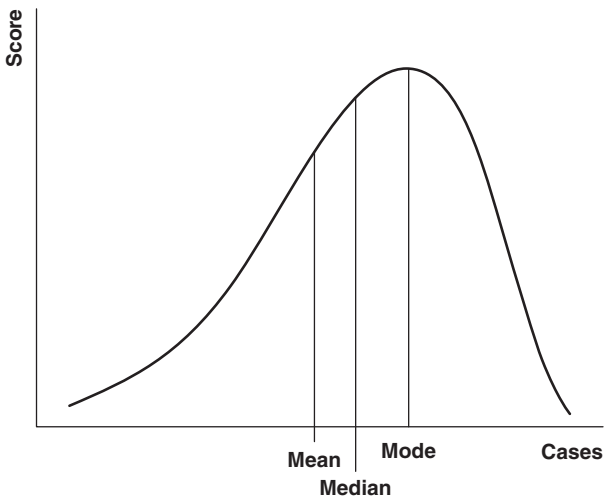
- **Bar graph** – shows the distribution of nominal and ordinal variables. The categories of the variables are along the horizontal axis (x axis), the values on the vertical axis (y axis). The bars should not touch each other.
- **Pie chart** – shows the values of a variable as a section of the total cases (like slices of a pie). The percentages are also usually given.
- **Standard deviation error bar** – this shows the mean value as a point and a bar above and below that indicates the extent of one standard deviation.

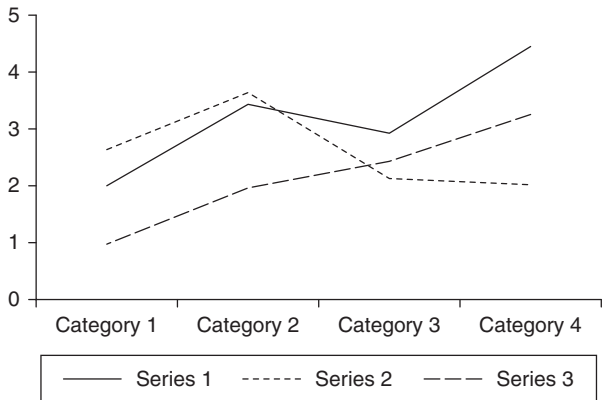


Figure 9.5 Charts and diagrams

Charts and diagrams are far easier to understand quickly by the non-expert than are results presented as numbers (see Figure 9.5).

#### BIVARIATE ANALYSIS

**Bivariate analysis** considers the properties of two variables in relation to each other. The relationship between two variables is of common

Standard deviation error bar

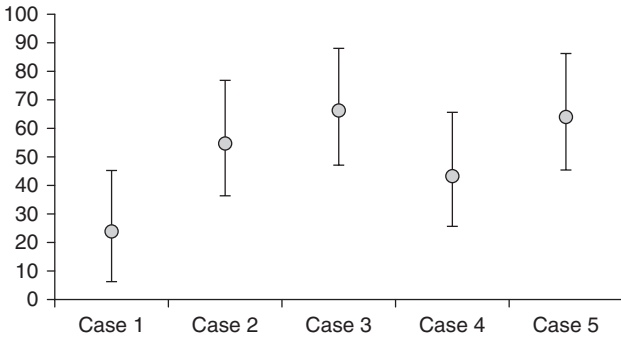


Figure 9.5 (Continued)

interest in the social sciences, e.g. does social status influence academic achievement?; are boys more likely to be delinquents than girls?; does age have an effect on community involvement?; etc. There are various methods for investigating the relationships between two variables.

An important aspect is the different measurement of these relationships, such as assessing the direction and degree of association, statistically termed **correlation coefficients**. The commonly used coefficients assume that there is a linear relationship between the two variables, either positive or negative. In reality, this is seldom achieved, but degrees of correlation can be computed, how near to a straight line the relationship is.

A positive relationship is one where more of one variable is related to more of another, or less of one is related to less of another. For example, more income relates to more political power, or less income relates to less political power. A negative relationship is one where more of one variable is related to less of another or the other way round. For example, more income relates to less anxiety, less income relates to more anxiety. Note that detecting a relationship does not mean you have found an influence or a cause, although it may be that this is the case. Again, graphical displays help to show the analysis.

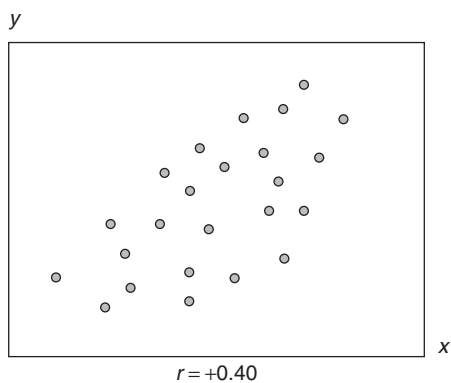
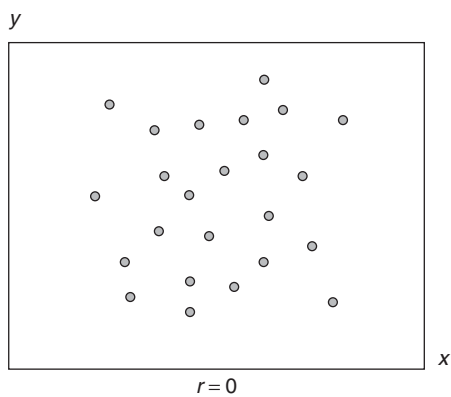
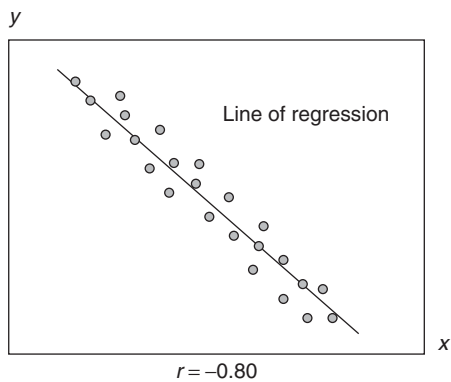


Figure 9.6 Scattergrams of two variables with different levels of relationships

**Scattergrams** are a useful type of diagram that graphically shows the relationship between two variables by plotting variable data from



cases on a two-dimensional matrix. If the resulted plotted points appear in a scattered and random arrangement, then no association is indicated. If however they fall into a linear arrangement, a relationship can be assumed, either positive or negative. The closer the points are to a perfect line, the stronger the **association**. A line that is drawn to trace this notional line is called the **line of best fit** or **regression line**. This line can be used to predict one variable value on the basis of the other (see Figure 9.6).

**Cross tabulation (contingency tables)** is a simple way to display the relationship between variables that have only a few categories. They show the relationships between each of the categories of the variables in both number of responses and percentages. In addition, the column and row totals and percentages are shown (see Figure 9.7). As an alternative, the display can be automatically presented as a bar-chart.

The choice of appropriate statistical tests that do bivariate analysis depends on the levels of measurement used in the variables. These tests are called by exotic names, e.g. Pearson's correlation coefficient ( $r$ ), used for examining relationships between interval/ratio variables, and Spearman's rho ( $\rho$ ) which is used when both variables are ordinal, or when one is ordinal and the other is interval/ratio.

#### STATISTICAL SIGNIFICANCE

As most analysis is carried out on data from only a sample of the population, the question is raised as to how likely is it that the results indicate the situation for the whole population. Are the results simply occasioned by chance or are they truly representative, i.e. are they **statistically significant**? To estimate the likelihood that the results are relevant to the population as a whole one has to use statistical inference. The most common statistical tool for this is known as the chi-square test. This measures the degree of association or linkage between two variables by comparing the differences between the observed values and expected values if no association were present i.e. those that would be a result of pure chance.

#### ANALYSIS OF VARIANCE

The above tests are all designed to look for relationships between variables. Another common requirement is to look for differences

between values obtained under two or more different conditions, e.g. a group before and after a training course, or three groups after different training courses. There are a range of tests that can be applied to discern the **variance** depending on the number of groups.

- For a single group, say the performance of students on a particular course compared with the mean results of all the other courses in the university you can use the chi-square or the one-group *t*-test.
- For two groups, e.g. comparing the results from the same course at two different universities, you can use the two group *t*-tests, which compares the means of two groups. There are two types of test, one for paired scores, i.e. where the same persons provided scores under each condition, or for unpaired scores where this is not the case.
- For three or more groups e.g. the performance of three different age groups in a test. It is necessary to identify the dependent and independent variables that will be tested. A simple test using SPSS is **ANOVA** (analysis of variance).

The results of the various statistical tests described above are expressed as numbers which indicate the characteristic and strength of the associations.

## MULTIVARIATE ANALYSIS

Multivariate analysis looks at the relationships between more than two variables.

### ELABORATION ANALYSIS

This tests the effect of a third variable in the relationship between two variables, for example the effect of gender on the income and level of education of a group of people. This uses a simple tabular comparison by generating two tables and comparing them.

You can continue the process of producing tables for fourth and fifth variables, but this quickly becomes unwieldy and difficult to achieve enough data in each table to achieve significant results. There are better ways to understand the interactions between large numbers of variables and the relative strength of their influence using **regression** techniques: multiple regression and logistic regression.

### MULTIPLE REGRESSION

This is a technique used to measure the effects of two or more independent variables on a single dependent variable measured on interval or ratio scales, e.g. the effect on income due to age, education, ethnicity, area of living, and gender. Thanks to computer programs such as SPSS, the complicated mathematical calculations required for this analysis are done automatically. Note that it is assumed that there are interrelationships between the independent variables as well, and this is taken into account in the calculations.

### LOGISTIC REGRESSION

This method is a development of multiple regression, that has the added advantage of holding certain variables constant in order to assess the independent influence of key variables of interest. It is suitable for assessing the influence of independent variables on dependent variables measured in nominal scale (e.g. whether a candidate's decision to accept a job was determined by a range of considerations such as amount of income, future promotion prospects, level of enjoyment of corporate life, amount of interest in the duties etc.).

The statistic resulting is an odds ratio (e.g. a candidate who was paid more was 3.1 times as likely to accept the job offer than one that was not, assuming all the other variables were held constant).

## STATISTICAL TESTS (NON-PARAMETRIC)

Statistical tests built around discovering the means, standard deviations etc. of the typical characteristics of a Gaussian curve are clearly inappropriate for analysing non-parametric data that does not follow this pattern. Hence, non-parametric data cannot be statistically tested in the above ways.

Non-parametric statistical tests are used when:

- the sample size is very small;
- few assumptions can be made about the data;
- data are rank ordered or nominal;
- samples are taken from several different populations.

The levels of measurement of the variables, the number of samples, whether they are related or independent are all factors which determine which tests are appropriate. This is perhaps a good place to warn you that computer statistical packages (e.g. SPSS) will not distinguish between different types of parametric and non-parametric data. In order to avoid producing reams of impressive looking, though meaningless, analytical output, it is up to you to ensure that the tests are appropriate for the type of data you have.

Some of the tests that you may encounter are: Kolmogorov-Smirnov (used to test a two-sample case with independent samples, the values of which are ordinal), Kruskal-Wallis (an equivalent of the analysis of variance on independent samples, with variables measured on the ordinal scale), Cramer coefficient (gives measures of association of variables with nominal categories) and Spearman and Kendall (which provide a range of tests to measures association such as rank order correlation coefficient, coefficient of concordance and agreement for variables measured at the ordinal or interval levels).

## QUALITATIVE DATA ANALYSIS

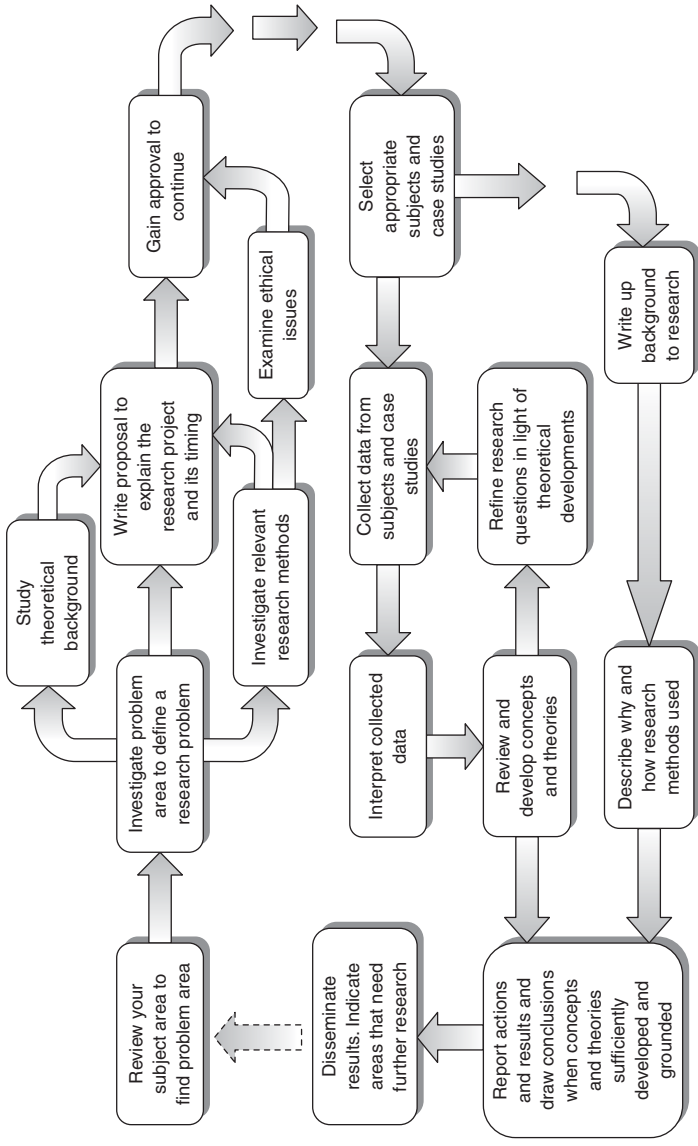


Figure 10.1 Work sequence in qualitative research

It would be convenient if, when doing a research project, every step of the process was completed before moving onto the next in a nice and tidy fashion. However, this rarely happens, particularly if you are an inexperienced researcher learning as you go or are delving into areas of knowledge that are little explored. You will often need to go back and reconsider previous decisions or adjust and elaborate on work as you gain more understanding and knowledge and acquire more skills. But there are also types of research in which a reciprocal process of data collection and data analysis is an essential part of the project. The information gained from analysis of the preliminary data collection leads to better understanding of the situation and helps to determine what further data collection is required. This process is repeated in order to build up an increasingly sophisticated understanding of the subject of the study. Figure 10.1 shows how this works. You will see that the first part of the research process is similar in all research, though in qualitative research the definition of the concepts and process of investigation will be more tentative and explorative than in quantitative research. It is in the data collection and analysis where the main difference lies. You will see the reiterative process of data collection, theory development and refinement of the research questions that indicates where more data collection is required. This process continues until satisfactory evidence is collected

to support the developed theory, which can then lead to drawing conclusions and finalizing the research.

This type of research is based on data expressed mostly in the form of words – descriptions, accounts, opinions, feelings etc. – rather than on numbers. This type of data is common whenever people are the focus of the study, particularly in social groups or as individuals. Frequently the situation or process under study is not sufficiently understood initially in order to determine precisely what data should be collected. Therefore, repeated bursts of data collection and analysis allow adjustments to what is further investigated, what questions are asked and what actions are carried out based on what has already been seen, answered and done. This tends to be a demanding and difficult process prone to uncertainties and doubts, and the analyst is put to the test as much as the data!

Bromley usefully suggests a list of ten steps you should take when carrying out qualitative research (1986: 26):

- Clearly state the research issues or questions.
- Collect background information to help understand the relevant context, concepts and theories.
- Suggest several interpretations or answers to the **research problems or questions** based on this information.
- Use these to direct your search for evidence that might support or contradict these. Change the interpretations or answers if necessary.
- Continue looking for relevant evidence. Eliminate interpretations or answers that are contradicted, leaving, hopefully, one or more that are supported by the evidence.
- ‘Cross examine’ the quality and sources of the evidence to ensure accuracy and consistency.
- Carefully check the logic and validity of the arguments leading to your conclusions.
- Select the strongest case in the event of more than one possible conclusion.
- If appropriate, suggest a plan of action in the light of this.
- Prepare your report as an account of your research.

As you can see in the list of activities, there are strong links between data collection and theory building. Ideally, the theoretical ideas should

develop purely out of the data collected, the theory being developed and refined as data collection proceeds. However, this is difficult to achieve, as without some theoretical standpoint, it is hard to know where to start and what data to collect!

An alternative to this approach is to first devise a theory and then test it through the analysis of data collected by field research. In this case the feedback loops for theory refinement are not present in the process. Even so, theory testing often calls for a refinement of the theory due to better understanding gained by the results of the analysis. There is room for research to be pitched at different points between these extremes in the spectrum.

Although it has been the aim of many researchers to make qualitative analysis as systematic and as 'scientific' as possible, there is still an element of 'art' in dealing with qualitative data. However, in order to convince others of your conclusions, there must be a good argument to support them. A good argument requires high quality evidence and sound logic. In fact, you will be acting rather like a lawyer presenting a case, using a quasi-judicial approach such as used in an enquiry into a disaster or scandal.

Qualitative research is practised in many disciplines, so a range of data collection methods has been devised to cater for the varied requirements of the different subjects, such as: qualitative interviewing, focus groups, participant, discourse and conversation analysis and analysis of texts and documents.

## STEPS IN ANALYSING THE DATA

How is it possible to organize and analyse qualitative data that is in the form of words, pictures and even sounds, and to come to some conclusions about what they reveal? Unlike the well-established statistical methods of analysing quantitative data, qualitative data analysis is still in its early stages. The certainties of mathematical formulae and determinable levels of probability are difficult to apply to the 'soft' nature of qualitative data, which is inextricably bound up with individual human feelings, attitudes and judgements and their interplay in society.

Miles and Huberman (1994: 10–12) suggested that there should be three concurrent flows of action:

- 1 data reduction;
- 2 data display;
- 3 conclusion drawing/verification.

An awkward mass of information that is normally collected to provide the basis for analysis cannot be easily understood when presented as extended text. Information in text is dispersed, sequential rather than concurrent, bulky and difficult to structure. Our minds are not good at processing large amounts of information, preferring to simplify complex information into patterns and easily understood configurations. Therefore data reduction through coding, clustering and summarizing provides the first step to simplification, followed by arranging the compacted data into diagrams and tables which can display the data in a way that enables you to explore relationships and gauge the relative significances of different factors.

#### PRELIMINARY ANALYSIS DURING DATA COLLECTION

The process of **data reduction** and analysis should be a sequential and continuous procedure, simple in the beginning stages of the data collection, and becoming more complex as the project progresses. When doing field research, you should keep a critical attitude to the type and amount of data being collected, and the assumptions and thoughts that brought you to this stage. Raw field notes, often scribbled and full of abbreviations, and tapes of interviews or events need to be processed in order to make them useful. It is always easier to structure the information whilst the details are fresh in the mind, to identify gaps and to allow new ideas and hypotheses to develop to challenge your assumptions and biases. Much information will be lost if this task is left for too long.

To begin with, one-page summaries can be made of the results of contacts, e.g. phone conversations, visits. A standardized set of headings will prompt the ordering of the information – contact details, main issues, summary of information acquired, interesting issues raised, new questions resulting from these. Similar one-page forms can be used to summarize the contents of documents.

#### TYPOLOGIES AND TAXONOMIES

As the data accumulate, the first step is to organize the shapeless mass of data by building typologies and taxonomies, i.e. classification

by types or properties thereby forming subgroups within the general category at a nominal level of measurement. Even the simplest classification can help to organize seemingly shapeless information and to identify differences in, say, types of behaviour or types of people. For example, people in a shopping centre might be classified as 'serious shoppers', 'window-shoppers', 'passers through', 'loiterers', etc. This can help you to organize amorphous material and to identify patterns in the data. Then, noting the differences in terms of behaviour patterns between these categories can help you to generate the kinds of analysis that will form the basis for the development of explanations and conclusions.

This exercise in classification is the start of the development of a **coding** system, which is an important aspect of forming typologies. Codes are labels or tags used to allocate units of meaning to the data, going beyond the simple physical facts. Coding helps you to organize your piles of data and provides a first step in conceptualization and helps to prevent 'data overload' resulting from mountains of unprocessed data. The process of coding is analytical, and requires you to review, select, interpret and summarize the information without distorting it. There are two essentially different types of coding, one that is used for the retrieval of text sequences, the other devised for theory generation. The former refers to the process of cutting out and pasting sections of text from transcripts or notes under various headings. The latter is a more open coding system used as an index for interpretive ideas – reflective notes or memos, rather than merely bits of text.

The codes you devise will depend on the type of subject and the nature of the study. Often, codes used in similar previous studies can be adopted or adapted. Codes can be used to differentiate between types of acts, activities, meanings, relationships, settings etc. Normally, a set of codes based on the background study should be devised before doing the fieldwork, and then refined during the data collection process. One important consideration when devising codes is to ensure that they are discrete and unambiguous to ensure that the text fragments or whatever else you are coding can only fit into one code.

There are several computer programs that have been devised for analysing qualitative data (such as *Ethnograph* and *Nudist*) which have facilities for filing and retrieving coded information. They allow codes to be attached to the numbered lines of notes or transcripts

of interviews, and for the source of the information/opinion to be noted. This enables a rapid retrieval of selected information from the mass of material collected. Different programs are aimed at specific types of qualitative research.

#### PATTERN CODING

In the next stage of analysis you need to start looking for patterns and themes, as well as explanations of why and how these occur. **Pattern coding** is a method of pulling together the coded information into more compact and meaningful groupings. It reduces the data into smaller analytical units such as themes, causes/explanations, relationships among people and emerging concepts. This allows you to develop a more integrated understanding of the situation and to test your initial answers to the research questions. This helps to provide a focus for later fieldwork and lay the foundations for cross-case analysis in multi-case studies by identifying common themes and processes.

You should find that generating pattern codes is surprisingly easy, as it is the normal way that we process information every day. You can compile notes in the form of **memos** as a way to explore links between data and to record and develop intuitions and ideas. You can do this at any time – but best done when the idea is fresh! Don't cling uncritically onto initially developed patterns, but test and develop and if necessary reject them as your understanding of the data develops, and as new waves of data are produced in subsequent data gathering. This memoing should be continued throughout the research project. You will find that the ideas become more stable until you achieve the point where you have reached a satisfactory understanding and explanation of the data.

#### INTERIM SUMMARY

At about one third of the way through the data collection, take stock of the quantity and quality of what you have found out so far, your confidence in the reliability of the data, whether there are any gaps or puzzles left to resolve, and to see what data still need to be collected in relation to your time available. Using this information, produce

an **interim summary**, or provisional report a few pages long that summarizes for the first time everything you know so far. This is also the first opportunity to make cross-case analyses in multi-case studies and to review emergent explanatory variables. Although the summary will be provisional and probably sketchy and incomplete, it is a useful tool for you to reflect on the work done and to discuss with your colleagues and supervisors.

#### ANALYSIS DURING AND AFTER DATA COLLECTION

Traditional text-based reports are a lengthy and cumbersome way to present, analyse and to communicate the findings of a qualitative research project. They have to present the evidence and arguments sequentially and the information is dispersed over many pages. This presents a problem for both the writer and especially the readers, who rarely have time to browse backwards and forwards through masses of text to gain full information. Graphical methods of both data display and analysis can largely overcome these problems by using two-dimensional layouts to order data. They are useful for summarizing, describing, exploring, comparing, as well as explaining and predicting phenomena and can be used equally effectively for one-case and cross-case analysis.

Graphical displays fall into two categories: **matrices** and **networks**.

#### *MATRICES (OR TABLES)*

A substantial amount of information can be summarized using two-dimensional arrangements of rows and columns. Matrices can be used to record variables such as time, levels of measurement, roles, clusters, outcomes and effects. They are easy to sketch to any size in a freehand fashion to explore aspects of the data. It is even possible to formulate three-dimensional matrices. You can also use computer programs in the form of databases and spreadsheets to help you in their production and provide neat presentations. For example, Figure 10.2 shows the levels of skills required and amount of help groups got when initiating self-build housing schemes. Six cases are described, and the notes explain the different codes that are used.

## NETWORKS

Networks are made up of blocks (nodes) connected by links. These maps and charts can be devised in a wide variety of formats, each with the capability of displaying different aspects of data, such as: processes or procedures, relationships between variables, and causal relationships between important independent and dependent variables. Networks are particularly useful when you compare the results of several case studies, as they permit a certain standardization of presentation, allowing comparisons to be made more easily across the cases.

The detail and sophistication of the display can vary depending on its function and on the amount of information available – displays are useful at any stage in the research process. You are free to display the information on networks in the form of text, codes, abbreviated notes, symbols, quotations or any other form that helps to communicate compactly.

Here are some different types of display described by the way that information is ordered in them:

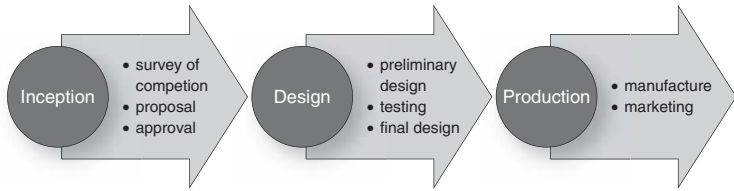


Figure 10.3 Time ordered display

- **Time ordered displays** record a sequence of events in relation to their chronology. A simple example of this is a project programme giving names, times and locations for tasks of different kinds. The scale and precision of timing can be suited to the subject. Events can be of various types e.g. tasks, critical events, experiences, stages in a programme, activities, decisions etc. Figure 10.3 shows a very simple sequence of bringing a product to market.

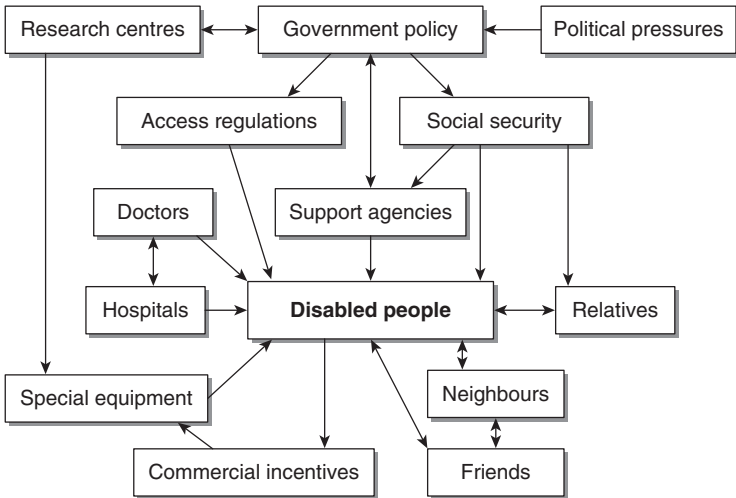


Figure 10.4 Conceptually ordered display

- **Conceptually ordered displays** concentrate on variables in the form of abstract concepts related to a theory and the relationships between these. Examples of such variables are motives, attitudes, expertise, barriers, coping strategies etc. They can be shown as matrices or networks to illustrate taxonomies, content analysis, cognitive structures, relationships of cause and effect or influence, decision trees etc. Figure 10.4 is an example of a simple influence diagram showing the different types of support provided to disabled people and how they interact.

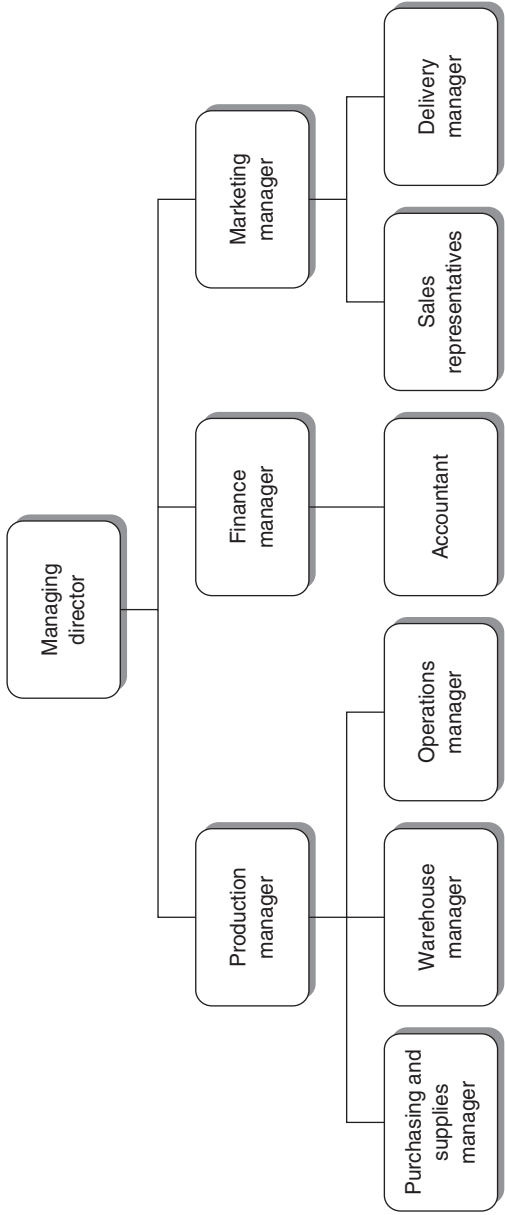


Figure 10.5 Role ordered display

- **Role ordered displays** show people's roles and their relationships in formal and informal organizations or groups. A role defines a person's standing and position by assessing their behaviour



and expectations within the group or organization. These may be conventionally recognized positions, e.g. judge, mother, machine operator; or more abstract and situation dependent e.g. motivator, objector. Note that people in different roles tend to see situations from different perspectives. A role ordered matrix will help to systematically display these differences or can be used to investigate whether people in the same or different roles are unified in their views. Figure 10.5 shows the role division in the management of a production company.

- **Partially ordered displays** are useful in analysing 'messy' situations without trying to impose too much internal order on them. For example a context chart can be designed to show, in the form of a network, the influences and pressures that bear on an individual from surrounding organizations and persons when making a decision to act. This will help to understand why a particular action was taken.
- **Case ordered displays** show the data of cases arranged in some kind of order according to an important variable in the study. This allows you to compare cases and note their different features according to where they appear in the order.
- **Meta displays** amalgamate and contrast the data from each case. For example, a case ordered meta-matrix does this by simply arranging case matrices next to each other in the chosen order to enable you to simply compare the data across the meta-matrix. The meta-matrix can initially be quite large if there are a number of cases. A function of the analysis will be to summarize the data in a smaller matrix, giving a summary of the significant issues discovered. Following this a contrast table can also be devised to display and compare how one or two variables perform in cases as ordered in the meta-matrix.

## QUALITATIVE ANALYSIS OF TEXTS, DOCUMENTS AND DISCOURSE

Sources in the form of texts and documents provide a great deal of data about society, both historically and of the present. There is a wide range of analytical methods that can be applied to analysis of the subtleties of text. Both quantitative and qualitative options are

available. Here is a brief summary of the main qualitative methods and their characteristics.

#### INTERROGATIVE INSERTION

This method consists of devising and inserting implied questions into a text for which the text provides the answers. In this way, you can uncover the logic (or lack of it) of the discourse and the direction and emphasis of the argument as made by the author. This helps to

uncover the recipient design of the text – how the text is written to appeal to a particular audience and how it tries to communicate a particular message.

#### PROBLEM–SOLUTION DISCOURSE

This is a further development of interrogative insertion which investigates the implications of statements more closely. Most statements can be read to have one of two implications. This is very commonly found in advertising e.g. 'Feeling tired? Eat a Mars Bar'. The same, but in more extended form, is found in reports, instruction manuals, and books. The analysis aims to uncover the sequence of the argument by following through first the situation, then the problem, followed by the response and the result and evaluation. The absence of any of these steps in the sequence will lead to a sense of incompleteness and lack of logical argument. Another way of presenting the analysis is to devise a network in the form of a decision tree that traces the problems and the possible solutions with their implications.

#### MEMBERSHIP CATEGORIZATION

This technique analyses the way people, both writers and readers, perceive commonly held views on social organization, how people are expected to behave, how they relate to each other and what they do in different social situations. For example, the relationships between parents and their children, behaviour of members of different classes of society, or the roles of different people in formal situations. Most of these assumptions are not made explicit in the text. By highlighting what is regarded as normal, assumptions and pre-judgements may be revealed and an understanding of typical characterization can be gained.

#### RHETORICAL ANALYSIS

Rhetoric is the use of language and argument to persuade the listener or reader to believe the author. For example, politicians try to give the impression that they should be believed, and harness the vocabulary and structure of spoken and written language to bolster this impression. Rhetorical analysis uncovers the techniques used in this kind

of communication. Rhetoric is used to aim at a particular audience or readership. It may appeal to, and engender belief, in the target audience, but is likely to repel and undermine the confidence of others. For example, a racist diatribe will encourage certain elements on the far-right but repel others.

The analysis detects credibility markers – signals that indicate the ‘rightness’ of the author and the ‘wrongness’ of others, such as assertions about the ‘correct’ moral position, claims of privileged understanding and dismissal of alternatives as unbelievable. Even in apparently non-partisan writing, such as scientific reports, where the author is de-personalized, rhetorical techniques are used to persuade the reader about the ‘rightness’ of the conclusions. Here one should check for markers relating to objectivity, logic and correct methodology.

#### NARRATIVE ANALYSIS

This form of analysis is aimed at extracting themes, structures, interactions and performances from stories or accounts that people use to explain their past, their present situation or their interpretations of events. The data, which is primarily aural, is collected by semi- or unstructured interviews, participant observation or other undirected methods. The narrative is analysed for different aspects, such as what is said rather than how, or conversely, the nature of the performance during the telling, and perhaps how the storyteller reacted with the listener(s). Alternatively, the structure of the story is inspected. All this is done in order to reveal the undercurrents that may lie under the simple narrative of the story.

#### SEMIOTICS

This is the term for the ‘science of signs’ which is used to examine visual and other media as well as written texts. **Semiotics** attempts to gain a deep understanding of meanings by the interpretation of single elements of text or visual units. Words are only meaningful in their relationship with other words, e.g. we only know the meaning of ‘horse’ if we can compare it with different animals with different features. Likewise, the meanings of objects are related to their context, e.g. the meanings of a red traffic light can be seen as embedded

in the system of traffic laws, colour psychology, codes of conduct and convention etc. (which could explain why for a time in China a red traffic light meant 'go'). A strong distinction is therefore made between denotation (what we perceive) and connotation (what we read into) when analysing a sign.

A range of technical terms has been devised that indicate the different aspects of signs, for example: 'signifier' – that which performs as a vehicle for the meaning; 'signified' – what the signifier points to; 'denotative meaning' – the obvious functional element of the sign; 'code' or 'sign system' – the generalized meaning instilled in a sign, and many others. This can simply be explained by looking at a traffic sign and attributing these terms to the various parts, as is shown in Figure 10.6.

#### DISCOURSE ANALYSIS

**Discourse analysis** studies the way that people communicate with each other through language within a social setting. Language is not a neutral medium for transmitting information; it is bedded in our social situation and helps to create and recreate it. Language shapes our perception of the world, our attitudes and identities. Two central themes can be identified: the interpretive context in which the discourse is set, and the rhetorical organization of the discourse. The

former concentrates on analysing the social context, for example the power relations between the speakers (perhaps due to age or seniority) or the type of occasion where the discourse takes place (a private meeting or at a party). The latter investigates the style and scheme of the argument in the discourse, for example a sermon will aim to convince the listener in a very different way from a lawyer's presentation in court.

Poststructuralist social theory, and particularly the work of the French theorist Michel Foucault, has been influential in the development of this analytical approach to language. According to Foucault, discourses are 'practices that systematically form the objects of which they speak' (1972: 43). He could thus demonstrate how discourse is used to make social regulation and control appear natural.

## WHERE TO FIND OUT MORE

As you would expect with this big and complex subject, there are a myriad of books dedicated to explaining all aspects. All the textbooks on social research methods will have sections on qualitative analysis. In the list below, I have tried to explain a bit about the individual book and how it may be of use to you. I have ordered them in what I think is going from simplest to most sophisticated.

## WRITING THE PROPOSAL AND WRITING UP THE RESEARCH

One of the skills essential to successful research is that of writing. Good communication is required at every stage of the project, but the main writing tasks are located at the beginning and end of the research project – at the beginning to explain what you will do in the research, and at the end, to explain what you have done and what you have found out. The task is made much easier these days with the help of word processing packages which provide simple ways to record, store, edit, expand and condense text and to present it in an attractive fashion.

### FORMULATING A SUCCESSFUL RESEARCH PROPOSAL

Before starting a research programme it is necessary to work out exactly what you want to do, why and how. A research proposal is a succinct summary of just that. Obviously it will be very helpful to you, the researcher, to make it clear to yourself what the aims of the research are and what you need to do to achieve the desired outcome. It will also be useful as a way to inform others of your intentions. In fact, the presentation of a research proposal is always required by courses that contain a research exercise, such as writing a dissertation or a thesis. In professional life, for all research projects that need funding you will be required to provide a detailed research proposal as part of the funding application.

Fortunately, research proposals tend to follow a defined pattern. They all need to explain the nature of the research and its context, and why it is needed. This then prepares the way for a statement of the aims and objectives of the research and how it will be carried out and what the outcomes are likely to be. Then there is a description of what resources will be required (time, money, equipment, staffing etc.) in order to carry out the work.

The research proposal, once approved, will act as a contract outlining the basis of agreement between the parties involved, e.g. the researcher, supervisors, institutions (e.g. university or college). In funded research, this will be part of a formal signed contract with the providers of the funds, which cannot be substantially altered without the agreement of all the parties. It is therefore advisable not to 'promise mountains and deliver molehills'!

In the context of research as an educational exercise, research projects should be suitable vehicles for students to learn and practise the theoretical and methodological aspects of the research process as much as being a way to gain new insights into the subject studied.

## THE MAIN INGREDIENTS AND SEQUENCE

Academic research proposals are usually composed of the following elements:

- the title;
- aims of the research;
- the background to the research – context and previous research;
- a definition of the research problem;
- outline of methods of data collection and analysis;
- possible outcomes;
- timetable of the project and description of any resources required;
- list of references.

### THE TITLE

The function of the title is to encapsulate in a few words the essence of the research. Ideally it should contain all the essential key words that someone might use in an attempt to locate the kind of study you are proposing. These words are likely to include the main concept and variables, and limits to the scope. You can leave out such phrases

as 'an investigation into', 'a study of', 'aspects of', as these are obvious attributes of a research project.

Take for example the title 'The implications of the present Labour and Conservative policies on what is taught in primary schools in England'. The independent variables are 'Labour and Conservative policies', and the dependent variable is 'what is taught'; the type of research task is implied as a comparative study; the theoretical basis is one of prediction of effects of policies; and the purpose of the study is to predict their effects on the curricula of primary schools. Also important are the words which limit the scope of the research, e.g. only 'present policies', only those of 'Labour and Conservatives', only in 'the present', only effects on what is 'taught', only in 'primary schools', and only in 'England'.

#### AIMS OF THE RESEARCH

This goes right to the heart of the project. One main aim, and perhaps two or three subsidiary aims resulting from it are sufficient. Precision is essential – too many or vague aims indicate woolly thinking and will be difficult or impossible to achieve within the available resources and time.

#### THE CONTEXT – BACKGROUND AND PREVIOUS RESEARCH

This explains to the reader the background from which the research problem emerges. It should explain the major factors which surround your problem, and of any significant literature which relates to it. It also has the function of capturing the interest of the reader.

Some of the factors which make up the context might be of a physical nature, such as location, materials, artefacts, organizations, processes etc, while others might be more conceptual, such as the economy, legislation, development policy etc. Even more abstract are theoretical concepts such as power, poverty and Marxism. The research problem should emerge from this context.

Virtually every subject has been researched previously, so a critical account of what has been achieved so far to address the problem is required in order to identify the gaps in knowledge or contentious issues. Accurate referencing is essential here. The research should fill

one of these gaps or try to resolve the contention. It is quite difficult to pitch the level of your text so that any intelligent reader understands the factors from which your problem emerges, while at the same time persuading the expert that you are conversant with details of the principal issues. Do not assume that the reader knows anything about your subject.

#### THE RESEARCH PROBLEM

The research problem provides the focus of the research project. It is the culmination of the background work and the initiator of the specific research tasks. It must be very clearly defined to explain the nature of the problem and why it is significant. The problem may be expressed in abstract **terms** initially, but through the statement of **sub-problems**, you should indicate how it can be investigated practically.

#### OUTLINE OF METHODS

This part of the proposal explains briefly what you are going to do in order to carry out your research, based on your chosen research approach. In proposals for funded research this may need to be described in great detail.

Every proposal is different in its description of methods, as these have to be specifically tailored to efficiently collect and analyse data relevant to the specific research problem and to produce the outcomes aimed at. One common feature is likely to be a review of the literature relevant to the research topic. It is generally relevant to distinguish between the methods of data collection and data analysis, although in some cases, particularly in qualitative research, these may go hand in hand. The explanation will outline which methods you will use for what, and why. You will probably need to refer to books that describe the methods in detail. There may be only one method used, e.g. experimental, or a combination of several, each suitable for different aspects of the research. You may have to indicate how you will be able to access certain types of information if these are obscure, in remote locations or only available to certain people. Access to materials or equipment may also be discussed.

## POSSIBLE OUTCOMES OF THE RESEARCH

Although you cannot predict exactly what the outcomes will be (if you could, there would be little point in carrying out the research) you should try to be quite precise as to the nature and scope of the outcomes and as to who might benefit from the information. The outcomes should relate directly to the aims of the research. Note that in PhD proposals and most funded research there is a need to indicate what will be the original contribution to knowledge.

## TIMETABLE OF THE PROJECT AND DESCRIPTION OF ANY RESOURCES REQUIRED

There is always a time limit to research projects, particularly strict if it is a piece of university or college coursework. The formulation of a timetable is therefore essential in order to allocate time limits to the sequence of tasks that you need to accomplish in order to hand the finished report or dissertation in on time. This is not only a test of the practicality of the proposed project, but also an organizational guide when you carry out the work.

Resources that are essential to the project, such as equipment, transport, skills, software etc. should be listed and availability assured in order to convince the reader (and yourself) of the practicality of achieving the aims of the project.

## LIST OF REFERENCES

The location of the cited work of others must be meticulously recorded in this list. Not only does this ensure that you cannot be accused of plagiarism but also demonstrates that you are aware of the latest thinking in the subject. However, keep the references relevant – it is not a bibliographic list of all the literature surrounding the subject.

## WRITING THE PROPOSAL

For a major undertaking such as a final year dissertation or research degree, it is important to keep conferring with your tutor or supervisor

as you refine the structure of the argument and develop your successive drafts of the proposal. Comments from other members of staff and/or colleagues can be useful too as they might see things from a different perspective. Remember, however, that it is you who must decide what you want to do in the research, so be prepared to discuss it further with your tutor if you do not agree with some of the comments or recommendations made by others.

Why might a proposal be rejected? Here are some reasons:

- There is no need for the research.
- The scale of the proposed research is too big so an adequate conclusion cannot be reached.
- The aims and objectives are vague or impractical or do not match, or are expressed as personal goals.
- The research problem is not clearly defined so the research work has no adequate focus.
- The procedures are confused with the objectives.
- There is a lack of logic in the argument in the proposal, so the link between the research aims and outcomes is broken.
- The project is formulated on an emotional or a political agenda rather than a factual or a theoretical basis.
- Not enough information is provided about the details of the project.
- Access to information, equipment or other resources are uncertain or impossible.

The completed proposal must conform to the requirements of the course or project in which you are taking part. Normally, there is limited space on the forms, and often you must ensure that your proposal is not longer than can be comfortably fitted onto two sides of A4. This is not easy, but is a very good discipline in writing a dense argument. Where possible, use the references as a shorthand to describe theoretical approaches.

Here is an example of a research proposal that has been prepared by a Masters level student for their dissertation that they wrote over the space of three months during the summer. I have annotated it to point out the features described above.

## RESEARCH PROPOSAL

This proposal was written by Marina Muenchenbach as part of her Research Methods Module in the Masters course, Development and Emergency Practice (DEP), at Oxford Brookes University.

### **Local Economy Development in Humanitarian Assistance for Transition to Development in Post-Conflict Environments**

*[Comment: Note how the title introduces the main concepts and defines and limits the scope of the research.]*

#### **The aims of the research**

This research aims to investigate possible concepts and tools that add further knowledge to the question of how best Humanitarian Assistance (HA) Programs during the transition phase from emergency to development can prepare the ground for long-term and sustainable Local Economy (LE) Development by forming partnerships with Local Markets and achieving Win-Win situations based on common interest.

The research specifically addresses the context of conflict affected environments.

*[Comment: This section gives the briefest outline of the aims to explain the focus of the research to the reader, and introduces some of the distinctive issues that will be involved.]*

#### **Background to the research**

The objectives of Humanitarian Assistance are 'to save lives, alleviate suffering and maintain human dignity during and in the aftermath of man-made crises and natural disasters, as well as to prevent and strengthen preparedness for the occurrence of such situations' (IPB, 2003).

The current system of Humanitarian Assistance is composed of Donors, UN agencies, NGOs and the Red Cross and Red Crescent Movement (ALNAP, 2010). In the last decades, Humanitarian Assistance has made considerable progress in conscious building

regarding its impact on economies in conflict affected environments and the need to prepare for a smooth transition to development.

In contrast to Humanitarian Assistance, Development Assistance is economy-centred and is provided bilaterally and multilaterally by developed countries, International Financial Institutions (including the Bretton Woods Institutions WB, IMF and WTO), Foreign Direct Investment and the Private Sector.

*[Comment: Here, the two main concepts are defined and explained, with a quotation – note the citation – and references to the literature.]*

Humanitarian Assistance and Development currently appear 'dis-jointed' with a sharp change in objectives from the humanitarian to the development phase. By focusing on 'humanitarian' objectives actors may forget that at one point the respective country will strive for development based on economic efficiency criteria. Assistance can thus run the risk to create prolonged dependency or even hinder independent sustainable development.

*[Comment: The main research problem that inspired this research is revealed. This provides the reason and focus for the research.]*

Coordination of Humanitarian Assistance was improved by the creation of the UN cluster system in 2005. Within the system, the Early Recovery Cluster was given the specific responsibility for promotion of early steps that enable long-term development (UNDP Country Team Pakistan, 2006).

*[Comment: This problem has been tackled to some extent.]*

Despite successful efforts on various levels, there is still a lack of awareness of Humanitarian Assistance organizations regarding their impact on local markets. Local purchase is usually not defined as a specific objective in programme planning, which often results in internal administrative and logistical procedures that are unfavourable to purchasing or contracting locally. Local Economy actors on the other hand usually do not have the contacts, knowledge or management capacity to successfully advertise their services.

*[Comment: However more needs to be done, particularly about a forgotten issue – that of local markets.]*

The research focuses on Local Economy Development in Northern Uganda which after over 20 years of violent internal conflict is in the transition to development.

*[Comment: This locates the research in a particular area and situation, limiting its scope in order to make it possible to encompass within a short research project.]*

### **Literature review**

Three major areas of current research shall be specifically outlined as relevant to the dissertation.

*[Comment: Breaking the review down into separate relevant areas helps to give a structure to the review and to focus the literature search to essential issues.]*

The Donor Committee for Enterprise Development has made important attempts in shaping the policy debate for *Private Sector Development in post-conflict countries*. Their review of current literature and practice (DCED, 2008) states that 'in addition, donor countries are increasingly bringing together development, diplomatic and defence efforts in order to achieve both security and development goals. This not only promotes security for developing countries, but also for donor nations themselves'.

*[Comment: Commenting on a previous, and no doubt, far more extensive review of the literature, and introducing a short quotation, mines into a wealth of information that can be used later in the research.]*

Making Markets Work for the Poor (M4P) is an approach to poverty reduction that donors such as the Department for International Development (DFID) and the Swiss Agency for Development and Cooperation (SDC) have been supporting over the past few years. The central idea is that the poor are dependent on market systems for their livelihoods (DFID, 2008).

The growing use of Market Mapping and Analysis (Albu, 2010) and Value Chain Analysis (USAID, 2008) is indicative for an evolving acceptance within the Humanitarian Assistance system of the significance of local markets and of local procurement and innovative forms of market-system support.

*[Comment: See how the literature is not just listed, but the ideas are extracted to make a relevant point about the proposed research.]*

The main current gap in knowledge concerns methods for practical implementation of formulated policies. The intended research will therefore focus on providing an open forum for concerned actors (Humanitarian Assistance, Local Economy and Local Governments) which allows for participatory brainstorming of possible concepts and tools to achieve stipulated goals.

*[Comment: Although very brief, this review has hinted at a gap in knowledge that will be addressed by the proposed research. Space permitting, this review of the literature could be much longer to dig deeper into the state of the art of theory and practice in this subject. However, a short proposal like this should concentrate on the main sources – the more extended exploration of the literature can come in the dissertation itself.]*

### **Research problem**

The importance of market integrated approaches in Humanitarian Assistance programmes during the transition phase that prepare the ground for long-term and sustainable Local Economy Development (LED) – specifically in the context of conflict affected environments – starts being acknowledged by the Donor community and concerned actors. However, up to date there is a lack of practical concepts and tools that allow efficient implementation of policies.

*[Comment: The problem stated in a nutshell. Note the use of the main concepts and their relationships, and the identification of a need for the research.]*

### **Research Questions**

- 1 What is the current impact of HA on economic sectors critical to long-term development?
  - a What percentage of goods, services and labour do HA organizations acquire locally, nationally and internationally?
  - b What percentage of goods, services and labour as delivered by local economy is purchased, contracted or employed by HA organizations?

- 2 Which sectors or markets offer win-win opportunities? Do some more than others? Agriculture more than construction? Services more than material?
- 3 How can 'critical' markets be stimulated to allow for greater involvement of Local Economy?
- 4 Which body, structure, organization is best suited to promote Local Economy Development at a given location? Is there an existing one? Does a new one have to be created? If yes, what should it look like?
- 5 Which concepts or tools can support LED and increase partnerships (HA – LE)?
- 6 Is the use of market mapping and analysis applicable to LED?
- 7 Is the use of action research in partnerships applicable to LED?

*[Comment: Devising questions is a good way to break down the main research problem into practically researchable units aimed at finding the answers. The questions provide a sort of task list for the project, hinting at the type of data that is required and how it should be analysed to produce conclusions that answer the questions. Care should be taken to ensure that the questions are all relevant to the main problem. Also ensure that they can practically be answered within the scope of the project, as is the case here. This section is about 'what to do'.]*

### **Methodology**

The research will be carried out following participatory action research principles and will be located in Kitgum, Northern Uganda. The area was chosen as one of the major arenas of humanitarian assistance. It is passing from transition to development and security conditions are favourable.

*[Comment: This section is about 'how to do it'. A step-by-step approach is a good way to organize the actual research activities, though you may need to introduce times when reiteration takes place.]*

The first step in the research will be the formation of a partnership-type research group consisting of representatives of Humanitarian Assistance, Local Economy, Local Government and Researchers.

The Scandinavian model of Participatory Action Research applied in the research is based on the concept of co-generating knowledge between insiders and outsiders on a specific topic of interest (Eden and Levin as cited in Reason and Bradbury, 1991).

*[Comment: Some groundwork is usually required to enable the research actions to take place, whether it is collecting material and equipment, organizing people, or getting the requisite permissions.]*

Subsequent steps in the research consist of:

- Data collection of the existing organizational situation from records and interviews with experts, using flowcharts to record the flow of funds, expertise and relationships and interactions in the process of Participatory Action Research.
- Identification of 2 to 3 markets with potential growth potential for LED by interviews with local businesses and market leaders.
- Mapping of identified markets using market mapping to chart key infrastructure, inputs and market-support services; market actors and their linkages in the market chain; and the institutions, rules, norms and trends of the market environment.
- Analysis of collected data using data display and reduction techniques for qualitative data to identify main themes and trends, and descriptive statistics for quantitative data, all aimed at answering the research questions.
- Formulation of Conclusions and Recommendations.

All steps should be carried out under supervision and with the direct involvement of local actors and under supervision of the research group.

*[Comment: It is usually far easier to describe the data collection process, as this is a familiar everyday activity, such as asking questions, reading publications and making observations. More difficult, and sometimes even glossed over in the first proposal drafts, is the ways used to analyse the data collected. The analysis methods are less familiar and need to be learnt about, such as statistical analysis, coding and mapping etc. This is where you will need to consult research methods books to find out what the appropriate analytical methods are for your research. The description here of the analytical methods is rather brief.]*

### **Potential outcomes and limitations to the research**

Potential outcomes may consist of agreed recommendations – if possible formulated as programme proposals – that can be adopted by interested actors for future implementation.

*[Comment: Although you will not know the answers yet to your research questions, it is good to form an idea of the form of the outcomes and how they might be used.]*

The main limitation of the research relates to the scope of work that can be covered within the dissertation period. The study will take place only in one location. Preferably, the described process should be implemented in all main districts of Northern Uganda (Gulu, Amuru, Pader, and Karamoja).

*[Comment: No research project can provide all the answers, so it is good to be aware of the limitations of the project so as not to overstate the case when it comes to the conclusions and recommendations. Any contribution to knowledge, however small, is welcome!]*

During the initial sourcing donor organizations expressed potential interest in dissemination of results and recommendations within their respective organizations and areas of work.

*[Comment: A good point is made here. In order for the findings of your research to be noticed and used, it has to be disseminated in some way to those who will find it interesting or useful.]*

The importance of the research – even if limited in scope and location – lies in its practical approach involving existing real actors and its potential to produce applicable concepts and tools that have been developed and agreed by a wider forum.

*[Comment: A good way to round off the proposal – stressing the worthwhile nature of the research effort.]*

### **Outline programme of the work**

*[Comment: An essential part of the research planning is the programme that demonstrates that all the work can be completed before the deadline. When you devise this, it will become clear whether your ambitions match your resources!]*

## WRITING UP A DISSERTATION OR RESEARCH PROJECT

Your dissertation or final year project will probably be the first lengthy piece of independent writing you have to undertake. The main issue when faced with such a task is how to structure the work so that it forms an integral whole. This structure will guide the reader as well as providing a framework to fill in as you are writing. In academic type writing, the aim is not to tell a story as one might in a novel, but to set up an argument to support a particular view. You will be trying to persuade the reader that what you have done is worthwhile and based on some kind of logical intellectual process.

Whatever your subject, there must be a central issue that is being investigated which provides the focal point of the text. The body of the dissertation will then revolve around this focal point, perhaps considering it from different perspectives, or examining causes or finding explanations. You will have to come to some conclusions at



the end, and this is why argument is required. These conclusions should be based on evidence, and a reasoned argument from this evidence leads to your conclusions.

#### WHEN TO START WRITING UP

It is a daunting prospect to sit down in front of a blank computer monitor with the task of writing a 20,000 word assignment. Thankfully, you can easily avoid this situation. First you will need to prepare a structure for the writing as soon as you are clear what you will be doing, probably after you have completed your proposal. The trick then is to gradually amass a collection of notes, observations and data on the issues relevant to your study, which you can then use as a basis for your first draft. The structure will provide a framework into which you can insert your text. This way, you will have started writing without even realizing it! Don't expect either the framework or the text to be the final version. Both will need refining and revising as your work and understanding progresses. Luckily, word processors make revision very quick and easy.

#### FRAME AND FILL

The framework for your dissertation is most easily created by making a list of possible chapter or section headings. Consult your proposal and plan of work for indications of what these may be. At the very simplest level the divisions may be like this:

- Introduction
- Background and previous research
- The main issues and research problem
- Research methods – how you will investigate the problem
- A description of the research actions and their results
- Conclusions in relation to the research problem

This is a conventional format and can be applied to a study in almost any subject. If you want to use an unusual structure or even want to develop your own, discuss this with your supervisor to check that it will be acceptable. Once you have the main framework, you can elaborate on the contents of each section by inserting sub-headings

to identify the various aspects that you want to consider in each. You will be able to reorder, expand or change these as you progress. However, you will need to know what number of words your assignment should contain in order to decide how long each section should be to get a balanced result.

You don't have to fill in your text starting from the beginning and proceeding to the end. Use what notes you have got so far and insert them where they are relevant within the framework. This way you will thus quickly have several pages of (very) rough draft. Although the text will be no more than a series of raw notes, completely unedited, disjointed and incomplete, it will provide you with a solid basis for working on to produce a first draft.

How do you find your notes and get them into the right place? This is where your retrieval techniques will be put to the test. Assuming that your framework gives you enough indication of what you are looking for, search through your notes by keyword or subject. If you do this on the computer, you will be shown a selection of relevant notes, from which you can choose what you think is suitable for that section. You can do this manually with notes on paper. Other useful search parameters may be date or author.

#### COMING TO CONCLUSIONS

The whole point of collecting data and analysing them is so that you can come to some conclusions that are relevant to your research problem and achieve the aims of your project. This is a quite demanding and creative process that requires a lot of clear thinking, perception and meticulous care to build up a logical argument. All the previous work will be devalued if you do not sufficiently draw out the implications of your analysis and capitalize on the insights that it affords. You cannot rely on the reader to make inferences from your results. It really is up to you to vividly explain how the results of your analysis provide evidence for new insight into your chosen subject, and respond to the particular research problem that you exposed at the beginning of the research.

Coming to conclusions is a cumulative process. It is unlikely that the problem you have chosen is simple, with questions raised that can be answered with a simple yes or no. Normally, you will find that the questions have several sub-questions requiring individual

investigation and answers. Throughout the analysis part of your work you should come to conclusions about these fragments of the main issues. The skill is to gather these up at the end in the concluding chapter to fit them together into a 'mosaic' that will present the complete picture of the conclusion to the entire research project. Just as you should be able to summarize the main problem that your project addresses in one or two sentences, so you should be able to state the conclusion equally briefly.

### REVISIONS

The nice thing about using a word processor is that you can easily change things after you have written them. This takes off the pressure of getting everything right first time – something that is impossible to do anyway. Once your work is on paper, then you can review it, get a second opinion on it, and discuss it. You cannot do these if it is still all in your head. Hence the importance to get on with writing as soon as possible. Regard the making of revisions to be an integral part of the process of doing a dissertation. You will of course have to include some time for this in your time plan.

Revision can be done at different levels. The more general levels are concerned with getting the structure and sequence right. At a more detailed level, you might look at the sequence of paragraphs – does each concentrate on one point, do they follow each other in the right sequence? At the most detailed level you will be looking at grammar, punctuation, vocabulary and spelling.

It is important to keep a track of your revisions, making sure you know what the latest one is! The best way is to save your revision as a new file, clearly labelled with a revision number (e.g. Chapter 3/1, 3/2 etc.). You will thus be able to go back to a previous revision if you change your mind or want to check on some detail. Most word processing programs also provide a facility for keeping track of revisions.

### WHERE TO FIND OUT MORE

There are plenty of books with advice for students for different aspects of study. Here is a selection of books that will provide more information on different aspects of writing.

This offers practical, in-depth guidance on each of the stages of the essay writing, reading academic texts, how to get the most out of lectures, referencing and citations, fluency and appropriateness of style and language.

There are books that are solely dedicated to writing academic proposals of all kinds. Some go into great detail, but you will undoubtedly find something useful. I have put them in order of complexity, simplest first. Every book on how to do dissertations will also have a section on writing a proposal.

# GLOSSARY

**Abstractness** A characteristic of research findings that make them independent from specific time and place. Such research findings are useful as they can be applied to other situations.

**Accidental sampling** Also called convenience sampling. A non-random sampling technique that involves selecting what is immediately available e.g. studying the building you happen to be in, examining the work practices of your firm.

**Algorithm** A process or set of rules used for calculation or problem solving, especially using a computer. These can be expressed graphically or more often, as a mathematical formula. An example is a formula that summarizes the interior conditions that lead to the feeling of climatic comfort, with factors such as air temperature, humidity, air movement, amount of clothing, etc.

**Analogy** A comparison of two different types of thing in order to detect the similarities between them. It may be possible to infer that they possess further undetected similarities.

**Argument** A type of discourse that not only makes assertions but also asserts that some of these assertions are reasons for others. Argument is often based on the rules of logic in order to provide a solid structure.

**Assertive discourse** A type of discourse that contains assertive statements, e.g. this man is bald.

**Associational statements** Make an assertion that two concepts are associated in some way, positively, negatively, or not associated at all. The word 'correlation' is often employed to refer to the degree of association.

**Authentication** Checking on historical data to verify whether it is authentic. Typical techniques used are textual analysis, carbon dating, paper analysis, cross referencing etc.

**Axiomatic theory** A theory that comprises an initial set of statements (axioms) or self-evident truths, each independent of the others, and from which it is possible to logically derive all the other statements (propositions) of the theory. A good example of one of these is Pythagorean geometry.

**Bell curve** Also known as 'normal' or Gaussian curve. A common parameter of populations, where there is a preponderance of values to group around the centre, with progressively less towards the extremes. The basic characteristic required by parametric statistical analysis.

**Bias** A distortion of a statistical or other analytical result due to a factor not allowed for in the calculations. This can be due to human or other influences. Often referred to in sampling methods.

**Bibliographic database** An electronic list of bibliographic information. These may be on CD-ROM, or online on the Internet. Many of these are available through university and other libraries and can be searched using key words, subjects, authors, titles etc.

**Bibliography** A list of key information about publications. These can be compiled on particular subjects or in relation to a particular piece of academic work. There are standard systems for compiling bibliographies, e.g. Harvard. Libraries usually compile their own bibliographies to guide students to literature in their particular subject.

**Bivariate analysis** The analysis of two variables as to whether and to what extent they influence each other.

**Categorization** Involves forming a typology of object, events or concepts. This can be useful in explaining what 'things' belong together and how.

**Causal process theory** An interrelated set of definitions and statements which not only define the theory, but describe when and where the causal processes are expected to occur, and explain the causal processes or mechanisms by identifying the effect of the independent variables on the dependent variables.

**Causal statements** These make an assertion that one concept or variable causes another – a 'cause and effect' relationship. This can be deterministic, meaning that under certain conditions an event

will inevitably follow, or if the outcome is not so certain, probabilistic, meaning that an event has a certain chance (which may be quantifiable) of following.

**Central tendency** A descriptive statistic that gives the measurement of location of, most commonly, the mean, median and mode of a data set. These are different types of 'average'.

**Citation** A reference to a source of information or quotation given in a text. This is usually in abbreviated form to enable the full details to be found in the list of references.

**Class** A set of persons or things grouped together or graded or differentiated from others. Classes can be formed by collection or division. Classes can be divided into sub-classes to form a hierarchy.

**Cluster sampling** Selection of cases in a population that share one or some characteristics, but are otherwise as heterogeneous as possible, e.g. travellers using a railway station. Also known as area sampling when random segments are chosen from a large area of population distribution.

**Coding** The application of labels or tags to allocate units of meaning to collected data. This is an important aspect of forming typologies and facilitates the organization of copious data in the form of notes, observations, transcripts, documents etc. It helps to prevent 'data overload' resulting from mountains of unprocessed data in the form of ambiguous words. Coding of qualitative data can form a part in theory building. Codes can also be allocated to responses to fixed choice questionnaires.

**Coefficient of correlation** The measure of a statistical correlation between two or more variables. There are many types of these, the 'Pearsonian  $r$ ' being the most common.

**Concept** A general expression of a particular phenomenon, or words that represent an object or an idea. This can be concrete, e.g. dog, cat, house; or abstract – independent of time or place, e.g. anger, marginality, politics. We use concepts to communicate our experience of the world around us.

**Conceptual scheme theory** Conceptual schemes that designate, or even proscribe, what constitute the characteristics of 'social facts'.

**Consistency** A quality of argument concerned with the compatibility of beliefs, i.e. a set of beliefs that can be shown to be consistent with each other is said to be consistent.



**Control** Having the ability to determine the influences on variables in a phenomenon, for example in an experiment. The crucial issue in control is to understand how certain variables affect one another, and then be able to change the variables in such a way as to produce predictable results. Not all phenomena can be controlled as many are too complex or not sufficiently understood.

**Critical rationalism** An approach usually associated with Popper that maintains that rival theories can be judged against specific, unchanging, universal criteria, which are divorced from or set beyond the influences of time or society.

**Critical realism** A non-empirical (i.e. realist) epistemology that maintains in importance of identifying the structures of social systems, even if they are not amenable to the senses. This will enable the structures to be changed to ameliorate social ills.

**Data** The plural of datum, a particular measured value of a variable.

**Data reduction** Techniques used to summarize the most significant or interesting features of a mass of qualitative data, the results of which are often shown in the form of matrices or networks.

**Deduction** The inferring of particular instances from a general law, i.e. 'theory then research' approach.

**Dependent variable** A variable that is expected to be affected by a manipulation of the independent variable.

**Descriptive statistics** A method of quantifying the characteristics of parametric numerical data e.g. where the centre is, how broadly they are spread, the point of central tendency, the mode, median and means. These are often explained in relation to a Gaussian (bell) curve.

**Directive language** Language used for the purposes of causing or preventing overt action.

**Discourse** Communication in the form of words as speech or writing or even attitude and gesture.

**Discourse analysis** Studies the way people communicate with each other through language in a social setting, where language is not seen as a neutral medium for transmission of information, but is loaded with meanings displaying different versions of reality.

**Empirical generalization** A generalization based on several empirical studies that reveal a similar pattern of events. All concepts in an empirical generalization must be directly measurable.

**Empirical relevance** The measure of the correspondence between a particular theory and what is taken to be objective empirical data.

**Epistemology** The theory of knowledge, especially about its validation and the methods used. Often used in connection with one's epistemological standpoint – how one sees and makes sense of the world.

**Ethics** The rules of conduct. In this book particularly about conduct with other people and organizations, aimed at causing no harm and providing, if possible, benefits.

**Evaluation** Making judgements about the quality of objects or events. Quality can be measured either in an absolute sense or on a comparative basis.

**Existence statements** These claim that instances of a concept exist in the real world, and provide a typology or a description.

**Experience** Actual observation or practical acquaintance with facts or events that results in knowledge and understanding.

**Explanation** One of the common objectives of research.

**Expressive language** Language used to express emotions and feelings.

**External reality** Acceptance of the reliability of knowledge gained by experience to provide empirical evidence.

**External validity** The extent of the legitimate generalizability of the results of an experiment.

**Falsification** The process by which a hypothesis is rejected as a result of true observational statements which conflict with it.

**Focus group** A group of people assembled in order to discuss a particular subject of the research in order to reveal their opinions and beliefs. Usually they are selected for their relevant expertise or involvement in the subject.

**Formal fallacies** These occur due to some error in the structure of the logic used, causing the chain of reasoning to be defective.

**Frequency distribution** The values of the variables and their percentages of the total of variable values, usually displayed from the lowest to the highest values in a table.

**Generality** The assumption that there can be valid relationships between the particular cases investigated by the researcher and other similar cases in the world at large.

**Grounded theory** A type of research that develops theory on the basis of reciprocal phases of qualitative data collection, analysis and theory building, each phase informing the next.

- Hypothesis** A theoretical statement that has not yet been tested against data collected in a concrete situation, but which it is possible to test by providing clear evidence for support or rejection.
- Hypothetico-deductive method** Synonymous with scientific method. Progress in scientific thought by the four-step method of: identification of a problem, formulation of a hypothesis, practical or theoretical testing of the hypothesis, rejection or adjustment of hypothesis if it is falsified.
- Idealism** An epistemological stance that maintains that the world exists, but that different people construe it in different ways. Each has his/her own reality.
- Independent variable** A variable that when it is manipulated, causes an effect or change on a dependent variable.
- Index journal** Catalogues of the bibliographic details of journal articles without further details apart from perhaps key words.
- Indicator** A measure or sign, not usually directly measurable, that characterizes a concept.
- Induction** The inference of a general law from particular instances. Our experiences lead us to make conclusions from which we generalize.
- Inferential statistics** Statistical analysis that goes beyond describing the characteristics of the data and the examination of correlations of variables in order to produce predictions through inference based on the data analysed. Inferential statistics are also used to test statistically based hypotheses.
- Informal fallacies** These occur when: the ambiguities of language admit error to an argument, something is left out that is needed to sustain an argument, irrelevant factors are permitted to weigh on the conclusions, or unwarranted presumptions alter the conclusion.
- Informative language** Language used to communicate information.
- Informed consent** Consent given by participants to take part in a research project based on having sufficient information about the purposes and nature of the research and the involvement required.
- Interim summary** A short report prepared about one-third of the way through data collection in qualitative research in order to review the quantity and quality of the data, confidence in its reliability, and the presence and nature of any gaps or puzzles that have been revealed, and to judge what still needs to be collected in the time available.

**Internal validity** A measure of the level of sophistication of the design and extent of control in an experiment. The values of data gained should genuinely reflect the influences of the controlled variables.

**Interpretation** An integral part of the analysis of data that requires verification and extrapolation in order to make out or bring out the meaning.

**Interpretivism** The standpoint that recognizes the 'embedded' nature of the researcher, and the unique personal theoretical stances upon which each person bases his/her actions. It rejects the assertion that human behaviour can be codified in laws by identifying underlying regularities, and that society can be studied from a detached, objective and impartial viewpoint by the researcher. Attempts to find understanding in research are mediated by our own historical and cultural milieu.

**Intersubjectivity** Agreement between people about meaning of concepts used in statements, attained by precise definition of the concepts. Intersubjectivity is also promoted by the use of appropriate logical systems such as mathematics, statistics and symbolic logic.

**Interval level** (of measurement) The use of equal units of measurement, but without a significant zero value, e.g. the Fahrenheit or Centigrade temperature scales.

**Journal of abstracts** Catalogues of the bibliographic details of journal articles together with summaries of articles (indicative or informative abstracts). These often are devoted to specific subject areas.

**Laws** Statements that describe relationships that are so well supported by evidence, and confidence in their reliability is so strong, that they are considered to express the 'truth' in the cases to which they apply.

**Levels of abstraction** The degree of abstraction of a statement based on three levels – theoretical, operational and concrete, the last being the least abstract.

**Levels of measurement** The four different types of quantification, especially when applied to operational definitions, namely nominal, ordinal, interval and ratio.

**Library catalogue** Bibliographic details of items in a library. The databases are now usually accessed by computer as online public access catalogues (OPACs).

**Logical truth** (when referring to statements) Logically true statements can be divided into three varieties: trivial (obvious), true by necessity (according to rules, e.g. mathematical) and true by definition (conforming to unambiguous definition).

**Materialism** An epistemological stance that insists that only physical things and their interactions exist and that our minds and consciousness are wholly due to the active operation of materials.

**Matrices** Two-dimensional arrangements of rows and columns used to summarize substantial amounts of information. They can be used to record variables such as time, levels of measurement, roles, clusters outcomes, effects etc. Latest developments allow the formulation of three-dimensional matrices.

**Memos** Short analytical descriptions based on the developing ideas of the researcher reacting to the data and development of codes and pattern codes. Compiling memos is a good way to explore links between data and to record and develop intuitions and ideas.

**Meta-analysis** An overall analysis gained by drawing together the results of individual analysed components of the research, typically qualitative research.

**Model** (a) A term used to describe the overall framework that we use to look at reality, based on a philosophical stance (e.g. postmodernism, poststructuralism, positivism, empiricism etc.). (b) A simplified physical or mathematical representation of an object or a system used as a tool for analysis. It may be able to be manipulated in order to obtain data about the effects of the manipulations.

**Networks** Maps or charts used to display data, made up of blocks (nodes) connected by links. They can be produced in a wide variety of formats, each with the capability of displaying different types of data, e.g. flow charts, organization charts, causal networks, mind maps etc.

**Nominal level** (of quantification) The division of data into separate categories by naming or labelling.

**Null hypothesis** A statistically based hypothesis tested by using inferential statistics. A null hypothesis suggests no relationship between two variables.

**Operational definition** A set of actions that an observer should perform in order to detect or measure a theoretical concept. Operational definitions should be abstract, i.e. independent of time and space.

- Order** The condition that things are constituted in an organized fashion that can be revealed through observation.
- Ordinal level** (of quantification) Ordering data by rank without reference to specific measurement, i.e. more or less than, bigger or smaller than.
- Paradigm** The overall effect of the acceptance of a particular general theoretical approach, and the influence it has on the scientists' view of the world. According to Kuhn, normal scientific activity is carried out within the terms of the paradigm.
- Parameter** A measurable characteristic or feature that is shared in different populations.
- Parsimony** Economy of explanation of phenomena, especially in formulating theories.
- Participant** Someone who takes part in a research project as a subject of study. This term implies that the person takes an active role in the research by performing actions or providing information.
- Pilot study** A pre-test of a questionnaire or other type of survey on a small number of cases in order to test the procedures and quality of responses.
- Plagiarism** The taking and use of other people's thoughts or writing as your own. This is sometimes done by students who copy out chunks of text from publications or the Internet and include it in their writing without any acknowledgement to its source.
- Population** A collective term used to describe the total quantity of cases of the type which are the subject of the study. It can consist of objects, people and even events.
- Positivism** An epistemological stance that maintains that all phenomena, including social, can be analysed using scientific method. Everything can be measured and, if only one knew enough, the causes and effects of all phenomena could be uncovered.
- Postmodernism** A movement that reacts against the all embracing theories of the Modern Movement and insists on the inseparable links between knowledge and power.
- Prediction** One of the common objectives of research.
- Primary data** Sources from which researchers can gain data by direct, detached observation or measurement of phenomena in the real world, undisturbed by any intermediary interpreter. It is a matter of philosophical debate as to what extent the detachment and undisturbed state are possible or even desirable.

**Problem area** An issue within a general body of knowledge or subject from which a research project might be selected.

**Proportional stratified sampling** Used when cases in a population fall into distinctly different categories (strata) of a known proportion of that population.

**Proposition** A theoretical statement that indicates a clear direction and scope of a research project.

**Quantification** (of concepts) Measurement techniques used in association with operational definitions.

**Quota sampling** An attempt to balance the sample by selecting responses from equal numbers of different respondents. This is an unregulated form of sampling as there is no knowledge of whether the respondents are typical of their class.

**Ratio level of measurement** A scale with equal units of measurement and containing a true zero equal to nought – the total absence of the quantity being measured.

**Reasoning** A method of coming to conclusions by the use of logical argument.

**Regression** A type of statistical analysis that uses simple and multiple predictions to predict Y from X values. Usually shown as a line through the values plotted on a scattergram.

**Relational statements** These impart information about a relationship between two concepts. They form the bedrock of scientific knowledge and explain, predict and provide us with a sense of understanding of our surroundings.

**Relativism** The stance that implies that judgement is principally dependent on the values of the individuals or society and the perspectives from which they make their judgement. No universal criteria can be 'rationally' applied, and an understanding of decisions made by individuals or organizations can only be gained through knowledge of the historical, psychological and social backgrounds of the individuals.

**Reliability** In relation to human perception and intellect, the power of memory and reasoning to organize data and ideas in order to promote understanding.

**Research problem** A general statement of an issue meriting research. It is usually used to help formulate a research project and is the basis on which specific research questions, hypotheses or statements are based.

**Research question** A theoretical question that indicates a clear direction and scope for a research project.

**Sample** The small part of a whole (population) selected to show what the whole is like. There are two main types of sampling procedure, random and non-random.

**Sampling error** The differences between the random sample and the population from which it has been selected.

**Scientific method** The foundation of modern scientific enquiry. It is based on observation and testing of the soundness of conclusions commonly by using the hypothetico-deductive method. The four-step method is: identification of a problem, formulation of a hypothesis, practical or theoretical testing of the hypothesis, rejection or adjustment of hypothesis if it is falsified.

**Secondary sources** Sources of information that have been subject to interpretation by others, usually in the form of publications.

**Semiotics** The study of signs. A type of analysis, particularly of text and visual material, intent on revealing hidden or implicit meanings.

**Sense of understanding** A complete explanation of a phenomenon provided by a wider study of the processes that surround, influence and cause it to happen.

**Set of laws theory** A theory that comprises a set of separate, though interrelated, laws.

**Significance (statistical)** The quality of the difference between the value of a case compared with that of a population, and how much the difference varies from values expected to have occurred by chance. A big difference from the chance values indicates increased statistical significance.

**Simple random sampling** A method used to select cases at random from a uniform population.

**Simple stratified sampling** A method that recognizes the different strata in the population in order to select a representative sample.

**Simulation** The re-creation of system or process in a controllable form, usually using computers, in order to manipulate the variables in order to study their effects.

**Statement** An assertion based on a combination of concepts.

**Subject** The participant in a research project. The term implies a passive role in the project, i.e. that things are done to the subject in the form of a test or an experiment.



**Sub-problem** A component of a main problem, usually expressed in less abstract terms to indicate an avenue of investigation.

**Symbol** A sign used to communicate concepts in the form of natural or artificial language.

**Systematic sampling** A sampling method that selects samples using a numerical method e.g. selection of every tenth name on a list.

**Term** A word used to express a definite concept. They can be primitive, which cannot be described by using other terms, or derived, which can.

**Theoretical sampling** Selection of a sample of the population that you think knows most about the subject. This approach is common in qualitative research where statistical inference is not required.

**Theory** A system of ideas based on interrelated concepts, definitions and propositions, with the purpose of explaining or predicting phenomena.

**Typology** An ordering of cases or data according to types according to specific characteristics

**Validity** The property of an argument to correctly draw conclusions from premises according to the rules of logic.

**Value** An actual measurement of a variable.

**Variable** A measurable attribute of an indicator or a case.

**Variance** The values of the variables compared with the mean. The greater the dispersion of values, the greater the variance of the data set.

**Venn diagram** A diagram of overlapping circles used to analyse arguments.
